### SECOND UPDATE REPORT

#### **New Representations**

Since the committee and update report 4 representations have been received from members of the public, all of which object to the proposed development.

In addition, the following representation was received from Chris Davies MP:

'I have been contacted by several constituents in relation to the above planning application. Following a recent meeting I have agreed to write to you as I am very concerned that if this application is to be considered tomorrow in its present form the Local Authority will open itself up for legal challenge at the cost to our tax payers.

Therefore for a variety of reasons I would strongly suggest that the decision is deferred from tomorrow's meeting and I would further suggest that members are taken on site visit to ensure that any decision is seen to have been justified.'

In addition, the following representation has been received from Cllr David Andrews:

'Since being extensively involved with dealing with the nonsense surrounding the outrageous wind turbine proposals on Reeves Hill - near Knighton, - I have been extremely busy both personally and professionally and thus - most regretfully - have not been able to fully participate in objecting to this seemingly ongoing wanton destruction of our beautiful rural landscape.

Nevertheless, I still try to keep up with developments and my dismay with ill conceived renewal energy schemes remains prominent.

Never before has there been such widespread industrialisation of our countryside wind farms, solar farms, intensive chicken sheds etc. The accumulative effect is significant and is most relevant to town and country planning.

Whilst Powys County Council's failure to understand the folly of inland wind power and the damage to tourism, adverse environmental effect and loss of local amenity never ceases to astound and infuriate me, more recently I have been extremely concerned about the clear procedural errors and seemingly deliberate neglect of proper determination process.

I would urge PCC planning department to take due note of all representations, not least the well argued and most relevant submissions by CPRW & CADW. Crucially, the LPA needs to be seen to be acting in the spirit of the Town and Country Planning Act. I fear there is a temptation for Powys to get these schemes approved, just to get the applications off their crowded desks. Perhaps more disturbingly, Powys's mania with wind farms seems to be driven by the obsession to comply with EC targets for renewable's. Perhaps not all are aware that with article 50 invoked, the political landscape is changing, and hopefully, there maybe a chance now to think more creatively about a solution for dwindling oil reserves.

Come on! - its time to do joined-up thinking about balancing energy needs with other social factors, e.g. encouraging home tourism and above all, promoting a sense of well being, and respect & appreciation for our beautiful landscape. There's still loads of space on windswept visually unexceptional coasts or off shore to plant these monstrous contraptions. If we have to have them, lets put them in the least damaging location.

Why are we hellbent on desecrating our most valuable resource just to provide a comparatively small amount of intermittent and inefficiently generated electricity, which by is inherent nature is subject to unpredictable and sudden fluctuations, and thus presenting a major difficulty for the national grid.

Please, let's start doing the right thing, and doing it the right way.'

It is not considered that the representations received raise any matters not already considered in the main and update reports with the exception of one comment asking that the conditions explicitly refer to the hub height, this is considered with below.

### **Conditions**

It is recommended following be amended from the text contained in the update report to read as follows *(italics indicates additional text)*.

In the definitions section:

"**development**" means the works that are permitted to take place as a result of this permission. This includes;

- (a)7 (110m tip height *and maximum hub height of 69m*) wind turbines (2.5 MW each) and associated infrastructure including crane hard standing areas;
- (b) 1 no. new site entrance to the east off the A44;
- (c) Construction of c. 3.3 km of new access tracks;
- (d) C.1km of existing track to be upgraded;
- (e) Construction of temporary site compound (20m x 30m) close to turbine T5;
- (f) Construction of a new on-site substation (circa. 40m x 20m) which includes a control building (25m x 10m) south of turbine T3.
- (g) upgrading of the byway through the applicant's property.

"expiry of this permission" means the date 25 years from the date of first export;

Condition 12 be amended to read:

'The wind turbine hereby apperoved shall have a blade tip of no greater than 110 metres and hub height no greater than 69m'.

In addition, the reasons for the proposed conditions in the update report omitted references to UDP policies. Should permission be granted it is recommended that the following reasons are cited on any permission granted:
