**1. Summary**

- 1.1 Further to the decision made by Cabinet on the 14<sup>th</sup> March 2017, the authority published a Statutory Notice proposing closure of the Welsh-medium stream at Brecon High School from the 31<sup>st</sup> August 2017, with Brecon High School becoming an English-medium school from the 1<sup>st</sup> September 2017. The Statutory Notice was published on the 16<sup>th</sup> March 2017.
- 1.2 The purpose of this report is to inform Cabinet of the Objections received during the statutory objection period, which ended on 13<sup>th</sup> April 2017, so that they can determine whether or not to close the Welsh-medium stream at Brecon High School from the 31<sup>st</sup> August 2017.

**2. Background****2.1 The Consultation Period**

Formal consultation in relation to the proposal for the Welsh-medium stream at Brecon High School was carried out in accordance with the

requirements of the School Organisation Code (2013) from the 21<sup>st</sup> November 2016 to the 9<sup>th</sup> January 2017. The consultation document issued in respect of this proposal is attached, for information, as Appendix C. A Consultation Report listing the issues raised during the consultation and the authority's response to them was considered by Cabinet on the 14<sup>th</sup> March 2017. This report is attached, for information, as Appendix D.

## 2.2 Statutory Notice / Objection Period

Further to the decision made by Cabinet on the 14<sup>th</sup> March, the authority published a Statutory Notice proposing to close the Welsh-medium stream at Brecon High School from the 31<sup>st</sup> August 2017, with Brecon High School becoming an English-medium school from the 1<sup>st</sup> September 2017. There followed a 28 day objection period, in accordance with the guidance within the School Organisation Code. The objection period ended on the 13<sup>th</sup> April 2017. The Statutory Notice is attached, for information, as Appendix E.

A total of 77 written objections were received during the statutory objection period. However, 21 of these were received from one individual.

In addition, a petition was received, which was signed by approximately 1700 individuals, and included 218 written comments.

The issues raised in the written objections and the petition received during the statutory objection period are listed in the Objection Report in respect of this proposal, as well as the authority's response to these issues.

## 3. Proposal

3.1 This report proposes that Cabinet:

- i) Receives the Objection Report in respect of the proposal to close the Welsh-medium stream at Brecon High School from the 31<sup>st</sup> August 2017
- ii) Rejects the proposal to close the Welsh-medium stream at Brecon High School from the 31<sup>st</sup> August 2017, and retains a Welsh-medium stream at Brecon High School.

## 4. Options Considered / Available

4.1 A range of options have been considered throughout this process. These have been outlined in the documentation issued during each stage.

4.2 Reference was made to a number of alternative options in the Objections received to the proposal, these are listed on pages 139-142 of the Objection Report produced (Appendix A).

4.3 The School Organisation Code states the following in relation to proposals which require approval by the local authority:

*'Local authorities must decide whether to approve, reject or approve with modifications, the proposals.*

*Modifications can only include changes to matters related to implementation such as changes to admission numbers or to the timing of implementation....'*

4.4 Therefore the options currently available to Cabinet are as follows:

- i) To approve the proposal
- ii) To reject the proposal
- iii) To approve the proposal with modifications

## **5. Preferred Choice and Reasons**

5.1 The preferred choice is to reject the proposal to close the Welsh-medium stream at Brecon High School from the 31<sup>st</sup> August 2017, and to retain a Welsh-medium stream at Brecon High School.

5.2 The reasons for the recommendation are as follows:

- i) To ensure the continued provision of Welsh-medium education in Brecon
- ii) To ensure that Welsh-medium pupils can access provision in the new school building planned for Brecon High School
- iii) To support the Welsh Government vision to create 1 million Welsh speakers by the year 2050

A recent analysis of the curriculum has indicated that the estimated cost of delivering the Welsh-medium provision in Brecon exceeds the available funding by £54,000.
