The budget necessary to enable separate boilers for separate systems at both the High School site, and the Leisure Centre in Llandrindod Wells. We are confident that a budget figure of £32k plus fees at 17.5 % of £5700, will be sufficient.

We are recommending a ' semi-permanent ' installation, due to the future of the functions on this site. This ' semi-permanent ' installation will allow the additional boiler to be easily re-located at another premise in the future, if necessary, yet dedicated to the sports centre for as long as is necessary.

In my opinion the risks of not providing an additional separate boiler for the sports centre are high, as the existing single boiler in the school basement, has already struggled through two mild winters, and I would not like to predict its longevity through another, harsher winter. If this single boiler does break down irreparably, then both the high school and the sports centre would have to close for a minimum of one week whilst the temporary stand by boiler is connected, but this is of a smaller capacity again, so not going to heat both buildings to an acceptable level. Approx 4 – 6 weeks for a replacement school boiler is installed.

Temporary heaters in classrooms/gyms, is not an option. We do have our biggest stand by boiler ready, but as stated, this is smaller than what is installed, and would only keep the buildings partially warm.
