#### **Details of Virement**

The Pay and Display Car Park Machines range from 34 to 25 years old and need to be replaced. Some will not be able to take the new £1 coin when it is introduced in 2017. The original virement requested funds to finance the replacement and installation of machines and upgrade 24 machines to take the new coins,

It has since been decided that the best and most cost effective course of action would be to replace all of the machines at the same time but for this an extra £100k is required.

Estimated expenditure on the Street Lighting Efficiency project is now forecast to be less than originally anticipated. Approval is requested to vire £100k of this budget to fund the increase necessary to replace all of the 60 Pay & Display machines at the same time.
