1 Summary

- 1.1 The Environment Act 1995 introduced a requirement on the UK Government to publish a National Air Quality Strategy which was to introduce National Air Quality Objectives and measures to improve ambient air quality. The legislation also requires local authorities to undertake periodic reviews of air quality in their areas, and where a National Air Quality Objective is unlikely to be met, they must establish an Air Quality Management Area.
- 1.2 In June 2007, a Detailed Assessment of levels of Nitrogen Dioxide within Powys was published which concluded that levels along part of New Road, Newtown exceeded the National Air Quality Objective. As a result, an Air Quality Management Area (AQMA) was declared on the 15th February 2008. A map showing the extent of the AQMA is provided in Annex 1.
- 1.3 Since then, the levels of Nitrogen Dioxide on New Road have been monitored and the results reported to Welsh Government. The results illustrated that the levels of Nitrogen Dioxide were declining over time and since 2012 have been below the National Air Quality Objective. On this basis, the latest Updating and Screening Assessment (USA) that was submitted to and accepted by Welsh Government recommended that the AQMA be revoked.

2 Background

- 2.1 Part IV of the Environment Act 1995 places a duty on local authorities to periodically review and assess air quality within their area in relation to the following 7 pollutants:-
 - Carbon monoxide
 - ➢ Benzene
 - > 1, 3-butadiene
 - Lead
 - Nitrogen Dioxide
 - > Sulphur Dioxide
 - > Particulates
- 2.2 Local authorities have been carrying out reviews and assessments in their areas since 1997 with a view to determining if any areas are likely to exceed the National Air Quality Objectives.
- 2.3 The assessments involve screening areas to identify whether there are any areas where an Objective may be exceeded. Where this is likely, monitoring is undertaken.
- 2.4 Since 1999, Powys County Council has undertaken monitoring of Nitrogen Dioxide on New Road as initial screening identified possible exceedance of the Objective of 40µg/m3 based on large traffic flows and the proximity of houses to the road. The levels of Nitrogen Dioxide are monitored using diffusion tubes which are mounted on streetlamps located between the road and the nearest dwellings.
- 2.5 The monitoring illustrated an increasing trend in Nitrogen Dioxide levels on New Road, Newtown, and in 2005 the National Objective of 40µg/m3 was exceeded. A Detailed Assessment was subsequently commissioned which combined monitoring and modelling data which confirmed that the levels at 2 properties on New Road would be in excess of the Objective and recommended that an Air Quality Management Area (AQMA) be declared.
- 2.6 On the 15th February 2008 an Air Quality Management Area was declared encompassing 2 properties located on New Road.
- 2.7 Since then, monitoring on New Road has continued and up until 2011, levels of Nitrogen Dioxide continued to exceed the Air Quality Objective. However since then, there has been a steady decline in levels which mirrors predicted trends.
- 2.8 On the basis that there has been no exceedance of the National Air Quality Objective since 2012 it is recommended that the Air Quality Management Area be revoked.
