**1. Summary**

- 1.1. Powys County Council (“the authority”) has proposed to close Builth Wells High School and Llandrindod High School from August 2018, and establish a new bilingual 11 – 18 school with effect from September 2018.

The name of the new school has been discussed by the pupils and staff of Builth Wells High School and Llandrindod High School together with the pupils of year 5 and 6 of the feeder primary schools. Following a discussion at the temporary governing body meeting on the 11<sup>th</sup> January 2018 it was agreed to propose Ysgol Calon Cymru as the name of the new school.
