Licensing Sub-Committees – Procedural Guidelines for the conduct of hearings in accordance with the Licensing Act 2003 (Hearings) Regulations 2005 ("the Regulations")

#### Introduction

The four licensing objectives, as set out in the Licensing Act 2003 are:

- The prevention of crime and disorder
- Public safety
- · The prevention of public nuisance
- The protection of children from harm

Each application that comes before a sub committee of the Authority will be treated on its own merits and this licensing authority will take its decision based upon the merits of the application, taking into account the need to promote the four licensing objectives. This Authority will also have regard to its Statement of Licensing Policy and the guidance issued under section 182 of the Licensing Act 2003.

- 1. The hearing will normally be held in public. However, the sub committee may exclude the public from all or part of a hearing where it considers that the public interest in so doing outweighs the public interest in the hearing, or that part of the hearing, taking place in public.
- 2. The hearing shall take the form of a discussion led by the Licensing sub committee and cross examination will not be permitted except at the discretion of the sub committee if it is required to consider the application or representations. This is in accordance with Regulation 23 of the Regulations. A party wishing to cross examine another party must make an application to the sub committee.
- 3. The procedure at the hearing shall be determined by the sub committee, normally in accordance with the following guidelines.
- 4. The sub committee shall appoint a Chairman.
- 5. The Chairman will welcome everyone to the hearing and will introduce him/herself and the other members of the sub committee.
- 6. The Legal Adviser to the sub committee will ask everyone present to introduce themselves and will explain the procedure to be followed. He/she will ask the applicant, if unaccompanied, if he/she was aware of the right to be represented. The sub committee will also consider any

- request made by a party under Regulation 8(2) for permission for another person to appear at the hearing as a witness.
- 7. The Licensing Officer will present a report outlining the nature of the application to be considered, any relevant representations and policy statements. The sub committee may ask any relevant questions of the officer through their Legal Adviser.
- 8. The applicant (or his/her representative) will be invited to put his/her case. The applicant may call witnesses to support the case provided that the sub committee have given permission to do so. The sub committee and other parties who have made relevant representations may ask any relevant questions of the applicant or of persons representing them. The sub committee should ask questions through their Legal Adviser.
- 9. The Chairman will then invite those parties making representations to address the sub committee. The sub committee may ask relevant questions of those parties making representations through their Legal Adviser. The applicant or his/her representative may also ask relevant questions of those parties making representations.
- 10. The Chairman will invite the applicant (or his/her representative), and any parties making representations, to briefly summarise their points if they wish.
- 11. The sub committee may ask relevant questions of any party during the hearing through their Legal Adviser, but should refrain from any discussion of the merits of the case.
- 12. The sub committee will retire with their Legal Adviser to deliberate in private. It if is necessary to recall any party to provide further information or clarification, all parties at the hearing will be asked to return.
- 13. When the sub committee has reached its conclusion, the parties will be recalled and the decision will be announced to the applicant by the Legal Adviser to the sub committee, accompanied by, as appropriate, a description of any conditions which are to be attached to the grant of a licence and the licensing objectives that they relate to. Reasons will be given for the decision. That information will also be given to the applicant in writing as soon as is practicable and he/she will be told of any statutory rights of appeal that are available. In cases where a decision cannot be given at the end of a hearing, the applicant and those parties present will be notified of the decision within five working days.

#### PLEASE NOTE:

- Any person attending the hearing, who, in the opinion of the Chairman, is behaving in a disruptive manner, may be required to leave.
- Late additions to representations and evidence will only be considered with the agreement of all parties present
- The sub committee may allow a maximum period of time for each party to make all relevant statements in support of their written representations. The sub committee would request that all parties avoid repetition and keep the discussion moving in the interests of efficiency.
- Decisions will generally be taken regardless of whether the applicant or those who have made written representations are present. All notices and written representations received from absent parties will be considered. However if a party is unable to attend a hearing due to unforeseen circumstances and would wish to be present, that party should contact the relevant Licensing Officer or Committee Clerk by telephone in order to explain the circumstances. In such a case, the sub committee may be prepared to adjourn the hearing.

REPORT FOR: DECISION

#### 1. APPLICATION

- 1.1 On 07/09/2022, an application, **Annex A**, to vary a Premises Licence, **Annex B**, was received from Michael David Lynch and Samantha Jane Tregallas for The Lounge Café Bar.
- 1.2 The premises is a bar licensed to sell alcohol, provide entertainment and late night refreshment. The current Premises Licence was granted under the Licensing Act 2003 following a hearing in 2005. The hearing was required as there were representations from Powys Environmental Protection, based on complaints of excessive noise. **Annex C.**
- 1.3 The applicants & the Licensing Authority satisfied procedural obligations by consulting the Responsible Authorities and advertising the application.
- 1.5 The Applicants had applied for a variation to the Premises Licence authorising the sale of Alcohol, Entertainment and Late Night Refreshment for an additional hour, on Thursday, Friday, Saturday and Sundays preceding Bank Holidays. Therefore these 3 activities would be licensed until 3am on these days. The application for the Entertainment and Late Night Refreshment were later withdrawn Annex D following initial objections from Powys County Council Environmental Protection and The Police leaving only the application that alcohol could be sold until the later 3am time on these days. The Police and Environmental Protection withdrew their objections. The applicants also agreed to new conditions being placed on the Premises Licence at the request of the Police set out at Annex E.

#### 2. REPRESENTATIONS

#### 2.1 Responsible Authorities

There are no objections from the Responsible Authorities. However, Powys Environmental Protection pointed out the 7 separate complaints about excessive noise

over the Jazz Festival in 2022. Powys Trading Standards also raised the issue of the Closure Order given to the premises due to COVID Regulation breaches and the sale of alcohol breaching the Minimum Unit Pricing Regulations in August of this year.

The Licensing Authority will confirm that a closure order under the COVID regulations was issued to the premises in November 2020. This was following an incident of disorder investigated by the police and CCTV being viewed which showed an obvious lack of control and serious breaches of COVID regulations.

In addition, a warning letter was sent to them regarding a breach of condition relating to all windows and doors to be kept closed after 23:00 hours. In this instance, on 12/08/2019, it was reported by a complainant that the front doors were left open and not closed until the police attended at 00:20hours.

#### 2.2 Other Persons

#### **Objections**

Representations were received from the local Cllr Liz Rijnenberg which is set out in full below and at Annex F

"I would like to object to the licence being extended until 3 am for The Lounge on Thurs/Fri/ Sat of Bank Holiday weekends. The reasons are as follows:

- The Lounge is located in the Centre of Brecon and there are many residents living in flats nearby, for example: 10 flats on Bell Lane; 22 properties on Castle Street, some of which contain up to 6 flats; 8 flats and a cottage on Chapel Street, 4 properties on George Street: 18 properties on Lion Street up to Bethel Square and properties on High Street. Some of these are elderly long standing residents who are not accustomed to noise late into the night.
- People leaving licensed premises are often noisy and the later that the premise is open the more alcohol is likely to be consumed. Patrons will be leaving on foot or by taxi which can wake people who go to work early in the morning.
- People will congregate out on the street in warm weather, and to smoke, which will also cause added disruption if it continues until 3 am.
- During the jazz festival 2022 I had complaints from people either in writing, or in person (passed to PCC environment) about the level of noise resulting from a licence being granted to The Bank and The Lounge to play music until 3am.
- I want to see all local businesses thrive but I am not confident that this is a necessary extension and a 2am closure should be adequate.
- I have also been approached with observations from public about the levels of mess left on the pavements outside The Lounge on weekend mornings. The cigarette buts have been left all over the pavements and no attempt to clean other deposits up. I believe that extending the alcohol licence is likely to exacerbate this issue. I have seen this mess first hand, taken photographs and spoken with an adjacent business who take great pride on the appearance of their frontage.

Overall, I don't think this is the right time for an extension and I would be interested to know what steps the owners are intending to put in place given the concerns raised.

Whilst the music may be turned off at 2 am patrons will still be going outside until 3am to smoke and will generate noise on leaving – do they have any plans on how this can be ameliorated if their application is accepted?"

# One complaint has been received from a member of the public. Set out below and at Annex G.

"Notice has been given in the Brecon & Radnor Express of 12th October of the application for a variation of a premises licence for the Lounge Cafe Bar at 21a The High Street, Brecon, LD3 7LA. This variation would allow the sale of alcohol from 11:00 to 03:00 Thursday, Friday, Saturday and Sunday prior to a bank holiday.

I live at a distance that 'should' mean I am not adversely affected by the activities of the Lounge Bar, however, that is currently not the case. Often the noise from this venue carries far enough to disturb me at night. In warm weather I can hear the clientele who spill out onto the streets and loud music from within. It is not fair that I have to sleep with windows closed in warm weather. When closing time eventually comes, I am often treated to drunken revellers singing, shouting, swearing, sometimes urinating, sometimes committing acts of vandalism as they make their way home along the street where I live. None of which can be solved by reporting after the event.

During the Jazz Festival, the noise and disturbance was extended up until 3am from this venue and the aftermath when their customers staggered through the streets carried on much longer and was utterly intolerable. I have heard that many noise complaints were made to the council about it (including myown via the noise app. though no acknowledgement or response was ever received.) It seems to me that this proposed alteration to the license will make every weekend just as unbearable for residents, some of whom have to rise early for work.

It shouldn't be necessary to serve alcohol till 3am several nights per week every week and would, I am certain, cause extra policing expenditure and to encourage extended periods of drinking during a time of financial crisis seems particularly unwise.

Police will not attend for noise emanating from a licensed premises, nor should they. But is it possible to complain to the council in real time and have someone attend to measure the decibels or walk the surrounding streets to experience the disturbance being caused and then do something about it in a timely fashion. Residents feel hard done by and disempowered.

I am not against enterprise by a local business to increase their trade and understand that these are difficult times for everyone. Perhaps a noise traffic light system that cuts off power when a certain level of decibels has been breached should be used at this venue. I know that they have been installed elsewhere. This would help to limit the noise issue from the venue itself, although open windows and doors do not help. As to the problems caused by alcohol fuelled customers after they leave, I have nothing to offer by way of a solution except regular and active patrols by the police. But I would welcome your serious consideration of both these issues and the effect they have on local residents, along with carefully planned measures to mitigate them before any variation to the license is granted."

#### 3. OPTIONS

- 3.1 In determining the application for the Premises Licence, the Sub-Committee must take such steps as are considered appropriate to promote the licensing objectives;
  - i) The Prevention of Crime and Disorder

- ii) Public Safety
- iii) The Prevention of Public Nuisance
- iv) The Protection of Children from Harm

- 3.3 The options are to;
  - grant the application as submitted by the applicant without modification, with the exception of the inclusion of mandatory conditions made under Section 19, Licensing Act 2003 (Supply of Alcohol); or
  - b) grant a licence with modified conditions; or
  - c) reject the whole or part of the application.

    - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);
    - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

- (d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on—
  - (i) the outcome of a race, competition or other event or process, or
  - (ii) the likelihood of anything occurring or not occurring;
- (e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
- 2. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 3. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 4. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
  - (2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.
- 5. The responsible person shall ensure that-
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml; and
  - (b) customers are made aware of the availability of these measures.

- (1) Sub-paragraph (2) applies where the permitted price given by 4. Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.

(2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### 1. INTRODUCTION

1.1 Mr Graham Craig Powell and Mr Michael David Lynch have applied to convert the existing Justices Licence and Public Entertainment Licence to a Premises Licence under the Licensing Act 2003. In addition, an application to vary the Premises Licence has been submitted for consideration.

#### 2. BACKGROUND

- 2.1 The Lounge Café Bar is situated on the High Street with adjoining commercial properties on both sides. The premise consists of bars on the ground and first floors with toilets in the basement and private accommodation on the second and third floors. There is no outside drinking area at the premises. A location map of the premises is set out at Annex A.
- 2.2 The premises currently holds a Full Justices Licence and Special Hours Certificate for consumption of alcohol on or off the premises under the Licensing Act 1964, which permits sale of alcohol between 11.00 to 23.00 Monday to Wednesday, 11.00 to 01.00 Thursday to Saturday and 12 noon to 22.30 on Sunday. The premises also holds a Public Entertainment Licence for the purposes of public dancing or music or any other public entertainment of a like kind, Monday to Wednesday 16.00 to 23.00, Thursday to Saturday 16.00 to 01.00 and Sunday 16.00 to 22.30. The current conditions detailed in Annex D which are attached to this Public Entertainment Licence, will be transferred automatically as part of this application.
- 2.3 On 3<sup>rd</sup> August 2005, Mr G.C. Powell and Mr M.D. Lynch submitted an application under the Licensing Act 2003 to convert to a premises licence and applied also to vary the terms of the licensable activity. A copy of the application and a plan of the premises are reproduced at Annex B.
- 2.4 The application is set out in two parts on the application form. Part A, to convert the current Justices Licence and Public Entertainment Licence to a Premises Licence are unopposed by the Police and therefore will be granted under delegated powers. Part B concerns the application to vary the licence and is opposed by the Environmental Protection Officer. The Licensing Sub-Committee is therefore asked to consider this part of the application.

## The Lounge Café Bar, Brecon

The Council's Environmental Health Service (EHS) can provide the following summary of prevention of public nuisance issues for these premises.

Public Complaints

The following members of the public have complained to the EHS about loud music at the Lounge:

1. Mr Blair, owner of the George Hotel - verbal complaint - 12/08/2005

- 2. Dorothy Kenny, resident of the George Hotel by letter dated -14/08/2005
- 3. Mr & Mrs J.J. Roberts, residents of the George Hotel by letter dated -18/08/2005

Police complaints and Monitoring by the EHS: -

- 1) 18/08/2003 Sgt Scrase (Brecon Police) complained about very loud music from the Lounge. Sgt Scrase had received complaints from other licensees & Police colleagues.
- 2) 07/11/2003 DKR of the EHS spoke to Mike Lynch (licensee) following concerns of Police over noise as part of Brecon Civic Pride Survey
- 3) 21/05/2004 Visit by DKR & MG of the EHS who spoke to Mike Lynch. On 02/06/2004, a follow up letter was sent to Mike Lynch by DKR providing noise control advice
- 4) Sgt Scrase complained on 15/08/2004 of excessive noise from the Lounge Bar and requested help from the EHS. In response AB of the EHS attended. She noted all doors were open, music speakers were facing the street and dancing drunks were seen in the street immediately outside the premises.
- 5) 20/08/2004 (11.20pm) Visit to area by MG/AB (EHS) loud music evident, doors and windows left open with a DJ playing music in the front of the ground floor bar.
- 6) 25/06/2005- 00:40hrs MG (EHS) heard very loud music from the Lounge windows to first floor lounge open & music louder when customers entered and left premises & doors were opened.

Prevention of Public Nuisance Measures Offered by the Applicants: -The applicant has offered the following measures to prevent public nuisance:

Deliveries and collections in day time only

Bottle and waste disposal not to take place at night time

Noise Control Issues

The following noise control issues are considered relevant: -

loud amplified music is regularly played at the premises with the openable frontage and front and rear doors and windows left open. This loud music is clearly audible in High Street and Castle Street and has prompted complaints from the members of the public.

 Existing air conditioning system is inadequate resulting in the windows being left open.

Noise control improvements are required which should include: -

- Replacement of operable frontage with a double door lobby & fixed structural frontage with acoustic glazing.
- Lobbies and self closing acoustic doors to ground & first floor rear doors (subject to agreement by the Fire Officer)
- Sealed acoustic glazing to FF bar lounge frontage
- An improved acoustically treated air conditioning ventilation system to serve all public areas.
- A sound limiter as an interim measure until the full noise control scheme is implemented.

#### Opening hours: -

Closing no later than 01:00hrs until noise control scheme can be implemented and its effectiveness reviewed. Closing at 03:00hrs is too late in current circumstances.

#### 3. VARIATION

- 3.1 The applicant wishes to vary the licence:
  - To include indoor sporting events such as darts and quoits.
  - To include the performance of live amplified music such as bands and singers.
  - To include the playing of recorded music.
  - To include the provision of facilities for making music.
  - To include the provision of facilities for dancing as the general floor area.

To carry out the above activities 7 days a week 11.00 to 02.00

- To include the performance of dance.
   Thursday to Sunday 12.00 to 01.00
- To include entertainment such as comedians and anything of a similar description.

7 days a week 19.00 to 02.00

- To include the provision of facilities for karaoke entertainment and anything of a similar description.
   7 days a week 18.00 to 02.00
- To include the provision of late night refreshment
   7 days a week until 02.00
- To extend alcohol sales.
   7 days a week 10.00 to 02.00
   To reflect existing New Years Eve/Day hours (36 hours continual trading)
  - Hours premises open to the public
     7 days a week 10.00 to 03.00

#### Dear Simon

I would like to object to the licence being extended until 3 am for The Lounge on Thurs/Fri/ Sat of Bank Holiday weekends. The reasons are as follows:

- The Lounge is located in the Centre of Brecon and there are many residents living in flats nearby, for example: 10 flats on Bell Lane; 22 properties on Castle Street, some of which contain up to 6 flats; 8 flats and a cottage on Chapel Street, 4 properties on George Street: 18 properties on Lion Street up to Bethel Square and properties on High Street. Some of these are elderly long standing residents who are not accustomed to noise late into the night.
- People leaving licensed premises are often noisy and the later that the premise is open the more alcohol is likely to be consumed. Patrons will be leaving on foot or by taxi which can wake people who go to work early in the morning.
- People will congregate out on the street in warm weather, and to smoke, which will also cause added disruption if it continues until 3 am.
- During the jazz festival 2022 I had complaints from people either in writing, or in person (passed to PCC environment) about the level of noise resulting from a licence being granted to The Bank and The Lounge to play music until 3am.
- I want to see all local businesses thrive but I am not confident that this is a necessary extension and a 2pm closure should be adequate.
- I have also been approached with observations from public about the levels of mess left on the pavements outside The Lounge on weekend mornings. The cigarette buts have been left all over the pavements and no attempt to clean other deposits up. I believe that extending the alcohol licence is likely to exacerbate this issue. I have seen this mess first hand, taken photographs and spoken with an adjacent business who take great pride on the appearance of their frontage.

Overall, I don't think this is the right time for an extension and I would be interested to know what steps the owners are intending to put in place given the concerns raised.

Whilst the music may be turned off at 2 pm patrons will still be going outside until 3am to smoke and will generate noise on leaving – do they have any plans on how this can be ameliorated if their application is accepted?

Subject: Licence variation application: The Lounge Cafe Bar, Brecon

For the attention of the Licensing Officer, Powys County Council, Neuadd Brycheiniog.

Notice has been given in the Brecon & Radnor Express of 12th October of the application for a variation of a premises licence for the Lounge Cafe Bar at 21a The High Street, Brecon, LD3 7LA. This variation would allow the sale of alcohol from 11:00 to 03:00 Thursday, Friday, Saturday and Sunday prior to a bank holiday.

I live at a distance that 'should' mean I am not adversely affected by the activities of the Lounge Bar, however, that is currently not the case. Often the noise from this venue carries far enough to disturb me at night. In warm weather I can hear the clientele who spill out onto the streets and loud music from within. It is not fair that I have to sleep with windows closed in warm weather. When closing time eventually comes, I am often treated to drunken revellers singing, shouting, swearing, sometimes urinating, sometimes committing acts of vandalism as they make their way home along the street where I live. None of which can be solved by reporting after the event.

During the Jazz Festival, the noise and disturbance was extended up until 3am from this venue and the aftermath when their customers staggered through the streets carried on much longer and was utterly intolerable. I have heard that many noise complaints were made to the council about it (including my own via the noise app. though no acknowledgement or response was ever received.) It seems to me that this proposed alteration to the license will make every weekend just as unbearable for residents, some of whom have to rise early for work.

It shouldn't be necessary to serve alcohol till 3am several nights per week every week and would, I am certain, cause extra policing expenditure and to encourage extended periods of drinking during a time of financial crisis seems particularly unwise.

Police will not attend for noise emanating from a licensed premises, nor should they. But is it possible to complain to the council in real time and have someone attend to measure the decibels or walk the surrounding streets to experience the disturbance being caused and then do something about it in a timely fashion. Residents feel hard done by and disempowered.

I am not against enterprise by a local business to increase their trade and understand that these are difficult times for everyone. Perhaps a noise traffic light system that cuts off power when a certain level of decibels has been breached should be used at this venue. I know that they have been installed elsewhere. This would help to limit the noise issue from the venue itself, although open windows and doors do not help. As to the problems caused by alcohol fuelled customers after they leave, I have nothing to offer by way of a solution except regular and active patrols by the police. But I would welcome your serious consideration of both these issues and the effect they have on local residents, along with carefully planned measures to mitigate them before any variation to the license is granted.

# 17 PREVENTION OF CRIME AND DISORDER

Licensed premises, especially those offering late night/early morning entertainment, alcohol and refreshment for large numbers of people can be a source of crime and disorder problems. The Licensing Authority will expect operating schedules to satisfactorily address these issues, applicants are recommended to seek advice from the Licensing Authority and the Police.

Where an applicant is considering installing CCTV as part of the operating schedule then advice should be sought from the Police Licensing Officer. There is a County-wide pub watch network in place run by licensees, known as the BOBB (Behave or be banned) scheme they promote good practice, sharing information, disseminating best practice and provide a forum for the responsible authorities to engage with licensees when necessary. The Licensing Authority encourages all licensees to actively participate in their local BOBB scheme in order to uphold this licensing objective

It may be appropriate for some late night venues to employ door staff in order to prevent crime and disorder, where door staff are employed then it is a mandatory condition that they are registered with the SIA (Security Industry Authority), operators will need to consider:

- what checks are made to the validity of the SIA licence?
- What records are kept of SIA checks,
- search & entrance policies
- employment times of SIA and their training?

Operators may wish to consider a drug and weapon policy? Is there a regular documented training of this policy carried out with staff when drugs/weapons are seized or stored? Are areas or surfaces designed to prevent the likelihood of drug use at the premises?

Use of polycarbonate drinking vessels might be a suitable control measure in some venues and also might be appropriate for all venues in some locations at certain times e.g. for premises in Builth Wells town centre during the Royal Welsh Show, or premises in Brecon town centre during the Brecon Jazz festival

#### 18 PUBLIC SAFETY

The Licensing Authority will expect operating schedules to satisfactorily address issues concerning public safety and are advised to seek advice from the relevant bodies e.g. Health and Safety Enforcement Officers and Mid and West Wales Fire Authority.

The Licensing Authority expects that applicants meet the requirement for both a Health & Safety Risk Assessment and Fire Risk Assessment under the relevant provisions, where necessary.

Other controls measures for consideration in order to promote the public safety objective may include:

- Regular testing (and certification where appropriate) of procedures, appliances, systems etc. pertinent to safety.
- Appropriate First Aid facilities and staff training on when to administer/ not administer First Aid.
- Appropriate instruction, training and supervision of those employed or engaged to secure the safety of everyone attending the premises.
- Adoption of best practice guidance (Assistance can be obtained by contacting such Environmental Health, Fire Safety and HSE).
- Provision of effective CCTV in and around premises.
- Implementation of crowd management measures.

The Regulatory Reform (Fire Safety) Order 2005 introduced a requirement that any person responsible for the management of a premises must make a suitable and sufficient assessment of the risks, to which persons may be exposed for the purpose of identifying the general fire precautions, which need to be taken, this would include a safe operating capacity. Therefore, no conditions may be imposed on an authorisation where it directly relates to fire safety. It is expected therefore that authorisation holders will conduct a thorough risk assessment which is regularly reviewed and updated; The risk assessment should be retained at the premises and be available upon request by any authorised officer of the Council.

# 19 THE PREVENTION OF PUBLIC NUISANCE

Licensed premises can have significant potential to impact adversely on persons in the vicinity and further afield through public nuisances that arise from their operation. Applicants must demonstrate in their operating schedule suitable and effective measures to prevent nuisance failure to address this objective is likely to lead to an objection. Particular regard should be had to minimise the potential for public nuisance that may arise from premises where:

- They are situated in residential or noise sensitive areas and/or
- Extended opening hours are proposed

Where an application has been made for either a one-off event or for a premises that is either wholly or partly outside or within a temporary structure such as a tent or marquee consideration needs to be given to the needs of local residents and the applicant will be required to offer controls so that local residents will not suffer noise nuisance; these should be proportionate to the nature/scale and duration of the event and also to the proximity to local residents. In some circumstances it will be appropriate to submit a noise management plan. Applicants should seek advice at an early stage from Environmental Protection Officers in relation to whether a Noise

Management Plan in accordance with The Noise Council Code of Practice is required.

The Licensing Authority recognises that beyond the immediate vicinity of the premises the control that a licence holder can exert over its patrons diminishes and individuals who engage in anti-social behaviour are accountable.

Smoking & External areas - Legislation preventing smoking indoors at public premises has resulted in many customers of licensed premises and clubs using external areas. Premises licence holders, designated premises supervisors and applicants must have regard to how this has an impact on the four licensing objectives. Control measure may include restricting access to external drinking areas at certain times, or prevent customers from taking drinks into external smoking areas in order to discourage customers from lingering outside and potential causing a disturbance to residents
