Summary

Double yellow lines were installed on Dol Y Fan at the request of the housing department, as they believed Dol y Fan to be housing land and not adopted highway. However, following a complaint from a resident, further investigations were carried out, and it was confirmed that Dol y Fan is indeed public highway. The lines have no legal order and are unenforceable. Housing have requested that these lines be advertised and the legal process followed to enable them to be legally enforceable.

Proposal

It is proposed to legalise the exiting double yellow lines and amend the length to include the approach to the junction.
