| New Policies / Plans: Complaints Policy | A complaints policy has been developed for the WPP which provides guidance to the Constituent Authorities (CAs) on the procedure to follow in relation to WPP operational and service quality complaints. | Policy Reviews: Responsible Investment Policy | The WPP have approved several policies / plans which are to be reviewed on a regular basis. This quarter, the OWG have undertaken an annual review of the Responsible Investment (RI) Policy. |
| | Following this year's review, the RI policy has been updated to include a section on Human Rights (section 5) and point no 8.2 under Stewardship has been extended to include voting on the pooled passive funds. |
| | The updated policy has been approved and the WPP website has been updated. |
| Operator Update | Link presented their quarterly update report as at 30 September 2022 (attached). This provides an update on WPP's sub funds and corporate and engagement activity. |
| Performance Reports as at 30 September 2022 | Russell presented a Q3 performance summary paper (attached) summarising the performance of each individual ACS sub fund for the quarter ending 30 September 2022. |

| Global Securities Lending Report as at 30 September 2022 | Stock Lending commenced in March 2020 and Northern Trust presented the Global Securities Lending Report for Q3 2022 (quarter ending 30 September 2022). |
| Robeco Engagement Report - Q3 2022 | In March 2020, Robeco was appointed as WPP's Voting & Engagement Provider to undertake Voting and Engagement functions on behalf of the WPP. Robeco commenced their engagement service in April 2020, and they have provided an engagement report for Quarter 3 2022. |

| Private Equity Allocator appointment | A two-stage competitive procedure with negotiation procurement process has been undertaken to appoint an Allocator for the Private Equity asset class. A recommendation report was taken to this JGC for approval. |

| | The JGC approved the recommended bidder. The contract was awarded on 20 December 2022 with Schroders being the successful bidder. Work is underway to complete the legal requirements by February/March 2023. |
| Responsible Investment and Climate Risk reports | Each quarter, Hymans Robertson produce quarterly Responsible Investment & Climate Risk Reports for the WPP's sub funds. |
| | For Quarter 2 2022 (quarter ending 30 June 2022), the ARB and MAC reports were produced. These should have been presented at the 21 September 2022 JGC meeting however this meeting was cancelled. |
| | The UK Opportunities and Emerging Market reports have been produced for Quarter 3 2022 (quarter ending 30 September 2022). |
