Rhayader Home Support – Evaluation

Service Aim: To improve the support available to the older people in the Rhayader area, enabling them to continue to live at home with greater practical assistance and to maintain links with the community.

Rhayader Home Support began in 1998 following the closure of a local nursing home the service also provides the warden service

The service operates within a 7 mile radius of Rhayader.

Majority of those registered with the service are patients of Rhayader GP practice with a few being patients of either Llandridnod Wells or Llanidloes GPs.

The service is free at delivery.

Current Membership

180 service users are registered with the service (service user can register their details with the service but not all want current daily/weekly involvement but are known to the service who maintain their details and can support if needed) service users can self-refer and referrals also come from family, GPs, health workers and social care staff.

62 people are currently active members of the service receiving regular contact with the service ranging from 1 contact per week to daily contact.

Service user visit/call via telephone up to 49 per day Monday to Friday with a limited number also receiving a telephone call on Saturday and Sunday if required

In addition to monitoring the service user health and wellbeing staff also support service user by:

Essential shopping; collection and delivery of medication; helping to manage recycling/waste collection; help with correspondence and form filling: fitting and testing Careline alarms, arranging and reminding of appointments

Staff do not form part of a domiciliary care service but can provide domiciliary care in the case of an emergency/or while a care package is sourced/or to return home from hospital /carer illness – this is normally time limited to not more than six weeks.

The service acts as a key holder and rapid response service for 92 individuals with a Careline alarm.

The staff work closely with

Health: Rhayader GP surgery, District Nurses, Llandrindod Hospital, Health OT's Physiotherapist, dementia nurse, Psychiatry Specialist and Diabetic nurse. The service plays an active part in the weekly virtual ward meeting.

Powys County Council: Care managers and CSOs, Reablement, OTs, Careline and Housing

Third Sector: Community support, Befrienders, Community Transport, Hospital Transport Age, PAVO, Age Cymru, Luncheon Club.

Others: Fire Service, Police.

Staffing

1 Senior Support worker (30 hours) and 4x support staff 80 hours (110 hours per week).

Hours of operation 8.30am to 5.30pm Monday to Friday and an out of hours service from 5.30pm to 8.30am and on Saturday and Sunday.

Economics:

A reduction of 9 hours of home care daily in Rhayader would pay for over half the service's budget.

£89,410

If the service reduced 2 home care visits for 2 people daily over one year this would equate to approximately £12k.

This evaluation should be read in conjunction with The Institute of Rural Health's report¹ on the service in 2013 which demonstrated significant financial savings.

Call Outs:

•Annually, ambulance services respond to 700,000 calls from older people who have fallen

•Accounts for 10 per cent of total calls.



•Around 25 per cent of these do not need to go to hospital.

•Average of £238 per ambulance call-out (Welsh Ambulance Trust Dec 2014 PtHB)).

•Based on the figures from RHS –the numbers of falls they dealt with in a quarter works out at 14% of the population (over 85).

•Aggregated figure for the whole of Powys' 85 Year old population would equate to $979 \times £238 = £233,002$ if the need for an ambulance response was prevented in just 1 quarter X 4 = £932,008.








% of people in Permanent Residential Care in relation to the over 85 population




% of people using ASC in relation to the over 60 population

- Data Integrity
- Over 85s are disproportionate in Rhayader (see table)
- Presteigne East Radnor Day Service impact?
- Do Presteigne residents go over the border for services?
- Are there more self-funders in Rhayader?
- Costs increase in rural areas (travel)
- Does not fully resolve loneliness issues model requires further befriending services
- Home Support as a substitute for day services does not consider carer respite
