Timing of Council Meetings: Survey of Members 2012/13

In accordance with the statutory guidance issued by the Welsh Government under Section 6(1) of the Local Government (Wales) Measure 2011, the Council is required to survey Members in respect of the times at which meetings of a local authority are held. All local authorities should review the times at which meetings are held at least once in every term, preferably shortly after the new Council is elected.

Councillors were asked to complete a form indicating their preferences. 42 Members responded and a breakdown of their responses is set out at Appendix A attached.

The clear majority of members who responded favoured a 10.00 a.m. start time for meetings. A number did favour a 10.30 start for Council meetings so political group meetings could take place beforehand.

A number of members did express a preference for evening meetings because work commitments made it difficult for them to attend meetings during the day. Other Members pointed out that they had other community based commitments which would prevent them from attending evening meetings. Although the preference is for morning meetings, the point made about daytime meetings being difficult for people in work and therefore a deterrent to people putting themselves forward for election does warrant consideration. The Committee might want to consider whether some evening meetings should be trialled and if so what committees would lend themselves to this.

All comments received are set out in Appendix B attached.

Members' Comments

- 1. Time of meetings do not affect me that much it takes 1.40/1.45 hours to travel each way so most of day is taken up no matter when the meeting is held.
- 2. 2.00 p.m. preferred for Council, Cabinet, Regulatory and Scrutiny Committees 7.00 p.m. preferred for Shires employment commitments.
- 3. 10.00 a.m. preferred these times are fine for me.
- 10.30 a.m. or 7.00 p.m. preferred. Have put 2 times down for Council, Cabinet, Reg & Scrutiny. 10.30 start allows time to see son and drop him off in school and allow time to travel to County Hall without rushing. Would not mind having night meetings where agenda allows eg Shire.
- 5. 11.00 a.m. preferred for Council. 10.00 a.m. for Cabinet, 10.30 a.m. for Regulatory and Scrutiny Committees. 10.00 a.m. for Shires. Full Council would be better half an hour later to give more time for group meetings. Cabinet is about right, Cabinet members tend to have other meetings later in the day, Other committees require members to travel from all over the county. Half hour later would be a benefit. For Shire meetings members do not have as far to travel.
- 6. 10.00 a.m. preferred being self employed it makes it easier to arrange my work commitments.
- 7. 9.30 preferred but 10.00 a.m. in winter months
- 8. Full Council/Cabinet starting at 10.30 a.m. allows for group meetings prior to them starting. Other Committee meetings I prefer them to stay in line with current practise. Agendas are usually long, an early start allows for business to be concluded by mid afternoon. I am fortunate in having a relatively short journey to County Hall, but for those whose journeys are longer these times suit best.
- 9. 10 a.m. preferred. I have expressed preference for morning meetings as PM or evening meetings would be very difficult for an area like Powys which is a very large rural area where members have to travel considerable distances.
- 10.10 a.m. preferred in order to provide full debate on issues and continue to the afternoon if necessary.
- 11.10.30 for Council, 10 a.m. for Scrutiny and Shire Committees. I have changed my part time work to fit in with meetings over the past 4 years so I would prefer not to change again.
- 12.6.00 p.m. preferred. Democracy should be easy to access and with that, it should be a process that every one can take part in. At present, Powys holds its meetings between "9 -5" and I think that this discourages interest and people from standing for election. This in turn stops the Council being representative of the communities it represents. If local government is to be truly representative and encourage people from all sections of society then being a councillor must be a viable option for

lifestyle. Daytime meetings choke this off and that is why large numbers of seats are uncontested!

- 13.10 a.m. preferred for Council, Cabinet and Shire meetings. 2.00 p.m. preferred for Regulatory, Scrutiny etc. I have expressed the above times. Perhaps some of the meetings could follow the morning meetings to save on travel expenses.
- 14.10.00 a.m. preferred. There are various organisations in my constituency that have their meetings in the evening. I either attend these meetings as a member of the organisation or in my capacity as the local County Councillor. If County Council meetings were to be scheduled in the evening I suspect my ability to attend these community meetings in my constituency would be seriously affected.
- 15. Generally I consider 10.00 to be a reasonable time for committees to meet given the long distances many members have to travel. I've suggested 10.30 for scrutiny Committees to enable them to have a half hour pre meeting before the formal meeting starts; and 9.30 for Shire Committees because all Members are closer. Personally I'd prefer meetings to start as early as possible if it meant they'd finish sooner – regrettably I suspect they'd just last longer.
- 16. A starting time of 10 a.m. appears to me to be a fair compromise in view of the considerable distance many Councillors have to travel. On a personal basis I am usually available to attend at any time.
- 17.10 a.m. preferred to take account travel time.
- 18.10.30 Council, 10 Regulatory and Scrutiny, 9.30 Shires. Times are convenient as they allow me to get my routine farm work done although 10 a.m. in Brecon for a Regulatory meeting is a bit of a push. Evening meetings out of the question!
- 19. I am not on some of the above but I feel 10 a.m. allows time for those who have furthest to travel and enable meetings to finish reasonably early in the afternoon. For myself <u>usually</u> any time is alright but I feel mornings are better than evenings. However, there are of course exceptions and sometimes it is expedient to have a meeting following a previous meeting to save travelling time and this would normally mean afternoon meetings.
- 20.9.30 a.m. preferred. Very often I have mid-afternoon meetings of local organisations. Late afternoon/early evening meetings would not be suitable as a general rule because of local commitments etc.
- 21.10 a.m. start for meetings with normally 1 pm finish suits me as I have 1 hours travelling time to get to Llandrindod Wells.
- 22.10.30 a.m. preferred for Council, Cabinet, Regulatory and Scrutiny Committees and 10.00 a.m. for Shire Committees due to time taken up travelling to meetings. Time also taken by receiving and sending phone calls during the working day.
- 23.10 a.m. is really best to start meetings but bearing in mind where some of us have to travel from weather conditions during the winter months could be difficult for an early meeting start.

- 24.10 a.m. for Council, Cabinet, Regulatory and Scrutiny meetings 10.30 a.m. for Shire committees seems a sensible time to start. It means that the business has a reasonable chance of being completed before lunchtime. This is important so that members can spend the afternoon on case work etc. I would not argue if 10.30 a.m. was a more popular starting time.
- 25.9 a.m. start being 1st choice rather than 10 a.m. otherwise the evening should be considered for some committee meetings. For those of us who also work thought should be given to fitting more meetings in with a working day either at the start or end of end of the day.
- 26. I do think the committee meetings should rotate for members of the public to be able to sit in if they want as the Regulatory Committee does. If Members are working part time are some "set" days better for them? I have now become accustomed to meetings starting at 10 a.m. in Llandrindod. If meetings are held in areas further north/south allowance should be made for extra travel. There is no train from Ystradgynlais. What about other means of public transport?
- 27.10 a.m. preferred. Travelling times of 1 hour plus each way.
- 28.10. a.m. preferred. I prefer an early start time so that you can have an afternoon to do some jobs. Full Council to start at 10.30 which would enable groups to meet prior to the meeting.
- 29. Council 11.30, Cabinet, Regulatory, Scrutiny 10.30, Shire Committee 10.00 a.m. Full Council starting at 11 a.m. allows for group meetings to take place beforehand.
- 30. Council and Cabinet 10.30 a.m., Regulatory, Scrutiny and Shires 10.00 a.m. All times I have indicated do not impose undue early starts for Members who have to travel longer distances to attend.
- 31. Council 10.30 a.m., Cabinet, Regulatory, Scrutiny and Shires 10.00 a.m. It takes me 45 minutes to drive from home to County Hall so including parking and getting lap top up and running I need at least an hour to get from home and to be ready for a meeting. I have commitments at home to fulfil first in the mornings so any earlier than 10.00 a.m. is difficult. With group meetings before full Council these are best started later.
- 32. Council, Regulatory and Scrutiny Committees 10 a.m. Shire Committees afternoon. I would prefer later meeting times but due to travelling time and meeting time 10 a.m. is acceptable for all day meetings. Shire meetings although would be preferable late afternoon due to work commitments.
- 33. Council, Cabinet 10 a.m. Regulatory and Scrutiny Committees 10 a.m. or 1.00 p.m. Shire Committees 9.30 a.m. 10.00 a.m. gives time for the 1 hour 20 minute journey to Ystradgynlais with a chance of completing business by lunchtime. This gives time to return to Ystradgynlais to deal with other matters. 1.00 p.m. meetings starting at this time can follow other morning sessions providing an opportunity to finish business by 4.00 p.m. or 4.30 p.m. thus giving some breathing space for evening appointments, should they arise.

- 34.1 am content with current arrangements.
- 35.10 a.m. gives ample time to travel. Not interested in evening meetings. Shire Committee could start at 2.00 p.m.
- 36.10 a.m. meetings fit in best with public transport without going into the afternoon so far that it is difficult to get back or breaking up the day too much, Evening meetings would be almost impossible for me to attend for this reason. From January I will have caring responsibilities and so 10 a.m. starts and afternoon finishes will fit in best with childcare and enable me to attend local meetings in the evenings.
- 37. Generally I am flexible for time but mornings are preferred to allow afternoon free for casework and ward visits.
- 38.9.30 a.m. preferred. A standard start time is good for all. I also think there should be a compulsory finish time and say 2 p.m. would allow 4 and a half hours I do not believe concentration is maintained over 4 and a half hours. Also officers and staff would be able to manage their days better.
