### A. General Standards Issues for County Councillors and Co-opted Members

#### A1 Appointment of Standards Community Sub-Committee

- A1.1 The Town and Community Council elections in May 2012 brought to a close the term of office for Town and Community Councillors sitting on the Standards Community Sub-Committee. A postal election (nominations followed by ballot) was held to elect three Town and Community Councillors one each to represent Brecknockshire, Montgomeryshire and Radnorshire for the new term of office.
- A1.2 The result of this postal ballot is as indicated on the ballot papers attached as **Appendix 1**: the votes for each candidate being shown in Column 4. Accordingly the successful candidates are: -

Brecknockshire Hugh Pattrick (Ystradfellte CC)
Montgomeryshire Derrick Pugh (Trefeglwys CC)
Radnorshire Claire Evans (Rhayader TC)

- A1.3 The function of making the formal appointments to the Sub-Committee has been delegated to the Standards Committee and accordingly the Committee is requested to formally appoint the new Sub-Committee to comprise the 5 Independent Members; the 3 Community Councillors referred to above and one of the County Councillors sitting on the main Committee.
- A1.4 The term of office to be served by those appointed to the Sub-Committee will be the maximum term permitted by Regulations. Currently this is 4 years but this may be extended by later legislation given that the current term of Councillors is 5 years until May 2017.

#### A2 Code of Conduct Training

It will be necessary to arrange a training session on the Code of Conduct for those six County Councillors and one Independent Member who were unable to attend the session held on 16<sup>th</sup> May 2012.

- The three Town and Community Council representatives appointed to the Standards Community Sub-Committee.

Involvement With	(i) Matters relating to the School Modernisation Programme – Gwernyfed Catchment.
Business To Be Considered	General Matters
Background	The County Council is undertaking a review of its school provision on an area basis. Area Project Groups have been established which consider options which then become recommendations for consideration by the Council's Cabinet.  County Councillor Ratcliffe is a member of the Council's Cabinet.  The Gwernyfed Catchment Area review involve schools in County Councillor Ratcliffe's electoral division. Councillor Ratcliffe was a former trustee of the Hay and District Sports and Community Association and his father in law is currently Chair of that organisation. He also owns and runs a take-away business in the town of Hay-on-Wye which could be affected by the development of a supermarket in the town which is part of the modernisation proposal for Hay-on-Wye.  The Standards Committee at its meeting on 4 <sup>th</sup> July, 2011 granted a blanket dispensation to County Councillors to enable them to take part in meetings relating to the school modernisation process unless it related to a pecuniary interest.  The applicant is seeking a dispensation to:  (i) Speak at a meeting
STEP 1 Personal Interest(s) under paragraph 10 of the Code.	In relation to the Hay and District Sports and Community Association (HDSCA) Councillor Ratcliffe has a personal interest under paragraph 10(2)(c)(i)(bb) and 10(2)(c)(v)(bb) of the Code relating to the membership of his father in law of the organisation. However the blanket dispensation issued by the Standards Committee applies to this personal interest, and this is not an issue which requires consideration by the Committee.  The other personal interest which Councillor Ratcliffe has is in relation to his business under paragraph 10(2)(a)(i) of the Code.  "You must regard yourself as having a personal interest in any business of your authority if it relates to, or is likely to affect any employment or business carried on by you"
STEP 2 Exemptions under paragraph 12 (2) & (3) of the Code.	In relation to County Councillor Ratcliffe, none of the exemptions in Paragraph 12(2) would apply in relation to the personal interests.
STEP 3 Application of "public perception" test under paragraph 12 (1)	In applying the Paragraph 12(1) test in relation to the business involving the school modernisation process it is suggested that the Committee approach the issue in this way i.e. to ask itself:

	"Is it reasonable to suppose that the public perception would regard the Councillor's personal interest, as so significant that whenever a proposal regarding the school modernisation process was discussed at the Area Project Board / Cabinet / Council the potential conflict of interest would be so significant as to be likely to prejudice his / her judgement of the public interest in performing his / her role as a County Councillor?"  In applying the Paragraph 12(1) test in relation to this matter it is difficult to conclude that the Committee would answer this question otherwise than in the affirmative i.e. that a prejudicial interest would exist in this situation, unless the business under discussion is of such a nature that it would be categorised as trivial, insignificant or uncontentious.
STEP 4 Ground(s) on which dispensation could be granted	In relation to the County Councillor the grounds which could be considered for this matter would be grounds (d) and (f), namely:  (d) The nature of the Member's interest is such that the member's participation in the business to which the interest relates would not damage public confidence in the conduct of the relevant Authority's business.  This ground enables the grant of dispensation to speak and vote or to speak only.  (f) The participation of the Member in the business to which the interest relates is justified by the Member's particular role or expertise.  This ground enables the grant of dispensation to speak and vote or to speak only.
STEP 5 Determine the application:-  (i) Refuse (ii) Approve:- (a) attend (b) speak (c) vote (d) exercise Board Function (e) seek to influence (f) make written communications (g) make oral representations	The applicant has requested a dispensation to attend meetings of the County Council (which will include meetings of the Area Project Board, the Cabinet and the County Council) to speak only, on matters relating to the school modernisation process for the Gwernyfed Area Catchment Review.  In relation to Councillor Councillor Ratcliffe, it is uncertain as to what extent his business will be affected by the development of a supermarket in Hay-on-Wye. As the school modernisation process is generally a contentious issue there is an expectation that County Councillor Ratcliffe as the local member is involved at meetings representing his electorate.
RECOMMENDATION:	In view of the fact that County Councillor Ratcliffe has indicated that the dispensation should extend to speaking only at meetings (which will include meetings of the Area Project Board, the Cabinet and the County Council), it is suggested that

it would not damage public confidence if the councillor was granted a dispensation to speak but not vote on all matters relating to the school modernisation process for the Gwernyfed Catchment Area. Therefore he should be granted a dispensation under paragraphs (d) and (f).

#### **Attendance at Council Meetings**

Prior to the last meeting of the Standards Committee you received a letter and list of Member attendance from November 2011 to May 2012. This communication resulted in some Members querying the way that attendance was calculated for the consideration by the Standards Committee.

The Committee has agreed to re-examine the issue at its September meeting but in the meantime has required that Members receive further clarification on the way that Member attendance is calculated.

The Standards Committee monitors attendance at the main council committees on a twice yearly basis. The periods for calculation of attendance levels run from the Annual council meeting in May to the 31<sup>st</sup> October and the 1<sup>st</sup> November to the Annual Council meeting in May. The Standards Committee also acknowledges that there is some Council business which should count towards the attendance calculations and this includes meetings of:

- Brecon Beacons National Park
- Dyfed Powys Police Authority, and
- Mid and West Wales Fire Authority.

The Committee has set a level of 60% attendance below which it seeks an explanation from Members as to their reasons for absence. The Standards Committee accepts that Members have other duties as County Councillors which may require their attendance but consider that the 60% level for committee attendance allows sufficient time to undertake such other duties.

The Standards Committee whilst also acknowledging that Councillors undertake many other duties on behalf of their constituents has concluded it is not practical to capture and collate this information and therefore it cannot be taken account of in calculating the set level of 60%.

If Members have any suggestions as to a fairer, proportional method for calculating attendance the Committee will of course consider them.
