#### **C1.1 Local Resolution Process**

The draft Local Resolution Process agreed at the last meeting was approved by the Democratic Services Committee in July and will be considered by the County Council as part of the new constitution.

#### **D** Dispensations

#### **D1.1 Applications - County Councillors**

Applications from County Councillors Aled Davies and Gwynfor Thomas

County Councillor G. Williams and Independent Member S. Jarman declared an interest and left the meeting.

Observer C. Evans left the meeting.

Councillors Davies and Thomas have applied for a dispensation to speak and vote on matters relating to the control of bovine TB. They wish to put a motion to Council regarding the participation of farmers in Powys in a proposed trial on the eradication of TB. It is the case that at least 20 Members may be in a similar position and may have to declare an interest in a debate on bovine TB.

Councillors Davies and Thomas are cattle farmers and therefore would have a personal and prejudicial interest in any debate on bovine TB. The dispensation that is sought is to attend a meeting, speak, seek to influence a decision, make written representations and make oral representations on matters relating to the control of bovine TB. It is noted that decisions regarding the control of bovine TB lie with Welsh Government and the role of Powys is effectively limited to lobbying. As such the decision regarding lobbying made at the Standards Committee meeting of 11<sup>th</sup> November 2013 applies namely:

The Committee agreed that a dispensation to speak and vote should be granted if the following general principles were met:-

- (1) That the motion/decision involves lobbying for a revocation or variation or the influencing of a decision or proposed decision that has been made or is to be made by a body other than Powys County Council; and
- (2) Where the matter affects a significant proportion of the Council/
  Cabinet/Committee so as either (a) no fewer than half of the
  members of the Council/Cabinet/Committee which is to consider
  the business has a personal and prejudicial interest in that
  business or (b) the inability of member(s) to participate would
  upset the political balance of the Authority or committee or Cabinet
  such that the outcome would be likely to be affected; and
- (3) The issue is not one in which the Council is being consulted upon by an outside body (as those matters will be dealt with by officers and/or portfolio holders and influence/lobbying occurs as part of the consultation process).

Committee agreed that the general principles had been met in this case and

#### **RESOLVED THAT**

- i) a dispensation be granted to those Members who are cattle farmers (including Members whose spouse or partner is a cattle farmer) to speak and vote on matters relating to bovine TB.
- ii) a dispensation be granted to those Members whose family or close personal associates are cattle farmers to speak and vote on matters relating to bovine TB.

#### REASON FOR RESOLUTION

- i) due to the rural nature of the county a significant proportion of the Council was affected and unable to take part in a discussion on this matter, and
- ii) that no fewer than half of the Members of the Authority or of a committee of the Authority by which the business is to be considered has an interest which relates to that business,
- iii) that the interest is common to the Member and a significant proportion of the general public, and
- iv) that the nature of the Member's interest is such that the Member's participation in the business to which the interest relates would not damage public confidence in the conduct of the relevant Authority's business.

#### D1.2 Blanket Dispensation - Council Tax Discount

County Councillors P. Medlicott and G. Williams and Independent Members S. Jarman and H. Rhydderch-Roberts declared an interest and left the meeting.

Observers C. Evans and D. Pugh declared an interest and left the meeting.

At a meeting of the County Council on 22<sup>nd</sup> October 2014 Members will be debating a recommendation from Cabinet that from 2015 the Council tax discount for unoccupied and substantially unfurnished dwellings shall cease.

It is understood that a number of Members may have personal and prejudicial interests with regard to this item particularly those who own property other than that in which they live, who have family or close friends who own property other than that in which they live or who are in receipt of such discount.

Discussion centred around the financial implication of any such decision and the public perception that those taking such a decision should be untainted by any connection to any actual or potential benefit/disbenefit in relation to a council tax discount.

- (i) A dispensation be granted to Members who personally have (or have a close relative, person living with him/her or a close personal associate who has) a property in Powys which is both unoccupied and substantially unoccupied but available or potentially available to sell or let to make written representation to the Monitoring Officer by 5.00pm on 21st October 2014. Such Representations may not attempt to persuade Members on the outcome of the debate but may give information or provide scenarios that should be taken into consideration. Any representations received to be made available to Members eligible to participate in the debate.
- (ii) Members covered by the dispensation in (i) above do not have a general dispensation to participate in the debate and should consider declaring their personal, prejudicial and pecuniary interest in the debate.
- (iii) In the event that a debate on the Report cannot take place due to the lack of a quorum of Members without a personal and prejudicial interest, the Standards Committee will be prepared to consider the matter again.

# E Late payment of expenses
