Council considered the Powys Local Development Plan Deposit Plan, Volume 1 – Written Statement, Volume 2 – Proposals and Inset Maps, the Habitats Regulations Assessment Report (HRA), the Environmental Report (Strategic Environmental Assessment) (SEA) and the Sustainability Appraisal Report (SA).

Council discussed extending the consultation period and officers agreed that it would be possible to extend it to the first week of September but that it would be difficult to go beyond that. The consultation date would be confirmed subject to final editing and translation. Officers confirmed that typographical errors in the report would be corrected before the documents were sent out for consultation. The Lead Professional was delegated authority to make minor amendments to Deposit Draft LDP and any

amendments to the assessment reports arising from changes agreed by Council to the Deposit Draft LDP.

Having heard the officers' presentation and debated various parts of the Plan, **Council resolved to make the following amendments:-**

**1. Policy RE1 - Renewable Energy**

**RESOLVED to delete from paragraph 1ii. The following :- “Where they support diversification of, and remain subordinate to, an existing rural enterprise”**

**2. Policy H4 – Affordable Housing Contributions**

**RESOLVED to amend the target contribution for Central Powys from 30% to 20%.**

**3. Hierarchy of Settlements**

**RESOLVED to standardise the terminology for the hierarchy of settlements to Towns/Large Villages/Small Villages/Rural Settlements.**

**4. Policy H10 - Removal of conditions / planning obligations**

**RESOLVED to amend Policy H10 to read:-**

**Applications to remove restrictions on the occupancy, sale price or size of a dwelling which continue to serve a useful planning purpose will only be permitted where:**

**Evidence is provided demonstrating unsuccessful attempts to sell the property; and**

**A financial contribution is paid towards the provision of affordable housing equating to 50% of the gross uplift in the value of the property resulting from the removal of the restriction.**

**5. Policy H7 - Rural Affordable Homes**

**RESOLVED to delete from criterion 1 the words “In exceptional circumstances where justified by a specific household's needs, a higher floor space may be acceptable up to a maximum of 115 sqm.”**

**6. Policy W2 - Anaerobic Digestion on Farms**

**RESOLVED that the whole of Policy W2 – Anaerobic Digestion on Farms be deleted.**

**7. Powys Local Growth Zones**

**RESOLVED that the Professional Lead Spatial Planning & Built Heritage (Place) be given delegated authority to include a reference**

to Powys Local Growth Zones in the Economic Development section of the plan.

#### **8. Inset Maps**

**RESOLVED** that proposed site P58 HA9 be removed from Inset Map P58E.

**RESOLVED** that the Portfolio Holder for Regeneration and Planning be given delegated authority to deal with site specific issues with local members, including a replacement allocation for the allocated site removed in Ystradgynlais.
