5.	CHIEF EXECUTIVE'S BRIEFING	CC66 – 2014

The Chief Executive advised that the Council would be using the Show to promote tourism and Powys as an events county.

He noted that there had been a very successful proclamation event for the 2015 National Eisteddfod in Meifod. The Council would be represented at the 2014 National Eisteddfod in Llanelli and would again be using the event to promote the county as a tourist destination.

The Chief Executive reminded Council of the statement made by the Minister for Local Government and Government Business advising that the 2015/16 budget settlement would be between -1.5% and -4%. Cabinet and Management Team were preparing a series of community based budget consultation events in the last week of September and first week of October.

The Chief Executive closed his remarks by thanking the Head of Schools, the education team from Ceredigion County Council and the schools based staff for their work in bringing about improvements to the Education service so that Estyn no longer judged it to be in need of significant improvement.

7. ANNUAL COUNCIL REPORTING FRAMEWORK CC68 – 2014

The Strategic Director People presented her annual report as the Statutory Director of Social Services for the period 1st April 2013 to 31st March 2014. The report set out the delivery, performance and risks as well as plans for improvement on the full range of Social Services functions. It would be used by the Care and Social Services Inspectorate for Wales to inform their independent evaluation of Powys and their inspection plan for the coming year. The Strategic Director paid tribute to her staff for their work in delivering services.

Council noted the population projections forecasting a 169% increase in the numbers of people aged over 85 by 2036 and the challenges that would bring, particularly in light of further budget cuts. The Leader advised that he had been discussing this with colleagues from other rural authorities so they were able to present a united front to Welsh Government when lobbying for resources for services.

Other Members queried whether by adopting only Welsh names the Council would be in breach of the Welsh Language Act which provided for equality of treatment of English and Welsh.

County Councillor A.G. Thomas put forward an amendment, duly seconded, that consideration of the motion be deferred for the Monitoring Officer to look into whether by adopting the motion the Council would be in conflict with the provisions of the Welsh Language Act.

Powys dairy and beef farmers are under extreme pressure. There has been a significant fall in the beef price at the farm gate over the last 12 months and TB outbreaks continue to have a devastating effect on both dairy and beef farms. Powys County Council calls on the Welsh Government to conduct a joint trial throughout Powys on the eradication of TB. This trial would be at no cost to the Welsh Government. The trial would only involve the Welsh Government issuing a licence to farmers who have suffered a TB outbreak. The aim of the trial would be to establish if there is an effect on TB incidents on Powys farms when a farm is issued with a licence that permits the farmer to control the badger population on that farm on the same day the Livestock Movement Restriction is issued due to a TB outbreak. Powys County Council would monitor the success of the trial by recording the incidents of TB over the period of the trial. The aim of the trial is to have a very focused targeted approach to the incidents of TB.

The following is a petition by Cilmeri Community Council calling on Welsh Government to enhance, improve and promote Llywelyn's monument. The petition will be presented to the National Assembly for Wales Petitions Committee at the Royal Welsh Show.

"Due to the National importance of our Prince Llywelyn Monument we, the Community of Cilmeri call, on the National Assembly for Wales to urge the Welsh Government to: - Install locational signage boards, incorporating a brown signage battlefield icon, to denote the historical significance of our village, on the A483 at both main road entrances to the village; - Work in partnership with Powys County Council, Cilmeri Community Council and CADW to help maintain the famous monument, so that visitors can enjoy our national historical amenity in a safe and befitting environment; - Help identify resources to implement, in a phased manner, the Lloyd Brown Interpretation Plan (January 2013), commissioned by CADW. Additional Information: The interpretation plan highlights the fact that Llywelyn was the last native Welsh Prince to fall in battle, marking the effective end of the

powerful dynasty of Gwynedd, which played an important role in forging a sense of Welsh nationhood and identity."

We ask for Powys County Council to support this petition.

In presenting the motion, Councillor Price thanked William Powell AM for raising the matter in the National Assembly and the Portfolio Holder for Regeneration and Planning and the Tourism Officer for their support. He advised that there was an e petition which would be presented to the Minister at the Royal Welsh Show and he encouraged fellow members to sign it and to bring it to the attention of their communities. County Councillor G.P. Vaughan spoke to second the motion in the absence of Councillor W.D. Powell.

15.1 Question to the Portfolio Holder for Highways and Environmental Health from County Councillor Gareth Ratcliffe

Can the portfolio with responsibility for graveyards confirm all avenues will be examined to find suitable area to extend Hay-on-Wye cemetery before any plans are implemented. Concerns are being raised that all possible avenues have not been fully explored in a timely manner.

Officers of the Council have been exploring the potential to extend Hay on Wye Cemetery since 2007 when a report was presented to the Council's Board recommending the following:

1. Approval be given in principle to extending the cemetery
2. Approval be given to enter into negotiations with a local landowner to purchase adjacent land which was in private ownership.
3. Approval for the proceeds of the sale of the Cemetery Lodge to be used to finance the development.
4. That the pre-purchase of graves be suspended

Negotiations began with the owner of land to the south east of the cemetery to purchase an area of 1.672 acres. Discussions continued until 2008 when the agent for the landowner advised that his client was unwilling to sell and was prepared to wait until the land achieved its full development value.

At that time, the land was outside the development limit and was agricultural land. This remains the case today.

Adjacent Council owned land at the recreation ground had been previously considered but at that time no further progress was made with the proposal as it was considered that parts of the recreational ground might form part of a larger scheme incorporating the re-location of Hay on Wye C P School and other uses.

The Council's Cabinet resolved not to proceed with the development on the 19th March, 2013.

The Cemetery Lodge was sold on the 23rd January 2014. However, by then Council had resolved that capital receipts would not be linked to specific projects. This being the case, a bid for funding for the project had to be made, resulting in £100,000 being set aside for the development.

Given the Cabinet's decision, the possibility of utilising part of the adjacent recreational ground owned by Powys County Council was re-examined. This would require consideration of the re-location of the existing cricket square to allow the ground to continue to be used by the cricket club.

Officers initially met with Cllr Ratcliffe to discuss the proposal on the 15th May, 2014. At the meeting it was agreed that Officers would subsequently meet with the Cricket Club and Town Council.

Officers met with a representative of the Cricket Club on the 22nd May 2014 and the Town Council on the 2nd June 2014 to discuss the proposal and to request their views in writing.

A response was not received from the Town Council until the 24th June, 2014. No response has been received from the Cricket Club to date, despite a reminder being sent on the 18th June.

An approach could be made to local landowners in the area before doing so it's important to consider the following:

- 1) *Depending on future burial rates, there could be as little as 2 years burial capacity remaining in the existing cemetery.*
- 2) *A pre-planning consultation has already taken place with the Brecon Beacons National Park Authority which suggests that the use of the recreational ground for the cemetery extension would be acceptable subject to other material considerations.*
- 3) *Any land identified for the development of the extension would be subject to planning approval. A pre-requisite to planning approval would be a groundwater assessment of the site which is likely to take 12 months to complete. In the event that planning permission is granted, it will take an additional few months to develop the infrastructure of the site.*
- 4) *Consideration also needs to be given to the additional cost of acquiring private land for the development.*
- 5) *In any negotiations to purchase land, the Council would have to undertake tests to determine the suitability of the land for use as a cemetery.*

In answer to Councillor Ratcliffe's supplementary question about the potential loss of recreational grounds, the Portfolio Holder confirmed that he would

consider all available options including approaching neighbouring land owners again.

15.2 Question to the Leader from County Councillor Gareth Ratcliffe

Can the leader please update the council on the programme for public consultation for transfer of assets to town and community councils? The council has stated they will be looking to transfer assets such as public conveniences and sports buildings such as changing rooms to town councils or sports groups. At the last meeting the portfolio holder for Public conveniences stated "I have instructed officers that we need to engage with Town and Community Councils beginning end of May – June and I am awaiting dates and times of those meetings and with whom." To date Hay Town Council have not been contacted and with the town council not meeting to September due to the summer break this does not leave suitable time for the council to set budgets and consult with their community.

The Authority has a policy that outlines our approach to Community Asset Transfers (CAT). A CAT can be instigated by Powys County Council or any community group, including Town and Community Councils, on properties where PCC is willing to consider this avenue. The process includes the completion by the Group of an Expression of Interest and if approved, a full Business Case. This is required to demonstrate that the community venture is required and sustainable. All CAT applications where the Business Case is recommended for approval, go via Cabinet. There is no separate programme for Town or Community Council transfers, with each Service considering this option as part of their modernisation agenda, using the Corporate Asset Policy and Corporate Property to guide and advise them.

With regard to the situation on public conveniences the Portfolio Holder is due to bring an update report to Cabinet shortly. This will enable us to consider how best to move forward having regard to the recent consultation by Welsh Government on a public health bill and the potential for wider collaborative working with town and community councils.

Sport buildings and pitches are being dealt with by the Recreation Service and discussions are ongoing where these facilities have been highlighted for transfer. A spreadsheet is attached showing the current position with regards successful or recommended CAT applications.

In relation to seeking asset transfers of outdoor sports areas and associated buildings, letters were sent out to related Town Councils on 9th December 2013 and 6th March 2014 following earlier letters in 2013. Outdoor Recreation Officers are continuing to seek meetings with Town Councils, and are encouraging Clubs to do the same, so as to ensure dialogue.

Meetings have taken place with Talgarth Town Council on 28th February 2014 and Ystradgynlais Town Council on 3rd July 2014, and a meeting with Hay-on-Wye Town Council is planned on 7th July 2014. The local member also invited the Crickhowell Town Council to attend a meeting with local sports clubs on 14th May 2014. A number of meetings have also taken place with Newtown Town Council and associated sports clubs, with another meeting on 7th July 2014.

Sue Simpson, the Partnership and Policy Manager, is taking the lead for Community Delivery; and Town and Community Council Liaison. Part of the role will be identify the blockages which communities experience when aspiring to take over facilities/services.

Councillor Ratcliffe asked in his supplementary question about the Council's plans to consult Town and Community Councils as they were awaiting the Cabinet's decision on public conveniences so they could set their budgets. The Leader advised that the report would be considered by Cabinet on 29 July and that arrangements would be made to meet Town and Community Councils soon after. Council was also advised that a team of officers was being established to liaise with Town and Community Councils.

15.3 Question to the Portfolio Holder for Highways and Environmental Health from County Councillor Gareth Ratcliffe

Can the portfolio holder for Highways please provide the number of claims against the council for pothole and drain damages to members of the public vehicles over the last 2 years. Please can the cost to the council be included also the number that were rejected by the authority?

The number of claims for the period 1st July 2012 to 1st July 2014 is as follows:


In relation to drain damages it is presumed that this relates to incidents of damage arising from vehicles hitting faulty manhole, gully covers etc. rather than claims arising from flooding of the highway. These claims are not recorded as a separate category. Some will be included as potholes e.g. where there is a failure of the tarmac around the frame. Others will be classed as general highway defects or drainage problems arising from flooding.

The processing of claims can take time and therefore there will always be a high number of open claims at any one time. Some of these will be straightforward claims whilst others will be longer term disputed claims. In general claims have to be submitted within three years although for minors this does not commence until they are 18 years of age. A claim can therefore be received up to 21 years after the event. This is unlikely however in the event of claims relating to pothole damage.

The settled value represents the total paid to claimants. The value against open claims is based on either the sum claimed or an assessment of likely settlement value. This is not an assessment of claims that are likely to be paid.

In addition to any settled claim costs there will also be staff charges for dealing with the claim. Costs for these are not recorded separately. Under the terms & conditions of our public liability insurance policy it is a requirement that all claims or potential claims are notified as soon as practicable to the Loss Adjustors appointed by the insurer to handle our claims. Standard charges are applied for these of £105 for damage for property and £255 for personal injury claims.

The trend for the last five years is shown below.



There was no supplementary question.

15.4 Question to the Leader and Portfolio Holder for Waste from County Councillor Gary Price

How much income has Powys County Council received since the introduction of the orange garden waste sacks?

There has not been time to research the figures before 2007.

It is important to note that the scheme was never intended to raise income, it is simply a last resort for people who are unable to take their garden waste to a Community Recycling Site or a Household Waste Recycling Centre. The cost is intended to persuade residents to use the alternative options (including home composting) as these bags are unfortunately collected with the residual waste and hence landfilled.

In answer to Councillor Price's supplementary question, Councillor Thomas said that he could not agree that they were an unnecessary charge on those unable to take their waste to a Community Recycling Site or Household Waste Recycling Centre as people had to be discouraged from putting waste in landfill.

15.5 Question to the Portfolio Holder for Property and Assets from County Councillor Gary Price

Can the Portfolio Holder provide me with details of all Powys County Council leased buildings where the lessees receive an annual payment from PCC? To include the amount paid for the lease and annual payment paid.

The Portfolio Holder explained that the answer to this question was still being compiled and that it would be made available to Members at a later date.

15.6 Question to the Portfolio Holder for HR from County Councillor Gary Price

Can the Portfolio Holder provide me with the numbers of staff per directorate that have just ceased employment with PCC via the recent voluntary severance scheme?

From data taken off the Trent system and reconciled with the Human Resources voluntary severance data base a total of 290 employees have left the employment of the Council this year through the Voluntary Severance Scheme. The breakdown is as follows;

Resources Directorate - 41 employees

People Directorate - 113 employees

Place Directorate - 67 employees

Schools - 53 employees

Change and - 16 employees

Governance Directorate

There have also been 23 employees who have taken a voluntary reduction in working hours via the Voluntary Severance Scheme.

Councillor Price's supplementary question was on the total amount paid to the 290 employees who left the employment through the Voluntary Severance Scheme. The Portfolio Holder indicated that he did not have that information to hand and he felt that the supplementary question was not related to the original question.

15.7 Question to the Portfolio Holder for HR from County Councillor Gary Price

Can the Portfolio Holder provide me with the numbers of staff per directorate that have either been reemployed on temporary / permanent contracts or via a zero hours contract that have just ceased employment with PCC via the recent voluntary severance scheme?

Up to 2nd June 2014 a total of 7 former employees have been identified as attached to the Trent system having finished through voluntary severance and subsequently returned to work for the Council in alternative roles. We are also aware there are a small number of former employees who are not included in these figures as they are still currently going through either an appointment process or are awaiting to be attached to the Trent system. All except 2 of the returning employees currently attached to the Trent system are returning on a zero hours contracts. The 2 employees who are not employed on zero hour contracts have returned to different posts which are on a lower salary and on part time hours. A breakdown is set out below;

The Council's Voluntary Severance policy does not provide any restrictions on former employees returning to work for the Council in alternative roles except for the 28 day restriction set out in the Modification Order. Any former employee who returns to work for the Council or takes up a suitable alternative post within 28 days with an employer cover within the Modification Order may not eligible for a redundancy payment.

All former employees are eligible to apply in the normal manner for any posts that become available with the Council.

In answer to Councillor Price's supplementary question, the Portfolio Holder said that as far as he was aware that all appointments had been made following the correct HR procedures but that if Councillor Price had information to the contrary he should make that information available.

15.8 Question to the Portfolio Holder for ICT from County Councillor Gary Price

As per the email sent out by the ICT Service Desk on 15.05.14 can the Portfolio Holder explain why 200 computers and approximately 100 pieces of ICT equipment have been identified as out of use following the recent audit?

The following email was sent to all staff on 15.05.14:

Dear Colleagues

Following a recent audit, we have identified around 200 computers which have not been used for the last 3 months. On top of this, with the recent staff redundancies, there are approximately a further 100 pieces of kit which could potentially be out of use.

Given the current climate, we cannot justify the continued purchase of new PCs, Laptops and the associated licenses, when we have so many un-used devices and licenses out there. Therefore we are urging all services to return any use-used kit they have.

We can offer two options to managers who have PCs or Laptops, which for any reason, are not currently in use.

1. If you have spare PCs/Laptops and do not envisage needing them in the future, we will hire your head of service £60 for a PC and £110 for a laptop. We will ensure any viruses associated with each device are stopped.

Please note: Should you subsequently decide that you need an additional PC/Laptop, you will then have to re-enter at the start of the refresh cycle for that device.

2. If you do not need the PC/Laptop now, but feel you may in the future – we can take the kit back in to be used elsewhere, but you can then retain a vacant ‘slot’. For example, should you need another PC/Laptop in 6 months’ time, we will issue you with a device and there will be no additional charges on top of what you are already paying.

Please note: If you returned a PC, you will receive a similar PC back - but it will not necessarily be of the same model. If you returned a PC, you cannot have a Laptop back in its place.

Please email ictservicedesk@powys.gov.uk with the following details of any devices you wish to return:

1. Asset number or Service Tag of each device – state if PC or Laptop
2. Location, Contact number and name of staff member acting as contact
3. Which option are you choosing from above? Option 1 – refund of monies, or Option 2 – retain vacant slot.
4. State your head of service

In addition to this, In the near future we will also be undertaking a full audit of ICT assets across the county. Any devices found, which are clearly not being used, will be taken back to be re-used elsewhere.”

As part of the software in use at the County, Information Services (IS) is able to determine when a computer last connected to the corporate network. When a computer has not accessed the corporate network for more than 3 months it is automatically “quarantined” and temporarily blocked from any further network access.

It was identified that at the end of financial year (2013/2014) we currently had over 200 computers tagged as quarantined. In addition IS undertook an exercise to identify equipment that may be able to be released from those staff that were leaving the authority under VSS/VR schemes, this identified a further 100 possible pieces of equipment.

Following the email the number of pieces of equipment returned to IS has been very low (Less than 25). To further aid the identification and redistribution of any unused assets, corporate property is now undertaking a

full audit of all locations and is collecting the asset information to enable further analysis of the data by IS. Once we have analysed this data we will be targeting service areas to recover these assets.

The Portfolio Holder agreed with Councillor Price's supplementary question that it was unacceptable for so many pieces of ICT equipment to remain unaccounted for and she advised that departments would be charged for unaccounted equipment.

15.9 Question 15.9 had been reinstated and was dealt with as a confidential item at the end of the meeting.

15.10 Question to the Portfolio Holder for Highways and Environmental Health from County Councillor Gary Price

Can the Portfolio Holder provide members with the reason why the former Head of Highways, Transport & Recycling ceased employment with Powys County Council?

Richard Hobbs decided to retire after 39 years of loyal service to the Council. This was communicated to Members at the time and a copy of the communication is shown below

"Dear Colleagues

I wish to advise you that the Head of Highways, Transport & Recycling; Richard Hobbs has retired from the Council after 39 years service.

Richard will be missed by both Members and Staff throughout the organisation many of whom know him personally. He will leave behind a legacy of commitment, integrity and hard work which has benefitted the Council significantly over many years of service.

There was no supplementary question.

15.11 Question to the Portfolio Holder for Employment Services from County Councillor Gary Price

How many staff employed by Powys County Council receive a hourly rate below that of the Living Wage?

How much extra would it cost Powys County Council to pay those employees the Living wage?

Total Number of Positions 1099

Total Number of People 923

The total cost of implementing the Living wage based on the June 2014 Payroll run would be approximately £402k (inclusive of on-costs). The large proportion of employees (70%) would be in the job categories of Cleaners and General Kitchen Assistants.

In answer to Councillor Price's supplementary question, the Portfolio Holder advised that any additional costs would have to be found from within existing budgets.

15.12 Question to the Leader from County Councillor Peter Lewis

Through the Llanfyllin representative on the Montgomery Forum on our town council I have learned that Powys are attempting to devolve responsibility for some services to 'clusters' of community councils. What services are involved and why has a matter as fundamental as this not been put before full council for debate?

The need to find savings of £40m over the next three years plus a further estimated £30m from 2017 to 2020 means that the Council needs to consider how services can be remodelled so as to protect them rather than cut them.

One option that needs to be explored is alternative methods of service delivery, including working with Town and Community Councils. This was the subject of the seminar arranged for Members on 23rd June. The meeting heard from participants in a number of successful partnerships including social care and leisure projects.

These themes will be explored further at a series of summer and autumn community engagement events. The involvement and support of elected Members in these events will be key in helping to shape community delivery.

In addition, the Cabinet has recently approved a charter between the County Council and Welshpool Town Council. The Charter sets out the principles by which both authorities can work together, but no decisions have been taken on delegating responsibility for services at this stage.

In answer to Councillor Lewis' supplementary question about devolving services, the Leader explained that the Council needed to work closely with Town and Community Councils and their representative bodies, including One Voice Wales, to help deliver services at a time of ongoing budget cuts.

15.13 Question to the Portfolio Holder for Highways and Environmental Health from County Councillor Matthew Dorrance

What is the Council doing to promote and support cycling across the County?

For the past 10 years Powys CC has been very successful in attracting external funding to build new walking and cycling routes and the county has received in excess of a million pounds. Routes have been constructed in all areas of the county and range from the relatively small but very well used community link at Llanyre to the sizeable riverside path in Newtown. The Council has built entirely new routes in Ystradgynlais and Machynlleth, and developed a traffic-free link between Newtown and Welshpool in conjunction with the Canal & Rivers Trust. Promotional leaflets are available for most of these routes.

We have been successful in attracting the Tour of Britain to Powys for the past three years and will again host a race start at Newtown this year. Such high profile events promote the take up of cycling and will build on the current presence of the Tour de France in the UK.

The recent Active Travel (Wales) Act places new statutory duties on local authorities from September 2014. The Welsh Government intend to enable more people to walk and cycle so that they can experience the health benefits and support local economies. The County Council will be required to map the network of routes within their area that are safe and appropriate for walking and cycling to access work, education services and other facilities. It will also be expected to -

- *identify and map the enhancements that would be required to create a fully integrated network for walking and cycling;*
- *deliver an enhanced network by securing new and improved “active travel” routes and facilities each year;*
- *take reasonable steps to enhance walking and cycling provision as part of new road schemes and in new developments.*

The Council promotes and supports cycling through a number of initiatives:

Staff Cycle Leasing

A “salary sacrifice” Cycle to Work Lease Scheme is in place for employees. The scheme is cost neutral and enables the Council to promote healthier journeys to work and to reduce environmental pollution. The scheme has operated successfully for four years and, through the Council’s chosen provider - Cycle Solutions - it has recently partnered with local stores. This allows local cycle shops to supply bikes direct to the employee, helping to keep the £ in Powys. Of 54 cycles that were purchased in the March uptake – 50% of sales went to local dealers.

Staff Travel Incentives

A cycling allowance of 20p per mile has been introduced to encourage short and efficient business journeys to be made by bike and provide a saving on travel costs.

A rolling programme has improved cycle parking facilities at Council buildings throughout the county and most now have suitable cycle storage, personal lockers and, at some locations, showers.

New Developments

All proposed developments over a certain size now have to include a site Travel Plan to meet Planning requirements and these Plans have to promote cycling and provide suitable facilities. New school developments, as recently in the Ystradgynlais area, have also to adopt a Travel Plan that shows a commitment to increase cycling by pupils and staff. Other schools may also have Travel Plans in place, notably where these have been introduced as a condition of ‘Safe Routes to School’ or ‘Safe Routes in Communities’ funding. It is a Welsh Government objective that Travel Plans are introduced to all schools.

Local Service Board (LSB) and other partners

The County Council’s Corporate Travel Plan has been awarded the Welsh Government’s Regional Consortium ‘Gold’ standard and the Council continues to influence and assist other Local Authorities in introducing ‘Cycle to Work’ schemes.

The Council also holds the Corporate Health Standard at ‘Platinum’ level and the Corporate Travel Plan was the case study for this award in which cycling provision and initiatives played a key part.

Cycle Training Programme – Primary Schools

The Road Safety Unit offers every child the opportunity to complete cycle training before they leave Primary School. The course is based on the RoSPA “Righttrack” programme and is delivered over a period of 6 weeks. Approximately 1,300 children are instructed each year and wherever possible this will be through on-road training.

‘On Your Bike’ – Adult Training

The Road Safety Unit has just launched a new ‘On Your Bike’ scheme aimed at adults and which follows the National Standards Cycle Training programme.

The course provides an hour of free assessment by a qualified Instructor and is available to anyone regardless of ability. It is intended to increase cyclists' confidence & skills and to encourage more people to travel in a sustainable manner and make use of the county's growing cycle networks.

In answer to Councillor Dorrance's supplementary question about what the Council could do to reduce fear of road traffic amongst cyclists, the Portfolio Holder acknowledged the work of the road safety unit and explained that the Council was applying for grants to connect cycle routes.

15.14 Question to the Portfolio Holder for Employment Services from County Councillor Matthew Dorrance

Can the Council provide a statement on its use of zero hours contracts including the number of posts and the percentage of the workforce currently employed on zero hour contracts?

From an Employment Services understanding, the employees are not penalised in anyway and we recognise their statutory entitlements to both sickness and holidays. In fact, to comply with The Part-time Workers (Prevention of Less Favourable Treatment) Regulations 2000, all holiday entitlements are based on the occupational leave entitlements provided by PCC, which is in excess of the minimum statutory leave entitlement. Staff are entitled to claim accrued holiday pay for all basic hours worked, and would be assessed for the eligibility to sick payments when exceeding the statutory earnings thresholds.

Total number of positions/contracts = 2047

Percentage of Positions = 20%

Councillor Dorrance asked in his supplementary question about the benefits that the Council gained through employing people on zero hours contracts. The Portfolio Holder advised that there would be a report to Cabinet on 29th July.

15.15 Question to the Portfolio Holder for Education and Children's Services from County Councillor Matthew Dorrance

Can the Cabinet member inform Council of any plans to develop Flying Start in Powys?

At present the Council has not received confirmation from Welsh Government that Flying Start will continue after 2016.

Once we have this information we will look at the Welsh index of multiple deprivation and the Lower Super Output Areas in the areas identified with greater deprivation and cross reference with Children in Need data to ensure that the service will deliver in the area where the need is greatest in Powys.

Councillor Dorrance asked in his supplementary question what discussions the Council was having with Welsh Government giving uncertainty over the future of the scheme. The Portfolio Holder explained that the Early Years Review would strengthen the Council's evidential base in discussions with Welsh Government. The Council also needed to look to its own Powys based solutions, including working with partners in the third sector and in health to ensure that support was available for those who needed it.

15.16 Question to the Portfolio Holder for Customer Services from County Councillor Russell George

Does the cabinet Member believe that the local authority responds adequately and within its own timeframes to complaints made by the public?

The council has a formal complaints system which is used to record, manage and respond to complaints submitted to the council. Whilst the service provides an efficient service for the vast majority of complaints we are aware of cases where performance has fallen below the standards we demand. Management Team have discussed how the council handles complaints and are initiating a review of our complaints procedures to improve overall performance.

Details of response times filed with the signed minutes. There was no supplementary question.

15.17 Question to the Portfolio Holder for Adult Social Services from County Councillor Russell George

In regards to domiciliary care services:

Does the Cabinet Member believe that vulnerable adults are being adequately cared for by the companies that are proving domiciliary care services on behalf of the authority?

Our highest priority has always been the care and wellbeing of our citizens, the new providers were awarded contracts based on their ability to deliver quality care that puts the service users' needs first. We will continue to monitor the progress of our new providers, and ensure that the delivery of care is not just adequate, but of the highest standard. We have experienced some challenges with delivery in particular parts of the county as members have previously been advised; the Adult Safeguarding Team, Social Work teams and the Provider along with the Project Team have worked hard to address all concerns of vulnerability and each individual situation has been followed up.

Can the Cabinet Member provide details of the Independent review that is proposed to investigate what went wrong with the transfer of the Council's adult domiciliary care service?

Officers are currently developing a draft brief in relation to commissioning an independent review. We will continue to consult with key stakeholders including our service users, scrutiny members, Welsh Government and CSSIW on the development of the review and time frame. We will also continue to improve our services on the lessons already learnt to date.

Is the Cabinet Member confident that TUPE arrangements in regards to staff transferring from previous providers to Reach and Abacare are being correctly adhered to?

During the transfer phase, the council and our new partners informed all outgoing providers of TUPE arrangements. During recruitment, adverts were also placed in local newspapers informing staff of their TUPE rights including the offers of both zero and 16hr contracts. We are aware that there were delays with some outgoing providers informing their staff of TUPE arrangements to incoming providers, and that our new providers sought their own legal advice in this respect. Our new providers are committed to ensuring that they recruit sufficient staff to meet their contractual obligations and that all staff will go through robust induction and training in order that staff can work to the highest standard to ensure we can deliver high quality and cost effective services.

There was no supplementary question.

15.18 Question to the Portfolio Holder for Highways and Environmental Health from County Councillor Russell George

Can the Cabinet member provide an update on how the authority is carrying out enforcement?

The council of 5th March 2014, agreed "that the Council holds a full review of civil enforcement powers by the relevant Scrutiny Committee and also extends the powers relating to dog fouling to CEO's to combat the issue of dog fouling across the county". Please can the cabinet member provide an update on the progress of this?

(a) *The Authority has continued to carry out enforcement through the Environmental Health Team with practical support from LE staff (cleaning, signs, bins) when required.*

(b) *The issue of dog fouling has been considered by:*

- *the Environment, Infrastructure and Crime and Disorder Scrutiny Committee on 13th March 2014 when the County Council's intentions were noted alongside a response to the Community Safety Partnership. An outcome of the meeting was the establishment of a working group, comprising three Members, to commence the review. [Cllrs. Viola Evans (Lead), Arwel Jones and Dai Jones];*

- *the Enforcement of Dog Fouling Working Group which met on 26th March 2014 and the outcomes of that meeting were notified to all Members, primarily to assess the extent of local problems and whether reports were being made;*
- *the Joint Chairs and Vice Chairs Steering Group – Scrutiny, Audit and Democratic Services Committees, which considered feedback from the Working Group on 16th May 2014 and determined that the Group's remit should extend to considering the impact of dog fouling controls on current enforcement activity;*
- *the Enforcement of Dog Fouling Working Group met on 4th June 2014 to receive a presentation from Keep Wales Tidy and to review issues arising from the Steering Group's recommendations;*
- *the Environment, Infrastructure and Crime and Disorder Scrutiny Committee on 5th June 2014 when it considered [item 8.3] a progress report.*

Please can the Cabinet Member inform me if the authority has contacted Dyfed Powys Police to discuss the possibility for Police Officers and Community Police Support Officers, to be given authority to enforce Fixed Penalty Notices and if so, what was the outcome of this discussion?

The recent progress report noted that the police want this issue to be dealt with on a common basis across the force area. The Scrutiny Committee has agreed that the Police Commissioner should be contacted in support of PCSOs undertaking enforcement duties.

I am aware that other local authorities have contracted external organisations to enforce Fixed Penalty Notices. I am advised that the cost to the County Council can be negated by the income received from Fixed Penalty Notice fines. Has the Cabinet Member considered contracting external organisations to enforce Fixed Penalty Notices for the problem of dog foul and litter?

External organisations could undertake enforcement though it has not been established that the likely income would meet the enforcement costs. The Working Group will no doubt consider this aspect as part of their review.

There was no supplementary question.

15.19 Question to the Portfolio Holder for Finance from County Councillor Gary Price

How much has been allocated in this year's budget for the Montgomeryshire Concurrent Functions Scheme?

The sum allocated for the Montgomeryshire Concurrent Function scheme in 2014-15 is £95,250.

In answer to Councillor Price's supplementary question whether the Montgomeryshire Concurrent Function Scheme budget be subject to an efficiency saving if not would the scheme be introduced to Brecknockshire and Radnorshire, the Portfolio Holder advised that this budget would be subject to an efficiency saving, as would the budgets for the services in Brecknockshire and Radnorshire.

15.20 Question to the Leader and Portfolio Holder for Waste from County Councillor Aled Davies.

What options, including cost, do Powys County Council offer village halls to dispose of their rubbish?

The legislation (Controlled Waste Regulations 2012) states that where a premise such as a village hall is used wholly or mainly for public meetings, they are classed as household and will receive the standard collection service (including limitations on residual waste). If, however, village halls are used for events, which many are, they are classed as commercial and will be charged as any other commercial premises. The current trade waste and recycling charges are attached.

In answer to Councillor Davies' supplementary question, the Leader said that he could not give a commitment that there would not be further increases in charges.

15.21 Question to the Portfolio Holder for Communications and ICT from County Councillor Kathryn Silk

Further to my question to Council on 30th April, can the Cabinet Member for Communications and ICT give details of how many breaches of data protection occurred within the Planning Department during 2013/14?

In the financial year 2013/2014 there were two instances of a breach of personal data within the Planning Department of the Council; following personal data being disclosed via the Council's web site.

The personal data disclosed was not considered sensitive under the terms of the Data Protection Act 1998.

Both instances were investigated, and information legislation training specific to the services was provided to Managers within the Regeneration Property and Commissioning Directorate.

On both occasions the lessons learnt were incorporated into the development of new processes in the way that personal data is identified and handled when being placed on the Council's web pages.

Powys County Council continues with the development and implementation of robust information governance practices and the lessons learnt from information security incidents inform our further development.

A key element of these information governance practices is the mandatory training in Data Protection, ICT, and Information Security for all staff processing personal data as part of their duties. Current training figures stand at 99%.

Staff's understanding of their responsibilities towards the handling of personal data is evidenced in their compliance with the robust processes in place to identify and manage information security incidents.

Earlier this year auditors for the Information Commissioner's Office determined that Powys County Council demonstrates a reasonable level of assurance that process and procedures are in place and are delivering data protection compliance.

Based on information governance practices implemented and those which continue to be developed it can be considered that the Council is actively developing systems to safeguard compliance with information legislation, including the reporting and management of Information Security Incidents.

There was no supplementary question.

15.22 Question to the Portfolio Holder for Communications and ICT from County Councillor Kathryn Silk

Can the Cabinet Member for Communications and ICT give details of the Council's policy in respect of responding to correspondence. What percentage of correspondence has been answered within the specified period during the last period for which figures are available?

Details of the Council's policy for responding to correspondence are set out in the reply to Councillor Russell George's question.

The statistics for the period 1st April 2013 to 31st March 2014 are filed with the signed minutes.

15.23 Question to the Portfolio Holder for Affordable Housing from County Councillor Kathryn Silk

Can the Cabinet Member for Planning give details of how many affordable housing units have been approved for each year since 2011? What percentage of total housing approved does this represent?


Unfortunately it is not possible to supply these figures as requested. However, as a result of the Development Management Improvement Implementation Board, the Development Management service has recently installed the Northgate ICT software to record this information. The introduction of the Sustainable Development Indicators (SDI), introduced as of December 2013, will enable this information to be provided in future.

The graph below shows the number of Affordable Housing units approved versus the total housing units approved for the last four months of the 13/14 financial year (Dec – March) when 14 Affordable Units were approved out of 139.

Development Management would be able to provide the information requested by going through all Planning Applications where affordable housing has been granted Approval, for each of the years in question. For example, the figure relating to the last financial year (12/13) would mean assessing some 1013 applications, identifying the number of approved Affordable Dwelling units and comparing this with the total amount of dwellings that were approved in the period.

It might be helpful if I remind Members of a recent report presented to the Strategic Housing Partnership with the following information in relation to the Affordable Housing Delivery programme:-

Projection: Having now received reports from our Housing Association partners a projection of completion dates gives us the following information: by August 2014 Mid-Wales HA will complete 45 homes at Welshpool and 5 at Churchstoke and Melin Homes will complete 4 at Talgarth and 10 at Llangynidr. These completions alone will take us to 258 affordable homes provided in the One Plan period, a 29% over-target achievement. It should also be noted that the coming year will see, almost certainly, a further 45 PSH empty homes rented at affordable levels; and finally that the on-going SHG programme will see a further 229 completions between now and the end of the 2015/16 financial year.



15.24 Question to the Leader and Portfolio Holder for Waste from County Councillor David Meredith

In view of the rise in fly tipping within Communities can we be advised of how many people have been caught and, of those, how many have been prosecuted?

Waste Services generally deal with the more minor incidences of fly tipping, for example around Community Recycling Sites and next to Communal Collection Points. When we can find evidence, for example an address on an envelope, we do write to the alleged offender under Section 33 of the Environmental Protection Act 1990. In 2013/14, we sent out 60 such letters but none of these led to a prosecution.

Environmental Health deal with incidents on private land but similarly have not prosecuted anyone. Major incidents are dealt with by Natural Resources Wales.

In answer to Councillor Meredith's supplementary question on whether it was time to start issuing penalty notices, the Leader said that he would consult with officers as to whether the policy needed to be amended.

15.25 Question to the Portfolio Holders for HR and Finance from County Councillor David Meredith

Now that Job Evaluation has been implemented did the pot of money set aside for its implementation cover the total cost or did some services of the Authority suffer as a result of insufficient money being allocated for this purposes? If this was the case how were those services selected?

The budget set aside for JE was adequate (the grading structure was designed within budgetary constraints). However it was made clear to services from the outset of the JE project that they needed to ensure that the role descriptions submitted for evaluation were as accurate as possible as any additional costs associated with successful appeals would need to be borne by the services as they had not been budgeted for. The additional costs of successful appeals was approximately £800k.

In his supplementary question Councillor Meredith queried how the grading structure was designed within budgetary constraints when job descriptions were being assessed. Council was advised that JE had been achieved within budget and through a collective agreement with the trade unions.

15.26 Question to the Portfolio Holder for Education and Children's Services from County Councillor David Meredith

In view of the fact that current legislation is not preventing the continued exodus of parents taking their children out of school during term time what is the Authority doing to address this issue with ESTYN and Welsh Government?

As a member of the South West and Mid Wales Consortium (ERW), the region is developing a strategy for improving attendance. This includes a policy on fixed penalty notices which will be circulated to schools in the region in the Autumn Term.

Councillor Meredith welcomed the response and asked that Head Teachers be supported. The Portfolio Holder advised that the ERW policy was robust and that families who took their children out of school needed to be challenged.

15.27 Question to the Portfolio Holder for HR from County Councillor Gareth Ratcliffe

Can the portfolio holder for HR brief the council on the direction of travel for jobs in Powys County Council following the BBC News report headed "Big job cuts if budgets keep shrinking, warn councils" where the leader of the WLGA stated "if we are seeing this scale of reduction, unfortunately the biggest cost pressure, our biggest cost, are employees".

The council has reduced the number of posts by 215 in the current budget and further changes are underway. Given the requirement to save approximately £70m by the end of the decade it is inevitable that the size of the workforce will continue to reduce. However we are actively seeking other savings measures such as reviewing third party expenditure in order to minimise the impact on front line services and staff.

The Portfolio Holder declined to answer Councillor Ratcliffe's supplementary question on negotiations with the trade unions as he did not think that it was appropriate to do so in an open meeting.

15.28 Question to the Leader and Portfolio Holder for Waste from County Councillor David Jones

What is the council's position on collecting recyclables from the curtilage of domestic properties since the advent of the new recycling vehicles?

There has been no change in the Council's position. We request that residents place their recycling boxes and wheeled bins at the curtilage of their property by 7:30am on their day of collection. There are of course exceptions to this with communal collection points and where residents are on the assisted collection scheme.

In his supplementary question Councillor Jones asked if residents who had their waste collected by Cae Post had been given different instructions. The Leader said he would follow this up with officers.

15.29 Question to the Portfolio Holder for HR from County Councillor David Jones

What is the council's current policy on re- employing former members of staff who have retired? Can he envisage circumstances where they might return?

The Council does not have a policy that deals with the re-employment of former employees who have retired but is exploring the value and appropriateness of introducing a policy that deals with the re-employment of former employees generally.

There are circumstances where I would envisage a retired ex-employee being re-employed by the Council. It is highly unlikely that this would be in the previous role and on the same terms. Re-employment is more likely to occur into roles and on terms that better suit the lifestyle of a retiree. It will of course be recognised that ex-employees are commonly Powys residents and contribute to its economy. They are also likely to retain skills and experience that are valuable to the Council and may also be scarce in the local employment marketplace.

In answer to Councillor Jones' supplementary question, to consider introducing a policy to stop retired members of staff from being re-employed, the Portfolio Holder said that to do so would cause particular difficulties for schools many of whom employed retired staff as supply teachers.

15.30 Question to the Leader from Councillor David Jones

Could the Leader provide an update on renewal of the congress system for the council?

Officers have been asked to look at the cost of updating the microphones in the Chamber and Committee Room A at County Hall, the Chamber at Neuadd Maldwyn and the Committee Room in Neuadd Brycheiniog. The Cabinet have also asked that Scrutiny look at the requirements for a new system.

In answer to Councillor Jones' supplementary question as to why Scrutiny had been asked to look at this when Council had approved the budget, the Leader explained that this was a very expensive scheme and he wanted to be sure that all members were happy with the system that had been proposed.

O ystyried penderfyniad y Cabinet, cafodd y posibilrwydd o ddefnyddio rhan o'r maes chwarae cyfagos sy'n eiddo i Gyngor Sir Powys ei ail-archwilio. Byddai hyn yn golygu ystyried symud y sgwâr criced presennol i ganiatâu i'r tir barhau i gael ei ddefnyddio gan y clwb criced.

Cyfarfu swyddogion i ddechrau gyda'r Cyng Ratcliffe i drafod y cynnig ar 15^{fed} Mai, 2014. Yn y cyfarfod, cytunwyd y byddai Swyddogion wedyn yn cyfarfod gyda'r Clwb Criced a'r Cyngor Tref.

Cyfarfu'r swyddogion â chynrychiolydd y Clwb Criced ar y 22^{ain} Mai 2014 a'r Cyngor Tref ar 2^{il} Mehefin 2014 i drafod y cynnig ac i ofyn am eu barn yn ysgrifenedig.

Ni dderbyniwyd ymateb gan y Cyngor Tref tan y 24^{ain} Mehefin 2014. Ni chafwyd ymateb oddi wrth y Clwb Criced hyd yma, er i nodyn atgoffa gael ei anfon ar y 18^{fed} Mehefin.

Yn y cyfarfod diwethaf dywedodd y deilydd portffolio Cyfleusterau cyhoeddus "Rwyf wedi cyfarwyddo swyddogion bod angen inni gysylltu â Chynghorau Tref a Chymuned o ddiwedd mis Mai – Mehefin ac yr wyf yn aros am ddyddiadau ac amseroedd y cyfarfodydd hynny a manylion gyda phwy." Hyd yma, ni chysylltwyd â Chyngor Tref y Gelli a gan nad yw'r cyngor tref yn cyfarfod tan fis Medi oherwydd gwyliau'r haf nid yw hyn yn gadael digon o amser i'r cyngor bennu cyllidebau ac ymgynghori â'r gymuned.

Mae gan yr Awdurdod bolisi sy'n amlinellu ein dull o ddelio â Throsglwyddo Asedau Cymunedol (CAT). Gall CAT gael ei ysgogi gan Gyngor Sir Powys neu unrhyw grŵp cymunedol, gan gynnwys Cyngorau Tref a Chymuned, ar eiddo lle mae CSP yn barod i ystyried y trywydd hwn. Fel rhan o'r broses byddai'r Grŵp yn cwblhau Datganiad o Ddiddordeb ac os caiff ei gymeradwyo, Achos Busnes llawn. Mae hyn yn ofynnol i ddangos bod y fenter gymunedol yn ofynnol a'i bod yn gynaliadwy. Mae pob cais CAT lle argymhellir cymeradwyo'r Achos Busnes, yn mynd drwy'r Cabinet. Nid oes rhaglen ar wahân ar gyfer trosglwyddiadau Cyngor Tref neu Gyngor Cymuned, gyda phob Gwasanaeth yn ystyried y dewis hwn fel rhan o'i agenda foderneiddio, gan ddefnyddio'r Polisi Asedau Corfforaethol ac Eiddo Corfforaethol i'w harwain a'u cyngori.

O ran y sefyllfa gyda chyfleusterau cyhoeddus mae'r Deilydd Portffolio i fod i gyflwyno adroddiad diweddar gerbron y Cabinet yn fuan. Bydd hyn yn ein galluogi i ystyried y ffordd orau o symud ymlaen gan ystyried yr ymgynghoriad diweddar gan Lywodraeth Cymru ar fil iechyd cyhoeddus a'r potensial ar gyfer cydweithredu ehangach gyda chynghorau tref a chymuned.

Mae Swyddogion Hamdden Awyr Agored yn parhau i geisio cael cyfarfodydd gyda Chynghorau Tref, ac maent yn annog Clybiau i wneud yr un fath, er mwyn sicrhau deialog.

Cynhaliwyd cyfarfodydd gyda Chyngor Tref Talgarth ar 28^{ain} Chwefror 2014 a Chyngor Tref Ystradgynlais ar 3^{ydd} Gorffennaf 2014, ac mae cyfarfod wedi'i drefnu gyda Chyngor Tref y Gelli Gandryll ar gyfer 7fed Gorffennaf 2014. Mae'r aelod lleol hefyd wedi gwahodd Cyngor Tref Crughywel i fynychu cyfarfod gyda chlybiau chwaraeon lleol ar 14^{eg} Mai 2014. 

Os nad yw cyfrifiadur wedi cysylltu â'r rhwydwaith corfforaethol ers mwy na 3 mis mae'n cael ei roi mewn "cwarantîn" yn awtomatig a chaiff unrhyw fynediad pellach â'r rhwydwaith ei atal dros dro.

Ar ddiwedd y flwyddyn ariannol (2013/2014) gwelwyd bod gennym dros 200 o gyfrifiaduron a oedd wedi'u tagio fel rhai mewn cwarantîn. Yn ogystal, fe wnaeth GG gynnal ymarfer i ganfod offer a allai gael eu rhyddhau oddi wrth y staff hynny a oedd yn gadael yr awdurdod o dan gynlluniau diswyddo gwirfoddol. Fe wnaeth hyn ganfod 100 darn arall o gyfarpar posib.

Yn dilyn y neges e-bost ychydig iawn o ddarnau o offer a ddychwelwyd i GG (llai na 25). Mae'r angen i ddod o hyd i arbedion o £40m dros y tair blynedd nesaf, ynghyd ag amcangyfrif o £30m pellach rhwng 2017 a 2020 yn golygu bod angen i'r Cyngor ystyried sut y gall gwasanaethau gael eu hailfodelu er mwyn eu diogelu yn hytrach na'u torri.

Beth mae'r Cyngor yn ei wneud i hyrwyddo a chefnogi beicio ar draws y Sir?

Dros y 10 mlynedd diwethaf, mae Cyngor Sir Powys wedi llwyddo i ddenu llawer iawn o gyllid allanol i adeiladu llwybrau cerdded a beicio newydd, ac mae'r sir wedi derbyn dros filiwn o bunnoedd. Adeiladwyd llwybrau ym mhob rhan o'r sir ac maent yn amrywio o'r cyswllt cymunedol cymharol fach ond poblogaidd iawn yn Llanllŷr i'r llwybr hir ar lan yr afon yn y Drenwydd. Mae'r Cyngor wedi adeiladu llwybrau newydd sbon yn Ystradgynlais a Machynlleth, ac wedi datblygu cysylltiad di-draffig rhwng y Drenwydd a'r Trallwng ar y cyd â'r Ymddiriedolaeth Camlesi ac Afonydd. Mae taflenni hyrwyddo ar gael ar gyfer y rhan fwyaf o'r llwybrau hyn.

Rydym wedi llwyddo i ddenu ras feicio Taith Prydain i Bowys dros y tair blynedd diwethaf a byddwn unwaith eto'n cynnal dechrau ras yn y Drenwydd eleni. Mae digwyddiadau uchel eu proffil o'r fath yn hyrwyddo beicio a bydd yn adeiladu ar y presenoldeb sydd gan ras y Tour de France yn y DU ar hyn o bryd.

Mae'r ddeddfwriaeth ddiweddar, Deddf Teithio Llesol (Cymru), yn rhoi dyletswyddau statudol newydd ar awdurdodau lleol o fis Medi 2014 ymlaen. Mae Llywodraeth Cymru yn bwriadu galluogi mwy o bobl i gerdded a beicio er mwyn iddynt fwynhau'r manteision iechyd a chefnogi economiau lleol. - cyflwyno rhwydwaith gwell drwy sicrhau llwybrau a chyfleusterau "teithio llesol" newydd bob blwyddyn;
- cymryd camau rhesymol i wella'r ddarpariaeth cerdded a beicio fel rhan o gynlluniau ffyrdd newydd ac mewn datblygiadau newydd.

Prydlesu Beiciau i Staff

Mae Cynllun Prydlesu Beicio i'r Gwaith "aberthu cyflog" ar waith ar gyfer gweithwyr. Mae'r cynllun yn niwtral o ran cost ac yn galluogi'r Cyngor i hyrwyddo siwrneiau iachach i'r gwaith a lleihau llygredd amgylcheddol. Mae'r cynllun wedi bod yn rhedeg yn llwyddiannus ers pedair blynedd a, drwy ddarparwr a ddewiswyd gan y Cyngor - Cycle Solutions - yn ddiweddar mae wedi sefydlu partneriaeth gyda siopau lleol. Mae hyn yn caniatâu i siopau beiciau lleol gyflenwi beiciau'n uniongyrchol i'r gweithwyr, gan helpu i gadw'r £ ym Mhowys. O'r 54 o feiciau a brynwyd ym Mawrth - aeth 50% o'r gwerthiannau i werthwyr lleol.

Cymhellion Teithio Staff

Mae lwfans beicio o 20c y filltir wedi cael ei gyflwyno i annog pobl i wneud siwrneiau busnes byr ac effeithlon ar feic gan arbed costau teithio.

Mae rhaglen dreigl wedi gwella cyfleusterau parcio beiciau yn adeiladau'r Cyngor ar draws y sir ac mae gan y rhan fwyaf yn awr lefydd addas i storio beiciau, loceri personol ac, mewn rhai lleoliadau, gawodydd.

Datblygiadau newydd

Mae'n rhaid i bob datblygiad arfaethedig dros faint arbennig yn awr gynnwys Cynllun Teithio ar gyfer y Safle i fodloni gofynion Cynllunio a rhaid i'r Cynlluniau hyn hyrwyddo beicio a darparu cyfleusterau addas. Mae datblygiadau ysgolion newydd, fel y gwelwyd yn ddiweddar yn ardal Ystradgynlais, hefyd yn gorfol mabwysiadu Cynllun Teithio sy'n dangos ymrwymiad i gynyddu beicio ymmsg disgyblion a staff. 
Yn anffodus, nid yw'n bosib cyflenwi'r ffigurau hyn fel y gofynnwyd. Fodd bynnag, o ganlyniad i'r Bwrdd Gweithredu Gwella Rheoli Datblygu, mae'r gwasanaeth Rheoli Datblygu yn ddiweddar wedi gosod y meddalwedd Northgate ICT i gofnodi'r wybodaeth hon. Mae'r Dangosyddion Datblygu Cynaliadwy (SDI), a gyflwynwyd ym mis Rhagfyr 2013, yn galluogi'r wybodaeth hon i gael ei darparu yn y dyfodol.

Mae'r graff isod yn dangos nifer yr unedau Tai Fforddiadwy a gymeradwywyd o'i gymharu â chyfanswm yr unedau tai a gymeradwywyd ar gyfer pedwar mis diwethaf blwyddyn ariannol 13/14 (Rhagfyr-Mawrth) pan gymeradwywyd 14 o unedau fforddiadwy allan o 139.

Pan allwn ni ddod o hyd i dystiolaeth, er enghraifft cyfeiriad ar amlin, rydym yn ysgrifennu at y troseddwr honedig dan Adran 33 o Ddeddf Diogelu'r Amgylchedd 1990. Yn 2013/14, anfonwyd 60 o lythyrau o'r fath, ond ni wnaeth dim un arwain at erlyniad.

Mae'r adran lechyd yr Amgylchedd yn delio â digwyddiadau ar dir preifat ond yn yr un modd, nid ydynt wedi erlyn neb. Cyfoeth Naturiol Cymru sy'n delio â digwyddiadau mawr.

Mewn ateb i gwestiwn atodol y Cynghorydd Meredith ynghylch a oedd yn amser dechrau rhoi hysbysiadau cosb, dywedodd yr Arweinydd y byddai'n siarad â'r swyddogion ynghylch a oes angen diwygio'r polisi.

Ac ystyried y ffaith nad yw'r ddeddfwriaeth gyfredol yn atal rhieni rhag parhau i dynnu eu plant allan o'r ysgol yn ystod y tymor, beth mae'r Awdurdod yn ei wneud i ddelio â'r mater hwn gydag ESTYN a Llywodraeth Cymru?

Fel aelod o Gonsortiwm De-orllewin a Chanolbarth Cymru (ERW), mae'r rhanbarth yn datblygu strategaeth ar gyfer gwella presenoldeb. Mae hyn yn cynnwys polisi ar hysbysiadau cosb benodedig fydd yn cael ei ddosbarthu i ysgolion yn y rhanbarth yn Nhymor yr Hydref.

Croesawodd y Cyngorydd Meredith yr ymateb a gofynnodd i Benaethiaid gael eu cefnogi. Dywedodd y Deilydd Portffolio fod polisi ERW yn gadarn a bod angen herio teuluoedd a oedd yn mynd â'u plant allan o'r ysgol.

15.27 Cwestiwn i'r Deilydd Portffolio Adnoddau Dynol gan y Cyngorydd Sir Gareth Ratcliffe

A all y deilydd portffolio Adnoddau Dynol friffo'r cyngor ar y sefyllfa o safbwyt swyddi yng Nghyngor Sir Powys yn dilyn yr adroddiad gan BBC News dan y pennawd *Toriadau mawr i swyddi os bydd cyllidebau'n dal i grebachu, rhybuddia'r cyngor pan ddywedodd arweinydd Cymdeithas Llywodraeth Leol Cymru os ydyn ni'n wynebu gostyngiad ar y raddfa hon, y pwysau mwyaf ar gostau, yn anffodus, ydy gweithwyr.*

Mae'r cyngor wedi colli 215 o swyddi yn y gyllideb gyfredol ac mae newidiadau pellach ar y gweill. O ystyried y gofyn i arbed tua £70m erbyn diwedd y degawd, mae'n anochel y bydd y maint y gweithlu yn parhau i leihau. Fodd bynnag, rydym yn chwilio am arbedion eraill megis adolygu gwariant trydydd partïon er mwyn lleihau'r effaith ar wasanaethau rheng flaen a staff.

Gwrthododd y Deilydd Portffolio ateb cwestiwn atodol y Cyngorydd Ratcliffe ar drafodaethau gyda'r undebau llafur gan nad oedd yn credu ei bod yn briodol gwneud hynny mewn cyfarfod agored.
