The Chairman thanked members for their best wishes and the health services for their care following his recent accident. He extended an invitation to the Members' Sunday lunch which would be held at Maes Mawr on 15th February. The Chairman reported that £320 had been raised for his charities and the Army Benevolent Fund at the fireworks display at Derings Lines and £96 at the carol service. He noted the successful receptions held at the Winter Fair for Farm Diversification and Gold and Silver Kite winners. He thanked County Councillor Joy Jones for accompanying him around her ward and said he would welcome the opportunity to visit other Members'

wards and to visit residents celebrating 100th birthdays or 60th wedding anniversaries.

The Chairman referred to the death of Mr Darren Davies, headteacher of Llanidloes High School. County Councillor Gareth Morgan paid tribute to Mr Davies.

The Chief Executive noted that the Council had saved £40m in the last 3 years but there was more to be done. He referred to the Wales GB Rally and the Winter Fair both of which had been good promotion for the county. He advised Council that the Welsh Government was expected to issue a white paper on 3rd February in response to the recommendations of the Williams Commission. As far as Powys was concerned, work continued on integration with Powys teaching Health Board. He advised that in principle approval had been received from Welsh Government for a primary school review in the Gwernyfed catchment area which represented a £24m investment in the area. He had been pleased to attend the turf cutting ceremony for the new Ysgol Dafydd Llwyd in Newtown and acknowledged the work of campaigners for Welsh language education in the county. Finally, he and Members of the Council congratulated County Councillor John Morris and his wife Margaret on the award of a Royal Warrant from H.R.H. The Prince of Wales for their Welsh farmhouse apple juice.

13.1 Area (Shire) Committees

The recommendation of the Democratic Services Committee in relation to Shire Committees was that all Area (Shire) Committees move to bi-monthly meetings, with the ability to call additional meetings in the case of emergencies.

County Councillor Wynne Jones moved an amendment, duly seconded, adding the words “to be reviewed in 2 years prior to the end of this Council” to the end of the recommendation. Members debated the issue with some arguing that the Shire Committees did not provide value for money and others that they provided a useful forum in which to discuss matters of local concern. Further amendments calling for a root and branch review of whether Shire Committees were value for money, and a composite amendment calling for bi-monthly Shire meetings, a report on their value for money to be completed within 3 months and for attendance at Shire Committees to no longer count towards the figures monitored by the Standards Committee were withdrawn.

The recommendation of the Democratic Services Committee was that the arrangements for rotating the Chair of Council between the Shires remain as currently until clarification is received regarding the future arrangements for Local Government in Wales.

Members debated an amendment moved by County Councillor Wynne Jones, duly seconded, that the Chair of Council rotate on a 2, 2, 1 rotation to take effect from May 2015 to take account of the larger number of Councillors in Montgomeryshire and Brecknockshire. One member felt that it would be insulting to the people of Radnorshire to be treated differently from the other Shires, other members felt that the Chair of Council should be elected by the whole Council regardless of which Shires they were from. The amendment was lost upon being put to the vote.

18.1 Question to the Portfolio Holder for Adult Social Care from County Councillor Gwilym Williams

The background to my question is regarding adult and social care, when a consultant drew up contracts and awarded them to four national large providers for people's care in their homes.

It came to my attention when these contracts were being awarded I was told that the consultant after he had finished his contracts and left Powys, he was going to work for one of these providers.

At the beginning of 2014 when I was Chairman of the Radnorshire Committee when the portfolio holder Darren Mayor attended, I asked the above question was the consultant going to work for one of these providers. They assured me and promised that this was not going to happen. It then came to light, confirmed by Darren Mayor, that the consultant was now working for one of these companies, therefore, is it ethical for this to happen?

I now understand there is to be an independent inquiry into how these contracts were awarded, and obviously we must wait the decision, but

any inquiry will look at what has happened in the past, I would like to look to the future.

My question would be to the portfolio holder in light of the above can all consultants that award contracts for Powys County Council, and then leave the authority, be not allowed to work for these companies for at least one year after the contract was awarded?

The Solicitor to the Council has been asked to look into the legal issues involved in attempting to impose such a “restraint of trade” clause into our consultancy contracts. I am advised that his enquiries are continuing but it is clear that it is unusual for such clauses to be imposed, perhaps because such a clause could be used by the consultant to suggest that they are employees rather than consultants. Consideration will also need to be given as to the issue of enforceability against the individual consultant, rather than against the company that the Council contract with. For tax purpose, most (if not all) of the consultants we engage, set themselves up as Limited Companies for trading purposes and the consultancy contract is with the company, rather than with an individual. In such an arrangement, the restraint of trade clause (if enforceable at all) would only be enforceable against the company and not against the individual. There is a risk that the individual consultant could attempt to circumvent the effect of such a clause by setting up a second company in a different name and using that second company to undertake work for our appointed Contractors.

In answer to Councillor Williams' supplementary question, the Portfolio Holder confirmed that the contractor had given a verbal guarantee as he reported to Radnorshire and the Solicitor to the Council advised that the legal issues raised were being looked at but that as had been indicated in the response there were drawbacks to putting “restraint of trade” clauses into consultancy contracts.

18.2 Question to the Portfolio Holder for Highways from County Councillor David Jones

Following complaints to NRW of the fly tipping of contaminated waste by Highways at three sites in Gwilsfield they partially cleared the offending material before resuming dumping. Why did Highways resume fly tipping and has this gone on in other parts of Powys?

The leaf litter deposited at the end of the highway known as Laundry Lane, Gwilsfield; which was the initial subject of complaints, was cleared during the week ending 14th December 2014. There has been no further material deposited at this location to date.

There are a number of other locations where our rural highways pass through NRW woodlands, and similarly to Laundry Lane the NRW (Forestry Management Section) have requested that the leaf-litter from these highways

within their woodlands be deposited at locations at the sites for their collection and re-use in regenerating the soil within areas of their woodland.

The material previously removed was clearly unsuitable; being in such a wet state, and operatives are aware that this is not acceptable.

In light of the complaints now received, and the fact that we have again received requests from the NRW for the leaf-litter material, we have requested further written confirmation and clarification of their position.

In response to Councillor Jones' supplementary question about how waste that had run onto neighbouring land would be recovered, the Portfolio Holder said that he had understood that all of the waste had been removed but that he would check this again. He also undertook to forward NRW's response to all Members when it was received.

18.3 Question to the Portfolio Holder for Waste Management from County Councillor David Jones

Has the council reported to WAG that they have been diverting contaminated material out of the waste stream by fly tipping and thus “improving” the percentage of waste re-cycled?

On completion of the trial in which Powys County Council participated in conjunction with NRW/WG, we notified NRW of our intent to ‘return all leaf litter arising to the highway verge on site’.

The material previously taken to the farm trial sites was included in the data submitted to WG and because it was being recycled at that time the material did contribute to our recycling figures.

The end of the trial meant a reduction in our recycling total of approximately 5.5%.

In answer to Councillor Jones' supplementary question about current recycling rates, the Portfolio Holder advised that the rate was 53.4%.

18.4 Question to the Portfolio Holder for Education from County Councillor Paul Ashton

In view of the introduction of the Education Improvement Grant how will the portfolio holder ensure that the transient Ministry of Defence pupils in Powys schools who require EAL will continue to receive the support they need in order to maintain standards?

It is a concern that the Welsh Government have decided to cease the Minority Ethnic Achievement Grant which has been used for many years to support learners across Powys and Wales who require support to develop their

competency in the English/Welsh language. Welsh Government are ceasing fourteen grants to create a new grant, namely the Education Improvement Grant. This new grant is a regional grant, the details of which have not as yet been provided by Welsh Government. As soon as details are available I shall be in a position to provide further information.

There was no supplementary question but Councillor Ashton did ask to be kept informed.

Gofynnwyd i gyfreithiwr y Cyngor edrych i mewn i'r materion cyfreithiol sy'n ymwneud â cheisio gosod cymal "cyfyngu ar fasnach" o'r fath o fewn ein contractau ymgynghoriaeth. Dywedir wrthyf fod ei ymholiadau yn parhau ond mae'n eglur ei bod yn anghyffredin i gymalau o'r fath gael eu gosod, efallai oherwydd y gellid defnyddio cymal o'r fath gan yr ymgynghorydd i awgrymu eu bod yn weithwyr yn hytrach nag yn ymgynghorwyr. Bydd angen rhoi ystyriaeth hefyd i sut y gellir gorfodi hyn yn erbyn yr ymgynghorydd unigol, yn hytrach nag yn erbyn y cwmni y mae'r Cyngor yn contractio ag ef. I ddibenion treth, mae'r rhan fwyaf o'r ymgynghorwyr yr ydym ni yn eu defnyddio (os nad pob un ohonynt) yn sefydlu eu hunain fel Cwmnïau Cyfyngedig i ddibenion masnachu ac mae'r contract ymgynghoriaeth gyda'r cwmni, yn hytrach na gydag unigolyn. Mewn trefniant o'r fath, byddai'r cymal cyfyngu ar fasnach (os gellid ei orfodi o gwbl) yn un y gellid ei orfodi yn erbyn y cwmni yn unig ac nid yn erbyn yr unigolyn. Mae yna berygl y gallai'r ymgynghorydd unigol geisio trechu effaith cymal o'r fath drwy sefydlu ail gwmni mewn enw gwahanol a defnyddio'r ail gwmni hwnnw i wneud gwaith ar gyfer y Contractwyr y byddem wedi eu penodi.

Mewn ateb i gwestiwn atodol y Cynghorydd Williams, cadarnhaodd yr Aelod Portffolio fod y contractwr wedi rhoi sicrwydd ar lafar fel yr adroddodd i bwylgor Sir Faesyfed. Cynghorodd Cyfreithiwr y Cyngor fod y materion cyfreithiol a godwyd yn cael eu hystyried, ond fel y nodwyd yn yr ymateb roedd anfanteision mewn rhoi cymalau "cyfyngu masnach" mewn contractau ymgynghoriaeth.

18.2 Cwestiwn i'r Aelod Portffolio dros Briffyrrd gan y Cynghorydd Sir David Jones

Yn dilyn cwynion i Gyfoeth Naturiol Cymru am dipio gwastraff wedi'i lygru'n anghyfreithlon gan yr adran Priffyrrd mewn tri safle yng Nghegidfa fe wnaethant glirio'r deunydd yn rhannol cyn ailddechrau gollwng y gwastraff. Pam y gwnaeth yr adran Priffyrrd ailddechrau tipio anghyfreithlon ac a yw hyn wedi digwydd mewn rhannau eraill o Bowys?

Cafodd y sbwriel dail a ollyngwyd ym mhen draw'r briffordd a elwir yn Laundry Lane, Cegidfa; sef testun y cwynion i ddechrau, ei glirio yn ystod yr wythnos yn diweddu 14 Rhagfyr, 2014. Ni chafodd ddeunydd arall ei ollwng yn y lleoliad hwn hyd yma.

Mae nifer o leoliadau eraill lle mae ein priffyrdd gwledig yn mynd drwy goetiroedd Cyfoeth Naturiol Cymru, ac yn yr un modd â Laundry Lane mae Cyfoeth Naturiol Cymru (yr Adran Rheoli Coedwigaeth) wedi gofyn am i'r sbwriel dail o'r priffyrdd hyn o fewn eu coetiroedd gael ei ollwng mewn lleoliadau yn y safleoedd ar gyfer eu casglu a'u hail-ddefnyddio wrth adfywio'r pridd o fewn ardaloedd o'u coetir.

Roedd y deunydd a gafodd ei symud yn flaenorol yn amlwg yn anaddas; oherwydd ei fod mewn cyflwr mor wlyb, ac mae gweithredwyr yn ymwybodol nad yw hyn yn dderbyniol.

Yn wyneb y cwynion a dderbyniwyd yn awr, a'r ffaith ein bod unwaith eto wedi derbyn ceisiadau gan Gyfoeth Naturiol Cymru ynghylch y sbwriel dail, rydym wedi gofyn am gadarnhad ysgrifenedig pellach ac am esboniad am eu sefyllfa.

Mewn ymateb i gwestiwn atodol y Cynghorydd Jones ynghylch sut y byddai gwastraff a oedd wedi rhedeg ar dir cyfagos yn cael ei adenill, dywedodd yr Aelod Portffolio ei fod wedi deall bod yr holl wastraff wedi cael ei symud, ond y byddai'n gwirio hyn eto. Addawodd hefyd anfon ymateb Cyfoeth Naturiol Cymru at yr holl Aelodau ar ôl iddo ei dderbyn.

Cwestiwn i'r Aelod Portffolio dros Reoli Gwastraff gan y Cynghorydd Sir David Jones

A yw'r cyngor wedi adrodd wrth Lywodraeth Cynulliad Cymru eu bod wedi bod yn dargyfeirio deunydd halogedig allan o'r ffrwd gwastraff drwy dipio anghyfreithlon, a thrwy hynny "wella" canran y gwastraff sy'n cael ei ail-gylchu?

Ar ôl cwblhau'r treial y bu Cyngor Sir Powys yn cymryd rhan ynddo ar y cyd â Chyfoeth Naturiol Cymru / LIC, fe wnaethom hysbysu Cyfoeth Naturiol Cymru am ein bwriad i 'ddychwelyd yr holl sbwriel dail sy'n ymddangos i ymyl y briffordd ar y safle'.

Cafodd y deunydd a gymerwyd o'r blaen i'r safleoedd treialu ar ffermydd ei gynnwys yn y data a gyflwynwyd i Lywodraeth Cymru ac oherwydd ei fod yn cael ei ailgylchu ar y pryd fe wnaeth y deunydd gyfrannu at ein ffigyrâu ailgylchu.

Roedd diwedd y treial yn golygu gostyngiad yn ein cyfanswm ailgylchu o oddeutu 5.5%.

Mewn ateb i gwestiwn atodol y Cyngorydd Jones am gyfraddau ailgylchu ar hyn o bryd, dywedodd yr Aelod Portffolio mai'r gyfradd oedd 53.4%.

18.4 Cwestiwn i'r Aelod Portffolio dros Addysg gan y Cyngorydd Sir Paul Ashton

O ystyried cyflwyno'r Grant Gwella Addysg sut y bydd yr aelod portffolio yn sicrhau y bydd disgylion dros dro'r Weinyddiaeth Amddiffyn yn ysgolion Powys sydd angen SIY (EAL) yn parhau i dderbyn y gefnogaeth angenrheidiol er mwyn cynnal safonau?

Mae'n bryder bod Llywodraeth Cymru wedi penderfynu rhoi'r gorau i'r Grant Cyrhaeddiad Lleiafrifoedd Ethnig sydd wedi cael ei ddefnyddio am flynyddoedd lawer i gefnogi dysgwyr ar draws Powys a Chymru sydd angen cymorth i ddatblygu eu cymhwysedd yn y Saesneg /y Gymraeg. Mae Llywodraeth Cymru yn dirwyn pedwar ar ddeg o grantiau i ben i greu grant newydd, sef y Grant Gwella Addysg. Mae'r grant newydd yn grant rhanbarthol, ac nid yw Llywodraeth Cymru wedi rhoi manylion amdanu eto. Cyn gynted ag y bydd manylion ar gael byddaf mewn sefyllfa i roi gwybodaeth bellach.

Nid oedd unrhyw gwestiwn atodol, ond gofynnodd y Cyngorydd Ashton am gael ei hysbysu am unrhyw ddatblygiadau.
