Scrutiny Observations to the Public Service Board meeting to be held on: 30th July 2021.

The Public Service Board Scrutiny Committee met on 04-05-2021 and considered the following documents:

- Well-Being Step 4 – Digital Infrastructure
- Well-Being Highlight Reports – Quarter 4 2020-21

The Scrutiny Committee made the following observations to the Public Service Board:

Step 2.

- The Committee suggested that all Steps should be using the reporting framework as developed by BBNPA as having different formats made it difficult to follow.
- The Committee expressed concern regarding the quality and lack of information in some of the performance reports.
- The Committee suggested that there was a need for more clear performance measures against which the Steps are monitoring progress.

Step 4.

- The Committee expressed concern regarding the lack of a Welsh Government representative on the Digital Businesses group.

Step 3.

- The Committee commented that there was no reference included under this step in relation to Safe Routes to Schools.

Step 7.

- The Committee expressed its disappointment with the lack of progress with Step 7 and asked the PSB to review this as a matter of urgency to speed up the process and so that some tangible projects could be commenced.

All Steps.

- The Committee commented that there was an inconsistency in steps in that some included detail of how that step linked with the other steps, where in others it was not included.
