SUBJECT: Council Tax Resolution for 2023-2024

REPORT FOR: Decision

1.0 PURPOSE

1.1 The purpose of this report is to meet the Council's legal obligation to approve the Council Tax resolution and to set the Council Tax charges for 2023/2024.

2.0 BACKGROUND

2.1 The budget for 2023/24 was agreed at Council on 23 February 2023 and an increase of 5% in Council Tax for the financial year 2023-24 was approved by Council as part of the budget.

2.2 At a meeting of the Cabinet on the 22 November 2022, the Council calculated the following Tax Base amounts for the year 2023/24 in accordance with Regulations made under Section 33 (5) of the Local Government Finance Act, 1992.

(a) Being the amount calculated by the Council, in accordance with the Local Authorities (Calculation of Council Tax Base) (Wales) Regulations 1995, as amended, as its Council Tax Base for the year 2023/2024.

4.0 Resource Implications

- 4.1 The figures contained within the report have been calculated in accordance with the draft Settlement from Welsh Government and updates confirming the final settlement and the Council Tax rate approved by Council and included in the budget decision of 23 February 2023.
- 4.2 Upon the resolution being adopted the annual billing process will commence to ensure households receive their 2023/24 annual demand in a timely manner, adequate workforce numbers are in place to undertake this task and to administer the billing, collection and recovery of Council Tax throughout 2023/24.
- 4.3 There are no known ICT, customer services or physical implications. Front line services have been made fully aware of the charges for the financial year 2023/24.
- 4.4 Communications commented: The report is of public and service user interest and requires use of proactive news release and appropriate social media activity to publicise the decision. A statutory notice will also be placed in local newspapers circulating in the county.
- 4.5 The Head of Financial Services (Section 151 Officer) supports the recommendation. This report is required by legislation to ensure the Council sets Council Tax rates for the forthcoming year so that it can collect income to fund services. It is important that Members note this is in effect a ‘technical’ report required by legislation and does not reopen the budget process.

5.0 Legal Implications Options Considered/Available

- 5.1 Legal commented: “the proposals satisfy the duty on the Council to set a Council Tax level for the forthcoming financial year”.
- 5.2 The Head of Legal and Monitoring Officer commented “The recommendation satisfy the requirement of the Council to set the Council Tax in accordance with Section 30(6) of the Local Government Finance Act 1992”.

6.0 Data Protection

- 6.1 No data protection implications within the proposal.

7.0 Local Members(s)

- 7.1 The Head of Legal and Monitoring Officer is not aware of any specific interests that may arise in relation to this report. If Members have an interest, they should declare it at the start of the meeting and complete

the relevant notification form.

8.0 Integrated Impact Assessment

- 8.1 An integrated impact assessment was undertaken as part of the budget setting process which incorporated the Council Tax increase agreed by Council within the budget set.

9.0 Recommendation

- 9.1 THAT the amounts contained in paragraph 3.1 above be accepted by the Council for the year 2023/2024 in accordance with Sections 32 to 36 of the Local Government Finance Act, 1992
- 9.2 THAT, the Council in accordance with Section 30 (2) of the Local Government Finance Act, 1992, hereby sets the amounts contained in paragraph 3.3 as the amounts of Council Tax for the year 2023/2024 for each of the categories of dwellings shown.

Report Title: Proposal for Revisions to the Scrutiny Committee Structure and Numbers of Seats on Committees

Report For: Decision

1. Purpose

- 1.1 The report asks Council to consider a recommendation from the Democratic Services Committee to reduce the numbers of seats on some of the Council's Committees with effect from the Annual General Meeting in May 2023 and to revise the Scrutiny Committee structure and. These matters were considered by the Democratic Services Committee on 17th February, 2023 and its recommendations are set out below.

2. Background

- 2.1 There are a number of reasons which led to the need to review the current Scrutiny Committee structure as well as the numbers of seats on committees including:
- Following the elections Political Group Leaders asked officers to review the numbers of seats on committees following the reduction in numbers of Members in May 2022 from 73 to 68 (-6.85%)
 - Smaller political group numbers meaning groups are having difficulty filling seats on committees.
 - More Members having other employment limiting their ability to sit on multiple committees.
 - A need to review the remits of Scrutiny Committees following the development of the new Corporate Improvement Plan
 - An acceptance that the remit of the current Economy, Residents and Communities Scrutiny Committee is too wide
 - A need to review the composition of the Public Service Board Scrutiny Committee as the model being currently used is not delivering the challenge expected to the Public Service Board.
 - A review of the numbers of seats on Planning Committee across authorities in Wales was undertaken and this indicated that the Powys Planning Committee is only one of three in Wales with 21 Members with the majority of Councils having 17 seats or less on their planning committees. **(See Appendix 1)**
- 2.2 The numbers of current vacancies on the Committees affected by the proposals below are listed at **Appendix 3**. The numbers of seats taken by non-affiliated Members is listed at **Appendix 4**.

4.3 The Number of Councillors on Scrutiny Committees

4.3.1– The Democratic Services Committee considered the possible reduction in the number of seats on all three scrutiny committees from 14 currently (plus the addition of co-opted members where required) to either :

- A Committee of 12 (formula 11 +1 additional seat) **(See Appendix 2)**
Political balance - Independents (1); Conservatives (2); Liberal Democrats (4); Labour (2); Plaid Cymru (1); Independents for Powys (1). Additional seat allocated to Conservatives (1)
- A Committee of 11 (formula 8+3 additional seats) **(See Appendix 2)**
Political balance - Independents (1); Conservatives (2); Liberal Democrats (3); Labour (1); Plaid Cymru (0); Independents for Powys (1). Additional seats allocated to Plaid Cymru (1), Labour (1) and Independents (1).

The reference to “additional seats” in the above is a reference to the formula which must be used to ensure that scrutiny committees are politically balanced according to the current make up of political groups within the Council. By way of example, members will see from Appendix 2 that the application of the Formula for a committee of 12, results in 11 seats being allocated to political groups with the 12th seat (“the additional seat”) being allocated to the next nearest group, namely the Conservative Group.

4.3.2 The recommendation from the Democratic Services Committee is that the numbers of seats on all three scrutiny committees should be reduced to 11 Members, plus the addition of co-opted Members where required)

4.5 Planning, Taxi Licensing & Rights of Way Committee: (21)

4.5.1 The current Committee has 21 members which represents approximately 31% of the total membership of the Council and has 2 vacancies. Democratic Services Committee considered the number of Councillors on other Planning Committees throughout Wales (see Appendix 1) and recommended that the number of seats on the Planning Committee should be reduced to 17. This would equate to the Committee being 25% of the membership of the Council.

5. Revised Scrutiny Structure

5.1 The current scrutiny structure is as follows:

- Economy, Residents and Communities Scrutiny Committee
- Health and Care Scrutiny Committee
- Learning and Skills Scrutiny Committee
- PSB Scrutiny Committee (comprising external partners)
- Finance Panel

5.2 At present the Learning and Skills Committee focuses on Education, Health and Care focuses on Adult Social Care and Children’s Services and the Economy, Residents and Communities Committee focuses on the rest of the Council; Housing, Highways, Transport and Recycling, Planning, Public Protection and Property, Community Services, Economy and Digital Services, Transformation and Democratic Services, Workforce and Organisational Development, Legal Services, and Financial Services.

The remit of the Economy, Residents and Communities Committee is too broad, and it is suggested that the committee structures are reviewed to spread the remit more evenly.

5.3 The Chairs of the Economy, Residents, and Communities Scrutiny Committee and the Learning and Skills Scrutiny Committee are supportive of the proposed changes set out in the table below.

However, The Chair of the Health and Care Scrutiny has expressed of the following reservations. It is regretted that the Chair’s reservations were not fully provided to the Democratic Services Committee;

- “I can see the reason behind wanting to align committees to directors in terms of capacity and them not having to attend two lots of scrutiny meetings. I can also appreciate that there are strategic crossovers between Children & Education and Adults and Housing which have sat behind the new SMT structure. However, I

already do not expect directors to attend the parts of scrutiny meetings which are not relevant to their service areas and there are just as many if not more cross over areas between Children's and Adult's Service (e.g. budget and officer in charge of this (Jackie), transition from children's to adults, Complaints data, CHC, North Powys Wellbeing Hwb etc).

- Due to the above, there would need to be a clear structure in place for combined working with two scrutiny committees for these crossover areas. This cannot result in more meetings being put in the diary due to capacity issues of officers, members and portfolio holders which already exist. I can envisage difficulties here with practicalities and chair autonomy/oversight of work programming (something which has been criticised in previous audit/inspections).
- I am also concerned about how each committee will have the capacity to do worthwhile deep dives, particularly for the Education /Children's committee. This was a previous structure pre 2018 and the committee was primarily only able to focus on looking at each service area under considerable pressure at any one time – in one sense this became fire fighting. Where there are huge transformation projects planned (e.g. schools/sixth form etc, this will take up the majority of programmed meetings and the other service will be left without as much scrutiny. Under this previous structure, I felt that members had limited understanding of services in detail and this restricted the difference scrutiny made. Much of meetings was spent explaining things to members rather than members asking probing questions of officers and portfolio holders. I recall this previous structure was criticised during a review or audit and in the 2017 Children's inspection report it was noted that members had not adequately challenged children's services.
- Members of the H&SC Committee have spent many hours getting up to speed with Member Development sessions provided in both service areas and also on each service's budget. The value of this has been really good and I would not want this to be lost. A new committee structure could not just hit the ground running for a new service area coming under their remit; appropriate training would need to be given.
- In terms of my personal interest, I put my name forward to chair an area which I felt I had a good knowledge of already (due to my professional background and experience to date as a councillor). I would be disappointed to lose Children's services from my committee. I do think it is important to get the right people in the right place aligned to their strengths and experiences.
- In terms of the overall Budget breakdown % of each service area, the three committees are fair.
- I realise that there are a lot of varying topics sitting under Angela's committee and so there are many heads of services and directors. However, I feel scrutiny work programming should be informed by performance data, service pressures and transformation projects, rather than trying to look at each service area in turn. One restriction for that committee is there is not the same type of monthly performance data systems in place for Highways and Waste as there is for other services. Perhaps if this was developed (and I have put public questions in on this previously and briefly spoken to Emma P about it), then there would be clearer indicators for where scrutiny is needed and this would help inform and streamline work programming.
- In conclusion given the above points, I would not like to see a new structure split Adults and Children's services and feel they should be kept in one committee for the duration of this council term."

As is the case currently, where there are issues which are cross cutting or span the remits of two or more scrutiny committees, joint working between those scrutiny committees can be facilitated using joint working groups.

Note – For Information only:

In April 2023 the current Community Health Council is to be replaced by the Citizen Voice Body for health and social care. The following is an extract from a Welsh Government consultation document Foreword by the Minister for Health and Social Services:

“From April 2023, the Citizen Voice Body for health and social care will be in place, to independently represent the interests of the public in relation to health and social care. Amongst its roles will be to actively seek and listen to the views of service users, carers and wider public and to make representations to NHS bodies and local authorities about the provision of health or social services, helping ensure people’s experiences drive continuous improvement in local, regional and national plans and policy.”

Discussions are ongoing between Council officers and the Citizen Voice Body to understand the implications and interactions between the Council's Scrutiny Committees dealing with social care and the new body as it could have implications for the membership of the scrutiny committees (possible requirements for co-option) as well as the remits of those committees. As the position is clarified further information will be made available to Members.

A review of PSB Committees in Wales has been undertaken and it showed that PSB in all Councils except Powys was comprised of councillors only. Powys had followed an earlier model used by Cardiff Council which had representatives of the bodies comprising the PSB

on the scrutiny committee. That situation has changed. The only similar structure to Powys is with Bridgend who have a panel which reports to a PSB Committee comprising of Councillors.

5.4.2 The non Powys County Council organisations that currently appoint representatives to the PSB scrutiny Committee have all been consulted with regard to the proposed changes and non have provided any comment.

6. Review of Senior Salaries

with other scrutiny Chairs. There is currently one Senior Salary in the Members Scheme of Remuneration which is unallocated. The additional cost would be £8800 (Chairs allowance £26400 – basic allowance £17600 from April 2023)

6.3 **Chair of the Employment Committee**

The terms of reference of the Employment Committee has been amended during 2022 with the Committee having no further involvement in officer appeals. As the Chair’s post is currently paid a Senior Salary , Council is asked to consider a recommendation from the Democratic Services Committee that Chair of the Employment Committee should continue to a Senior Salary. If the Senior Salary were not paid this would be a saving of £8800 per annum (Chairs allowance £26400 – basic allowance £17600 from April 2023)
