**1. Purpose**

- 1.1 Powys County Council (“the authority”) has proposed to close Banw Community Primary School and Llanerfyl Church in Wales Foundation School from August 2020, and establish a new Church in Wales Aided School with effect from September 2020.

**2. Background**

- 2.1 The name of the new school has been discussed by the pupils and staff of Banw Community Primary School and Llanerfyl Church in Wales Foundation School.

The communities were also part of the consultation process through the School Transformation Newsletter.

Following a discussion at the temporary governing body meeting on the 11<sup>th</sup> March 2020 it was agreed to propose Ysgol Cwm Banwy as the name of the new school.

A further discussion was held at the temporary governing body meeting held on the 18<sup>th</sup> June 2020 and it was proposed to amend the school name to Ysgol Cwm Banwy, Ysgol yr Eglwys yng Nghymru.

**3. Advice**

- 3.1 It is proposed that the new school to open in September 2020 to replace Banw Community Primary School and Llanerfyl Church in Wales Foundation School be named as Ysgol Cwm Banwy, Ysgol yr Eglwys yng Nghymru.
