REPORT TITLE: Instrument of Government – Llanbister CP School

REPORT FOR: Decision

1. Purpose

- 1.1 To consider the Instrument of Government following a decision by the governing body of Llanbister CP School on the 3rd December 2020 to adopt an amended Instrument of Government.
- 1.2 The report contains a recommendation to ratify an amended Instrument of Government for Llanbister CP School.
- 1.3 The report is supported by the revised Instrument of Government, appendix A.

2. Background

- 2.1 The Government of Maintained Schools (Wales) Regulations 2005 required all school governing bodies to review and adopt revised Instrument of Government (Instruments of Government are the legal documents that detail the composition of a school governing body). The Authority approved all revised Instrument of Government with effect from 3rd October 2006.

Llanbister CP School opted for the composition as outlined below: -

- 3 parent governors
- 2 LA governors
- 1 teacher governor
- 0 staff governor
- 2 community governors
- 1 additional community governor
- The headteacher

The amended Instrument of Government would be

3 parent governors
2 LA governors
1 teacher governor
1 staff governor
2 community governors
1 additional community governor
The headteacher

The Instrument of Government would increase by 1 staff governor.

2.2 The governing body of Llanbister CP School have recommended the increase in their Instrument of Government to strengthen the representation from the non-teaching staff at the school.

3. Advice

3.1 It is proposed that the governing body of Llanbister CP School increase its composition from 10 governors to 11 governors.

4. Resource Implications

4.1. There are no resource implications in approving the recommendation.

Instrument of Government for Llanbister C.P. School



1. SCHOOL

The name of the school is Llanbister C.P. School.

2. CATEGORY OF SCHOOL

The school is a community school.

3. NAME OF GOVERNING BODY

The name of the Governing Body is Llanbister C.P. School Governing Body.

4. COMPOSITION OF GOVERNING BODY

The governing body shall consist of:

- a) 3 parent governors
- b) 2 LA governors
- c) 1 teacher governor
- d) 1 staff governor
- e) 2 community governors
- f) 1 additional community governor - *appointed by Llanbister Community Council.*
- g) the headteacher (except at any time when he/she has given written notice to the clerk to the governing body of the school that he/she chooses not to be a governor).

5. TOTAL NUMBER

10 (except any time when the headteacher has given notice that he/she chooses not to be a governor, when the total number of governors will be 9).

6. DATE OF IMPLEMENTATION

Pursuant to regulation 37 of the Government of Maintained Schools (Wales) Regulations 2005, this instrument of government comes into effect:

- (i) on the date of making for the purpose of reconstituting the governing body;
- (ii) on 3rd October, 2006 for all other purposes.

7. DATE OF ORDER

This instrument was made by order of Powys Local Authority on 3rd October, 2006.
