Response by the Portfolio Holder:

As requested, please find attached a copy of the Eluned Morgan AS/MS, response to the Councils correspondence dated the 26th October 2021.

Strategic Property have written to all service areas requesting that defibrillators are registered on 'The Circuit' (The National Defibrillator Network). This request is in line with Welsh Government guidance regarding registration. The list of registered defibrillators can be accessed using this <u>link</u>. Once this process is complete, gap analysis will be undertaken to inform potential investment decisions going forward.

Work is ongoing to improve the accessibility of defibrillators under the control of Powys County Council. Strategic Property are currently looking into the possibility of relocating existing defibrillators installed within corporate offices to external locations to increase accessibility outside of specified office opening hours. Funding for this improvement will be secured from existing building revenue budgets.

Dear Councillor Thomas,

Thank you for your email of 26 October asking for support to extend the availability of publicly accessible Automated External Defibrillators throughout Wales and to promote their use and training within the education system.

I recognise how effective defibrillators can be and the impact they can make in terms of survival in the event of a cardiac arrest.

Early Cardiopulmonary Resuscitation (CPR) and prompt use of a defibrillator can increase a person's chance of surviving a cardiac arrest. The Welsh Government wants to see good coverage of defibrillators across the country, as well as more people who feel confident to use them and to undertake CPR. To achieve this, the Welsh Government published our Out of Hospital Cardiac Arrest Plan and formed the Save a Life Cymru Partnership. We have provided funding to the Save a Life Cymru campaign, which is working with organisations across Wales to raise awareness of the importance of CPR training and the use of defibrillators through the 'Touch Someone's Life' campaign. Part of this work concerns the current and future management of defibrillators; as currently defibrillators are purchased by a range of organisations, including charities and community groups.

You may be aware of the recent update I provided to Senedd members on the progress implementing the Out of Hospital Cardiac arrest plan and also the work of Save a Life Cymru, which can be found at: https://gov.wales/written-statement-update-progress-implementing-out-hospital-cardiac-arrest-plan.

Communities and organisations which already have defibrillators are being encouraged to register them on The Circuit – more than 5,420 are registered. Just under 50 per cent of these defibrillators are registered with guardians who make sure they are ready for use with regular checks on batteries and pads. We recognise there are still a significant number of defibrillators within communities which are not currently registered and which do not have guardians and would encourage your council to work with Save a Life Cymru and the Welsh Ambulance Service to ensure that all the defibrillators within your council area are both

I am grateful for the Council's support in taking forward this life saving initiative.
