#### **Details of Virement**

The scheme consists of the resurfacing of Penybont Highways Depot due to its current poor condition which is causing health and safety issues. The depot is proposed to be retained for the longer term and it is essential these works are carried out.

It is proposed that the work is carried out in two phases with the first phase being carried out in the 22/23 financial year and the second phase in 23/24.

There is some surplus budget in the Llandrindod Wells Lake scheme, which was a risk amount, for at the time of requesting budget the works required had not been established or agreed with the regulators regarding their 'notice'. Subsequently, designs have been accepted by regulators and tenders received significantly less than original estimated. The works have now been completed.

It is proposed the surplus Lake scheme budget is vired to Phase 1 of the Penybont depot scheme with Phase 2 funded from the small scheme capital budget in 23/24.
