**1. Purpose**

- 1.1 In accordance with Regulation 35 of the Government of Maintained Schools (Wales) Regulation 2005 the governing body of Treowen CP School have reviewed their Instrument of Government at a governing body meeting held on the 28<sup>th</sup> September 2023. The governing body therefore proposed to adopt an amended Instrument of Government. Treowen CP School is a school with 96 pupils on role.

The current composition of the Instrument of Government is as outlined below: -

5 parent governors  
 4 LA governors  
 2 teacher governors  
 1 staff governor  
 4 community governors  
 1 additional community governor  
 The headteacher

The amended composition of the Instrument of Government would be

4 parent governors  
 3 LA governors  
 1 teacher governor  
 1 staff governor  
 3 community governors  
 1 additional community governor  
 The headteacher

The Instrument of Government would decrease by 1 parent, 1 LA, 1 teacher and 1 community governor.

- 1.2 The report contains a recommendation to ratify an amended Instrument of Government for Treowen CP School.

## 1. SCHOOL

The name of the school is Treowen C.P. School.

## 2. CATEGORY OF SCHOOL

The school is a community school.

## 3. NAME OF GOVERNING BODY

The name of the Governing Body is Treowen C.P. School  
Governing Body.

## 4. COMPOSITION OF GOVERNING BODY

The governing body shall consist of:

- a) 4 parent governors
- b) 3 LA governors
- c) 1 teacher governors
- d) 1 staff governor
- e) 3 community governors
- f) 1 additional community governor - *appointed by Newtown and Llanllwchaearn Town Council*
- g) the headteacher (except at any time when he/she has given written notice to the clerk to the governing body of the school that he/she chooses not to be a governor).

## 5. TOTAL NUMBER

18 (except any time when the headteacher has given notice that he/she chooses not to be a governor, when the total number of governors will be 17).

## 6. DATE OF IMPLEMENTATION

Pursuant to regulation 37 of the Government of Maintained Schools (Wales) Regulations 2005, this instrument of government comes into effect:

- (i) on the date of making for the purpose of reconstituting the governing body.
