During the past year I have been involved in:

- Work with officers to complete flood defence for Kerry Village was completed in October 2015.
- Continuing to work closely with Community Police Officers and PSOs.
- Working with County Farm Officers towards providing a small quantity affordable housing/plots in Sarn and planning permission applied for.
- Regular attendance at Kerry Community Council meetings, although not a member of the Council I provided advice as needed.

- Liaising with Planning Officers and applicants and speaking to committee when appropriate.
- Writing regular articles for Kerry News, particularly dog fouling, litter and fly-tipping.
- Consultation with Wyro Developments regarding Dolforgan/Penarron Site.
- Working with the Sarn Acorn Group in obtaining funding and supporting the change of use via planning to establish a Play Area for the children of Sarn.
