Section 2: Constituency activity

Llanbadarn Fynydd: continual positive working relationship with Llanbadarn Community Council; prompted re-pair of metal fencing opposite the New Inn Pub, resurfacing of road on the bend prior to the shop. Continual repair, maintenance and clearing of roads during the Winter/Spring. Assisted in helping a resident in accessing hospital transport for emergency medical treatment through the severe snow conditions. Continual reporting of fly tipping. Initiated probation Youth to litter pick, as well as clearing rubbish from the verges myself. Local safeguarding concerns. Made the proposal for local volunteers at Llanbadarn Community Shop to be recognised for their volunteering efforts through Powys Association of Voluntary Organisations [PAVO] scheme. Teme Ithon Action Group: Continual involvement in raising much needed funds for community initiatives and needs of all three communities within the ward. Local access dispute. Support of Llanbadarn Fynydd YFC.

Llanbister: Continual positive working relationships with Llanbister Community Council and Hall committee. On-going process in identifying a potential bus stop/safe area for the general public to access. Road repair near the village hall, identifying hazard of speed bumps and manhole cover – still continues but, acknowledged. Gate repair on unclassified road. Support for local business's with highways issues. Request of toddler swing in play area undertaken. Access dispute and rights of way issue. Fly tipping issues, road maintenance and clearing of roads due to severity of the weather. Support though TIAG in securing a 'green space' for Llanbister CP School – remains on-going. Support for community in Community Asset Transfer [CAT] and future processes on this site. Support of Cantel YFC. Continual support for Llanbister CP School – safeguarding/health and safety roles.

Beguildy: Continual involvement and over sight in rectifying the drains and roads near Bryndraenog Farm. Continual repair, maintenance and where able clearing of roads during the Winter and Spring. Supporting Knucklas community by initiating a Community Connector to support with locality and raise profile and involvement of the Hall. Oversight

in CAT transfer and support in completion – on-going. Support in tree hazard. Assisted in initiating funds through Sports Wales for Felindre Football Club. Wind turbine issues and contamination concerns – met with MP. Enforcement issues, rights of way and fly tipping issues. Offering of Community Support through ‘Ask Me’ initiative. Support of TEME valley YFC and WI.

Adran 2: Gweithgaredd yr etholaeth

Llanbadarn Fynydd: perthynas weithio bositif a pharhaus gyda Chyngor Cymuned Llanbadarn; ysgogi atgyweirio ffens fetel gyferbyn â thafarn y New Inn, gosod wyneb newydd ar y ffordd ar y tro cyn y siop. Atgyweirio, cynnal a chadw a chlirio ffordd yn barhaus yn ystod y Gaeaf/Gwanwyn. Cynorthwyo preswlydd i gael cludiant gan yr ysbyty ar gyfer triniaeth feddygol frys yn ystod yr eira difrifol. Rhoi gwybod yn barhaus am dipio anghyfreithlon. Ysgogi leuenctid ar brawf i godi sbwriel, yn ogystal â chlirio sbwriel o ymylon y ffordd fy hun. Pryderon diogelu lleol. Cynnig bod gwirfoddolwyr lleol yn Siop Gymunedol Llanbadarn yn cael eu cydnabod am eu hymdrechion gwirfoddoli trwy gynllun Cymdeithas Mudiadau Gwirfoddol Powys [PAVO]. Grŵp Gweithredu Tefeidiad Ieithon: Ymwneud parhaus â chodi arian cwbl angenrheidiol ar gyfer mentrau cymunedol ac anghenion tair cymuned y ward. Anghydfod mynediad lleol. Cefnogi CFFl Llanbadarn Fynydd.

Llanbister: perthynas weithio bositif a pharhaus gyda Chyngor Cymuned Llanbister a phwyllgor y Neuadd. Proses barhaus o geisio dewis arosfan bws posibl/man diogel y gall y cyhoedd ei gyrraedd. Atgyweirio ffordd ger neuadd y pentref, nodi perygl twmpathau cyflymder a gwaith haearn ar y ffordd - mae'r sefyllfa'n parhau ond mae wedi ei chydnabod. Atgyweirio gât ar ffordd ddi-ddosbarth. Cefnogi busnesau lleol gyda materion priffyrdd. Hyrwyddo cais am siglen i blant bach mewn man chwarae. Anghydfod ynghylch mynediad a mater hawliau tramwy. Problemau gyda thipio'n anghyfreithlon, cynnal a chadw ffyrdd a chlirio yn sgil tywydd difrifol. Cefnogaeth trwy TIAG i sicrhau 'man gwyrdd' i Ysgol Gynradd Llanbister - y mater yn parhau. Cefnogaeth i'r gymuned gyda Throsglwyddo Asedau i'r Gymuned [CAT] a phrosesau ar y safle hwn yn y dyfodol. Cefnogi CFFl Cantel. Cefnogaeth barhaus i Ysgol Gynradd Llanbister - rolau diogelu/iechyd a diogelwch.

Bugeildy: Ymwneud parhaus â thrwsio'r draeniau, a goruchwyllo'r mater ar ffyrdd ger Bryndraenog Farm. Atgyweirio a chynnal a chadw ffyrdd, a lle bo modd, eu clirio yn ystod y Gaeaf a'r Gwanwyn. Cefnogi cymuned Cnwclas trwy ysgogi Cysylltydd Cymunedol i helpu gyda'r ardal a chynyddu proffil ac ymwneud y Neuadd. Goruchwyllo trosglwyddo asedau CAT a chymorth i gwblhau hyn - y mater yn parhau. Cymorth gyda pherygl coed. Cynorthwyo i ddenu cyllid trwy Chwaraeon Cymru ar gyfer Clwb Pêl-droed Felindre. Materion tyrbinau gwynt a phryderon halogiad - cyfarfod â'r AS.
