Summary

This report makes recommendations on

 Establishing a permanent governing body for the new 4-18 school in Machynlleth from September 2014

Background

On the 3rd December 2013, Cabinet approved a proposal to close Ysgol Bro Ddyfi and Ysgol Gynradd Machynlleth on the 31st August 2014, and open a new 4-18 school on two sites in Machynlleth from September 1st 2014.

A temporary governing body was established on the 9th January, in accordance with_The New Maintained Schools (Wales) Regulations 2005', which sets out the regulations for the governance of new maintained schools in Wales. The Regulations prescribe the timescale for the establishment of temporary or shadow governing bodies, the number and types of governors and how they are to be nominated. If a new school is to be established, there is a requirement to establish:

- a shadow or temporary governing body in advance of the incorporation of the school;
- a permanent governing body with effect from the date of establishment of the school.

Proposal

Instrument of Governance

The new school will be established under The Education (Middle Schools) (Wales) Regulations 2012 (" the Middle Schools Regulations"). These regulations are intended to determine, or enable the Welsh Ministers to determine, whether a middle school (that is a school which contains pupils of both primary and secondary school age) should be treated for legislative purposes as a primary school or a secondary school.

Middle schools are defined in section 5(3) of the Education Act 1996 as schools providing full-time education suitable to the requirements of pupils who—

- have attained a specified age below 10 years and six months,
- are under a specified age above 12 years.

Such schools would include 'all-through' schools, educating children between the ages of 4 and 16-18.

Regulation 4 of the Middle Schools Regulations provides that a middle school is to be determined to be a secondary school where that school has a wider range of pupils of secondary school age, than primary school age, or, unless a determination has been made under regulation 5(2), where that school provides education up to or beyond compulsory school age.

A governing body for the new 4-18 School will need to be established, replacing the current two governing bodies, which will cease on the closure of the schools on the 31^{st} August 2014. In accordance with the Middle Schools Regulations, the new School has been determined to be a secondary school.

The Instrument of Governance is based on this, and is attached at Appendix 1.

Name of new school

The name of the new 4 - 18 school has been agreed by the Temporary Governing Body to be Ysgol Bro Hyddgen, Machynlleth.

- 4 LA governors
- 2 teacher governor
- 1 staff governor
- 4 community governors
