1.0 Summary

To support a partnership - the Elenydd Landscape Partnership to apply for a 4 year HLF funded programme of environmental, built heritage tourism and community projects approx value £2m and if successful to support the Partnership in its delivery.

2.0 Background Information

Initiated as a project supported by the Cambrian Mountains Initiative Powys County Council has been working to support the development of a Landscape Partnership funding application focussed on the Elan Valley.

Working with key partners - Welsh Water, Ramblers, Elan Valley Trust, RSPB RWT RCAHM and the Cambrian Mounts Initiative. we hope to submit a Landscape partnership bid to the Heritage Lottery Fund –Partners have worked hard over a very short period to develop a scheme of ideas to fund both built heritage and environmental conservation project in the valley which will lead to a great deal of community engagement from local people and visitors. Although the timescale is tight the group wishes to make an application this year which has to be in on Tuesday 28th Feb or they must wait a further year. Welsh Water is prepared to take a project lead and accountable body role but at a meeting with the HLF on 6th February we were advised that a LA acting as lead would be more usual and as a result more helpful to the application

3.0 Proposal

That the Regeneration Service of PCC acts as lead partner for the submission of a HLF Landscape Partnership application on behalf of the Elenydd Landscape Partnership and for the Portfolio Holder for regeneration to act as the named signatory on the application

4.0 Corporate Improvement Plan

The project support the regeneration strategy aims that contribute to the CIP Projects to be supported within the scheme contribute to aims and objectives of regeneration and countryside services and also support museum service aims for e-trails. The project area stretches to Cwmystwyth and is supported by the Ceredigion Museum Service.

5.0 Options Considered/Available

A) Other partners could take a project lead however,

RCAHM could act as a lead but as a National organisation do not provide a Local multi interest overview and while local organisations such as the Elan Valley Trust (a key funding partner) are local they have limited capacity and may as project delivers also have a less strategic view.

B) PCC as strategic advisory partner acts as lead applicant in an HLF funding application

6.0 Preferred Choice and Reasons

B) PCC as strategic advisory partner to the ELP acts as lead applicant in an HLF funding application

Reasons:

- HLF development officers indicate that a LA lead bid would benefit the project
- PCC has a Strategic overview linking all elements environmental built heritage culture and community.
- PCC does not have any project delivery activities within the proposed scheme and as a result can maintain a non financial interest in its delivery.
