**Summary**

The Government of Maintained Schools (Wales) Regulations 2005 required all school governing bodies to review and adopt revised Instruments of Government (Instruments of Government are the legal documents that detail the composition of a schools governing body). The Authority approved all revised Instruments of Government with effect from 3rd October, 2006.
