At the Council's Annual meeting on 17 May 2018 I stepped down from my role on the Fostering Panel after almost ten years of involvement.

I served on the following outside organisations:

Franskbridge CP School Governing Body – I attended the Police and pupils seminar to parents and Governing Body members on Online Safety.

Heart of Wales Line - I have continued to be the council's representative supporting the Walking Trail along the Line and the change to a DevCo (Development Company).

Community Foundation in Wales grants panel – Councillor representing the Radnorshire area. Part of this responsibility is to spread the word about what the Foundation does.

Wyeside Arts Centre – I was the Chair of Trustees and this role required my attendance at Finance Committee, staff discussions, Quarterly Executive meetings, links to Child Protection and Safeguarding training for volunteers and staff. Alongside the general work budget issues around potential development of the Arts centre has been a large commitment over the last year.

Section 2: Constituency activity

I continued to attend my three community Councils as often as time and other commitments allowed. These were on evenings which sometimes clashed with other Council commitments. I liaised with the Clerks and followed up on Agenda items where appropriate.

I supported a new community councillor to engage with the relevant organisations and officers to develop her knowledge and role. I continued to respond to local issues raised by constituents in a timely manner.
