Section 2: Constituency activity

I was instrumental in saving the towns Friday Market from closing down by working with the Authority and the local Health Board to find a new site for them to use after their private site was sold. This resulted in them moving to the High Street Car Park.

I have worked with:

- the Indoor Bowling Club to help them finalize the transfer of the building from Powys County Council into their ownership.
- Dawns Powys Dance to help them successfully receive grant funding to look at future improvements to the building and services.
- various Portfolio Holders to look at issues affecting the Town and ways of improving the area.
- Powys Association for Voluntary Organisations [PAVO] and Grand Pavilion events to try and move forward the transfer of the building from Powys County Council.

I have received many calls, emails and letters from residents about parking on the streets and in the car parks. I arranged a walk around town with the Portfolio Holder for Highways to highlight the problems and look into ways the problems can be improved.

I have:

- spoken with Heads of Service about the ongoing issues with day care provision.
- attended the Residents Coffee Mornings at the Court Lant Avenue and drop in sessions with Housing Services to support residents.
- provided general help to residents with various issues around my ward and neighbouring wards.
- looked into further ways of tackling the ongoing problems around dog fouling within my ward and the Town in general.
- attended meetings between Powys County Council and local support services.
- chaired and attended meetings between members of Holy Trinity Church, Grand Pavilion Events, Tennis Club and the Indoor Bowling Club.
