Three years have gone by since being elected as a Councillor and it continues to be rewarding enabling me to represent Llangattock at the Council as a Welsh Liberal Democrat.

This year seems to have been dominated by crisis. In October and February Llangattock was hit by storms and flooding and now like every community in the UK we have COVID-19. Our community has drawn on its support for each other and is getting through with fortitude and resilience.

As the Welsh Liberal Democrat lead on Disability in our group I continue to support equality issues ensuring the voice of different disability groups are heard and listened to on the Powys strategic agenda.

Section 2: Constituency activity

Case work in Llangattock has been constant and I really enjoy getting this done. Speeding is still the greatest concern through the village and I have worked closely with Llangattock Community Council to fund and support three RTOs to slow down the traffic. COVID-19 has halted progress but changes are on the way. Powys Active Travel have a plan to deliver to Llangattock in 2020 now which will be part of the Powys Travel Plan Project application to Welsh Government.

Every month I hold a surgery in the Community Hall and deliver a monthly newsletter to residents which is posted on all notice boards, on the Community Council website and

my Facebook page. I interact regularly with residents on Nextdoor which has over 260 members now. During the COVID-19 crisis I have experimented with virtual Surgeries too.

I work very closely and actively with the Community Council on issues which directly affect residents including recreation ground improvements and a Village Vision. I have also worked very closely with Councillors in Crickhowell, Cwmdu/Bwlch and Llangorse on issues which affect us all including better interaction as a Five Councils body and flooding.

The Women's Equality Network retain my details as a County Councillor to Mentor for 2020. It remains a very rewarding role and all learning will be shared with Powys Democratic Services to support others who may wish to undertake such a role.

As an appointed Governor of Llangattock Church in Wales Primary and Crickhowell High School I continue to attend mandatory training, this is crucial for the role. Understanding the needs of our local schools is very important to the students and parents in the area. There have been many challenges this year for Crickhowell High School.

As a voting Member of Powys Community Health Council representing Powys County Council I continue to attend training as appropriate and provide other support for that role including participating in peer review and contributing to the strategic plan.

The various Committees such as Health & Care Scrutiny Committee and Democratic Services have provided extra learning and development opportunities.

Section 4: Outside organisations and other activities

Powys Community Health Council is now further forward as a result of a White Paper delivered by Welsh Government to change the structure and delivery of CHC's in Wales. This new body will undertake similar activities now in Social Care which will require greater participation from County Councillors in future, working closely with this organisation. Holding the Health Board to account is an important role for the CHC but they also have a strong team of advocates who support individuals who have health care complaints. This will become increasingly important as the County Council and Health Board continue to follow through with closer working and active partnership.

Adran 2: Gweithgareddau yr etholaeth

Mae gwaith achosion Llangatwg wedi bod yn gyson ac rwyf wirioneddol yn mwynhau cyflawni hyn. Mae goryrru yn parhau i fod yn bryder mawr trwy'r pentref ac rwyf wedi parhau i weithio'n ddiwyd gyda Chyngor Cymuned Llangatwg i ariannu a chefnogi'r tri Gorchymyn Traffig y Ffyrdd er mwyn arafu'r traffig. Mae COVID-19 wedi arafu'r cynnydd ond mae newidiadau ar y ffordd. O ganlyniad mae gan Deithio Llesol Powys

fwriad i gyflawni cynllun i Langatwg yn 2020 nawr a fydd yn rhan o gais Prosiect Cynllun Teithio Llesol Powys i Lywodraeth Cymru.

Rwy'n cynnal cymhorthfa bob mis yn y Neuadd Gymunedol ac yn cynhyrchu cylchlythyr misol i drigolion. Mae hwn yn cael ei roi ar hysbysfyRDDau, gwefan y Cyngor Cymunedol ac ar fy nhudalen Facebook. Rwy'n rhyngweithio'n rheolaidd gyda trigolion ar Nextdoor sydd â dros 260 o aelodau bellach. Yn ystod argyfwng COVID-19, rwyf wedi arbrofi gyda chymhorthfeydd rhithwir hefyd.

Rwy'n cydweithio'n agos iawn ac yn weithgar gyda'r Cyngor Cymunedol ar faterion sy'n effeithio ar breswylwyr yn uniongyrchol. Mae'r rhain yn cynnwys gwelliannau i dir hamdden a chwarae a Gweledigaeth i'r Pentref. Rwyf hefyd wedi cydweithio'n agos gyda Chyngorwyr yng Nghrughywel, Cwmdu/Bwlch a Llangors ar faterion sy'n effeithio ar bob un ohonom. Mae'r Rhwydwaith Cydraddoldeb Merched wedi cadw fy manylion fel Cynghorydd Sir i Fentora ar gyfer 2020. Mae'n parhau i fod yn rôl werthfawr a bydd yr holl ddysgu'n cael ei rannu gyda Gwasanaethau Democrataidd Powys i gynorthwyo eraill a fyddai efallai am ymgymryd â rôl o'r fath.
