### Section 2: Constituency activity

I have remained an active Councillor during the past year working hard for people across St John Ward and Brecon. I have continued to hold fortnightly advice surgeries for residents to meet with me as well as weekly street surgeries across St John Ward.

I hosted an older people's event earlier in the year with the Deputy Older People's Commissioner for Wales. The event was attended by people from across St John Ward and organisations like Dyfed-Powys Police, PRIME Cymru, Care and Repair, Wales and West, Social Services and Brecon's Dementia Friends also attended.

Throughout the past year, I have continued to deliver my *Local Voice* Newsletter to every house four times a year to help keep constituents up to date with my work as their local Councillor.

I worked very closely with the Town Council to help save Brecon's public toilets from closure by helping to develop a costed plan with Brecon's Town Council. I have also worked with the police to help secure a new CCTV system for the town.

I have continued to manage a very busy caseload, representing local people and working

hard to resolve their issues. I have worked with community organisations across the town to help improve the lives of St John Ward residents.

I have made regular contributions to meetings and debates at County Hall. I spoke and voted against the Council's budget, drawing particular attention to the impact of the proposals on the people I represent. I was able to stop a cut in funding for support services for victims of domestic violence.

I have campaigned against the Council's changes to Domiciliary Care Services and represented numerous constituents who have experienced poor service and failings caused by the Council's decision to externalise the service.

I have campaigned for improvements to Brecon's Market and handed a petition into the Council along with a letter signed by the traders that called on Powys Council to take action to clean the Market up, improve signage and engage with stall holders and traders.

I have continued to fight for speed calming measures on Cradoc Road. I regularly take Council staff around St John Ward to identify issues that need intervention.

Despite reductions in spending, I have been able to secure a number of improvements across St John Ward and I have been working with the Council, residents and community groups to identify issues.

I have regularly asked questions of the Council's Cabinet, scrutinising their decisions and the impact on my community.

Rwy wedi parhau i fod yn Gynghorydd gweithgar dros y flwyddyn ddiwethaf yn gweithio'n galed ar ran pobl Ward Sant Ioan ac Aberhonddu. Rwy wedi parhau i gynnal cymorthfeydd cyngor bob pythefnos i drigolion yn ogystal â chymorthfeydd stryd bob wythnos ar draws Ward Sant Ioan.

Trefnais i ddigwyddiad i bobl hŷn ar ddechrau'r flwyddyn gyda'r Dirprwy Gomisiynydd Pobl Hŷn Cymru. Daeth pobl o ar draws Ward Sant Ioan a mudiadau megis Heddlu Dyfed-Powys, PRIME Cymru, Gofal a Thrwsio, Cymru a'r Gorllewin, Gwasanaethau Cymdeithasol a Chyfeillion Dementia Aberhonddu.

Trwy gydol y flwyddyn rwy wedi parhau i ddosbarthu cylchlythyr "Local Voice" i bob tŷ bedair gwaith y flwyddyn i ddiweddar trigolion gyda'm gwaith fel eu Cynghorydd lleol.

Gweithiais i'n galed iawn gyda Chyngor y Dref i helpu i achub toiledau cyhoeddus Aberhonddu rhag cael eu cau trwy helpu i ddatblygu cynllun gyda Chyngor y Dref. Rwy hefyd wedi gweithio gyda'r heddlu i helpu i sicrhau system CCTV newydd i'r dref.

Rwy wedi parhau i reoli llwyth achosion prysur iawn, gan gynrychioli pobl leol a gweithio'n galed i ddatrys eu problemau. Rwy wedi gweithio gyda mudiadau cymunedol ar draws y dref i helpu i wella bywydau trigolion Ward Sant loan.

Rwy'n cyfrannu'n rheolaidd at y cyfarfodydd a'r dadleuon yn Neuadd y Sir. Siaradais a phleidleisio yn erbyn cyllideb y Cyngor, gan dynnu sylw arbennig at effaith y cynigion ar y bobl rwy'n eu cynrychioli. Llwyddais i stopio torri'r nawdd am wasanaethau cymorth i'r rhai sydd wedi dioddef traïs yn y cartref.
