Apart from assisting local people as required during the Covid-19 pandemic, my work has included working with Clyro Primary School to try to secure appropriate funding from Powys County Council and dealing with numerous highways issues. I was particularly pleased to see my efforts to secure improvements to the storm drainage system in Rhosgoch were rewarded with the installation of an excellent new system, which will greatly reduce the risk of flooding.

I have also supported Glasbury & District Community Council's efforts to install on-street parking restrictions (double yellow lines) to help reduce the parking problems that occur in the village every summer. The introduction of these double yellow lines is still pending but hopefully will be in place for summer 2022.

I was delighted to see the construction of the new Council houses in Clyro start and the building work has progressed well. These will provide ultra energy-efficient homes for local people to rent and are being built to a very high standard. They are due to be occupied by November 2021.
