Section 2: Constituency activity

Over the past 12 months there has been a flurry of activity in Llanyre and Newbridge on Wye. In addition to dealing with the day to day issues that residents face such as waste and recycling problems, grass cutting, housing problems etc. there have been some exciting developments.

One of the main issues people raised with me in Llanyre when I was campaigning was that there was no longer a village show. In September 2017, I set up a committee of enthusiastic, dedicated and keen volunteers with myself as Chairperson. After many months of hard work and planning, the Llanyre Show, resurrected after 6 years, will be held in August 2018, along with the new and much loved Scarecrow Competition. I also organised a very successful fundraising event in Llanyre Church where the Dolau Mixtures choir performed along with other local and very talented artists, with all money going towards the village show.

Llanyre Church Hall has been in a dilapidated state for many years with the building not being fit for purpose with areas being off limits to users. A public meeting was held for residents resulting in a fundraising committee and management committee being created to manage the works needed in order to bring the Hall up to spec. I now sit on both of these committees. We have many exciting events coming up in order to raise the funds to carry out continuing works and future maintenance. The Church hall has already received a major face lift and a new kitchen plus other works that has made it far more suitable for groups to use.

There has also been boundless activity in Newbridge with the forever growing and successful Community Speed Watch Campaign. Following on from undertaking the necessary training with Dyfed Powys Police, I attended a number of speed watch sessions on a regular basis. We have seen first-hand how effective the sessions are with drivers who regularly travel through the village slowing down to the appropriate speed. I also took

part in the Community Action Day along with Powys Road Safety, Dyfed Powys Police [DPP], Mid and West Wales Fire and Rescue Service, Newbridge Primary School Safety Committee (made up of pupils of all ages) to raise awareness of the dangers of speeding and how it affects residents of the village. In addition, I have met with the Portfolio Holder for Highways and Senior Officers in the hope of improving the speed signs and ground signs throughout the village. Along with this I contacted the Welsh Government and Trunk Road Agency in order to secure the lighting of the 20mph signs outside the school to be turned on earlier following requests from a number of parents.

I have also met with DPP in Llanyre, who have carried out risk assessments in preparation for the scheme to be mirrored in the village.

Adran 2: Gweithgaredd yr etholaeth

Dros y 12 mis diwethaf bu llawer o weithgareddau yn Llanllŷr a Phontnewydd-ar-Wy. Yn ogystal ag ymdrin â'r problemau y mae'r trigolion yn eu hwynnebu o ddydd i ddydd megis problemau gwastraff ac ailgylchu, torri glaswellt, problemau tai ac ati. Bu nifer o ddatblygiadau cyffrous.

Un o'r prif broblemau a gododd pobl gyda mi yn Llanllŷr wrth i mi ymgyrchu oedd nad oedd sioe bentref yn cael ei chynnal yno bellach. Fis Medi 2017, sefydlais bwyllogor o wirfoddolwyr brwdfrydig, ymroddedig ac awyddus a minnau'n Gadeirydd arno. Ar ôl sawl mis o waith caled a chynllunio, atgyfodwyd Sioe Llanllŷr ar ôl 6 mlynedd a bydd yn cael ei chynnal fis Awst 2018, ynghyd â'r Gystadleuaeth boblogaidd i greu Bwgan Brain. Trefnais hefyd achlysur codi arian llwyddiannus dros ben yn Eglwys Llanllŷr, lle perfformiodd côr y Dolau Mixtures ynghyd ag artistiaid lleol eraill oedd yn ddawnus iawn, ac aeth yr holl elwi at sioe'r pentref.

Mae Neuadd Eglwys Llanllŷr wedi bod mewn cyflwr gwael am sawl blwyddyn bellach, ac nid yw'r adeilad yn addas i'r diben. Nid yw pobl yn cael defnyddio sawl rhan ohono. Cynhaliwyd cyfarfod cyhoeddus i drigolion gan arwain at bwyllogor codi arian a phwyllogor rheoli i reoli'r gwaith angen rheidiol er mwyn diweddarwr Neuadd. Rywf bellach yn gwasanaethu ar y ddua bwyllogor. Mae sawl digwyddiad cyffrous ar y gweill i godi arian o gyflawni'r gwaith angenrheidiol a chynnal a chadw'r adeilad yn y dyfodol. Mae neuadd yr Eglwys eisoes wedi cael rhywfaint o ddiweddarwr a chegin newydd, a gwaith arall sy'n golygu ei bod bellach llawer yn fwy addas i grwpiau ei defnyddio.

Cafwyd llawer o weithgareddau ym Mhontnewydd hefyd gyda'r Ymgyrch Gymunedol i Wylio Cyflymder. Yn dilyn yr hyfforddiant angenrheidiol gyda Heddlu Dyfed Powys, mynchais nifer o sesiynau gwyliau cyflymder yn rheolaidd. Rydym wedi gweld â'n llygaid

ein hunain pa mor effeithiol yw'r sesiynau gyda'r gywyr sy'n teithio trwy'r pentref yn arafu i'r cyflymder priodol. Cymerais ran yn y Diwrnod Gweithredu Cymunedol ynghyd ag adran Diogelwch ar y Ffyrdd Powys, Heddlu Dyfed Powys [DPP], Gwasanaeth Tân ac Achub Canolbarth a Gorllewin Cymru, Pwyllgor Diogelwch Ysgol Gynradd Pontnewydd (sy'n cynnwys plant o bob oed) i gynyddu ymwybyddiaeth o beryglon gyrru'n rhy gyflym a sut y mae'n effeithio ar drigolion y pentref. Yn ogystal â hyn rwyf wedi cyfarfod ag Aelod Portffolio Prifffyrdd ac Uwch Swyddogion yn y gobaith o wella'r arwyddion cyflymder a'r arwyddion ar y ffordd trwy'r pentref. Cysylltiad â Llywodraeth Cymru a'r Asiantaeth Cefnffyrdd er mwyn trefnu i'r goleuadau ar gyfer yr arwyddion 20mya y tu allan i'r ysgol gael eu cynnau'n gynt yn dilyn ceisiadau gan nifer o rieni.

Rwyf hefyd wedi cyfarfod â DPP yn Llanllŷr, sydd wedi cynnal asesiad risg yn barod i'r cynllun gael ei adlewyrchu yn y pentref.
