In July 2021, Scrutiny requested that the Road Safety Partnership consider a cycle safety campaign:-

The group agreed to a social media campaign and to share/retweet.

This coincided with Op EDWARD (*Each Day Without a Road Death*) – an annual National Operation for a week (13-17 Sep 2021).
