I have endeavoured to be a hard working Ward Councillor throughout the year, dealing in a timely manner, with many constituency matters and residents problems, many with positive outcomes. I have attended meetings of Talgarth Town Council in the ward to provide Town Council colleagues with information and guidance where appropriate.

I have also contributed to regular newsletters in Talgarth Ward, including a 600 word monthly update in the Wye Local Community Magazine; have been a regular contributor to the "fyitalgarth" community web site and have maintained constant touch with local residents via facebook and Twitter, in order to keep my constituents informed and up-to-date with relevant issues that affect them. I have also held a monthly advice surgery at Talgarth Tourist Information & Resource Centre to deal with residents' concerns - as well as calling around the estates in Talgarth, to follow up on casework issues.

I also attended a forum for local businesses hosted by the Leader of Council. I have found both Powys Association of Voluntary Organisations [PAVO] and Powys local Health Board run sessions also most informative on areas of joint working.
