In addition to those listed I attended a number of scrutiny briefing sessions, corporate employment policy forums and sat on redundancy appeals/grievance hearings and Shortlisting and Appointments Sub-Committees amounting to a further 11 meetings.

I served on the following outside organisations:

## Section 2: Constituency activity

This year I have spent a considerable amount of time working on issues associated with the proposal to build a northern relief road around Shrewsbury in conjunction with a dam of the River Severn which would have had flooding implications for Llandrinio Ward. I ensured that all those who lived in areas likely to be affected knew about the proposals by personally delivering letters, and organised meeting for them with the Environment Agency and Shropshire County Council. I attended meetings with the River Severn Partnership, The Sever Rivers Trust, The National Flood Forum and with a number of Shropshire Parish Councils as well as requesting meetings of the County Council and our local MP and Senedd Member. I have taken a lead in ensuring that the best interests of my residents were considered and that they were kept well informed.

I continue to work with residents of the Wern area to push for improved management of flood water in this area in order to reduce the risk of flooding to properties and farmland.

I have also been involved in a project to bring Fibre Broadband to properties which currently suffer from a poor or intermittent service and this has also involved delivering letters to those who might benefit most.

I have maintained contact with our local police force through occasional meetings with our Police Community Support Officer

I write monthly articles for the Llandrino village magazine and quarterly articles for Arddleen's

I have spoken to, or met with constituents to discuss wide ranging issues including planning (both for and against and including breaches of planning conditions), road safety/speeding, potholes/road damage, road closures, bridge damage, grass cutting, signage, recycling, , dangerous parking, footpath use, school transport, noise and flooding.
