### Section 2: Constituency activity

**Surgery Sessions** - I held monthly advice surgeries at the Community Halls in Ystradfellte, Pontneddfechan and Coelbren (when the Ynys-wen Hall re-opens surgeries will be scheduled there).

**Youth Community** - I have supported the setting up of a Youth Committee in Coelbren with the co-operation of the Memorial Hall Committee.

**Water (Flooding) Issues (Caehopkin)** - I have been in discussions with officers of Powys County Council and Environment Agency Wales to implement a solution to the water problem in Caehopkin village.

**Subsidence (Lon Hill)** - I have kept in close contact with officers of the Authority to ensure repair work will commence after investigations to the road at Lon Hill Caehopkin after the subsidence.

**Ynys-wen Hall (Hall)** - I am in the process of trying to form an action group to proceed with activities which should lead to the eventual re-opening of the Hall at Ynys-wen and repair of the playing field.

**Penycae (Land Acquisition)** - I made representations to Powys Property Dept. on behalf of residents of Pen-y-cae to acquire a small piece of land through an 'Expression of Interest' to hopefully allow the re-location of existing play facilities.

**Local Concerns** - through direct contact and advice surgeries I have been able to feedback concerns for residents on all sorts of matters ranging from housing repairs, street lighting, dangerous trees, public/school transport, drainage issues, footpath matters, road re-surfacing and Youth/recreational activities. We have been successful in getting most of these resolved.

**Business Visits** - During the summer of 2012 I was accompanied by Joyce Watson AM and we visited a range of businesses in the Ward.

**Public Transport** - I have communicated concerns to the Authority over the poor public transport facilities in the Ward. Public meetings were also arranged.

**Ystradgynlais Hospital** - Meetings have been attended with management at Ystradgynlais Hospital with lengthy discussions around the availability of the Minor Injuries Unit and the future direction of healthcare at the hospital.

**Village Walkabouts** - I have conducted village 'walkabouts' with relevant officers of the Authority and future remedial action where needed has been discussed.

**Section 3: Learning & Development** - after the elections in May 2012 induction sessions were provided during May and June to ensure that Councillors could undertake their roles. Ongoing monthly development is provided.

Induction sessions – Induction 1& 3; Code of Conduct; Regulatory Committee – planning, windfarms, rights of way, taxi licensing; Licensing Act 2003 and Gambling Act; Safeguarding and Corporate Parenting; Planning Protocol; Audit Committee; Welsh Local Government Association Scrutiny induction

Ongoing development - Treasury Management, Information handling and data protection, Welsh Housing Standards, Alternative management and delivery of leisure services; Estyn update; Performance and project management; Adult Social Care; Members' Annual reports and using Outlook; Powys Change Plan; Making social media work for councillors.

**Governor Training:** I also attend a large number of school governor training events. The role of school governor is becoming evermore demanding both in terms of time commitments and expert knowledge. I have received specific governor training in relation to induction, complaints and disciplinary procedures. Training is on-going.

#### **Section 4: Outside organisations and other activities**

I have also undertaken the following:

- regularly attended meetings of both the Ystradfellte and Tawe Uchaf Community Councils.
- took up an invitation to visit the Ystradfellte Young Farmers Group.
- spoke to the Pontneddfechan Senior Citizens Group, Coelbren Senior Citizens and Pen-y-cae/Abercraf Senior Citizen Group.
- attended meetings called to discuss illegal substance abuse in Ystradgynlais.
- had regular contact with police officers and they often attend my advice surgeries.
- attended meetings of the Ystradgynlais Access Group.

### Adran 2: Gweithgaredd o fewn yr Etholaeth

**Cymorthfeydd** - Cynhaliais gymorthfeydd misol yn Neuaddau Cymuned Ystradfellte, Pontneddfechan a Choelbren (pan gaiff Neuadd Ynys-wen ei hail-agor, cynhelir cymorthfeydd yno hefyd).

**Cymuned Ieuencid** – Rwyf wedi cefnogi sefydlu Pwyllgor Ieuencid yng Nghoelbren gyda chydweithrediad Pwyllgor y Neuadd Goffa.

**Problemau Llifogydd (Caehopkin)** – Rwyf wedi cynnal trafodaethau gyda swyddogion Cyngor Sir Powys ac Asiantaeth yr Amgylchedd i weithredu ynghylch ateb y broblem gyda dŵr ym mhentref Caehopkin.

**Ymsuddiant (Lôn Hill)** - Rwyf wedi cadw cysylltiad agos gyda swyddogion yr Awdurdod i sicrhau y bydd gwaith atgyweirio yn cychwyn yn sgil ymchwiliad i ymsuddiant ar y ffordd yn Lôn Hill Caehopkin.

**Neuadd Ynys-wen** - Rwyf yng nghanol ceisio sefydlu gweithgor i symud ymlaen gyda gweithgareddau - eu bwriad yw y bydd yn y pen draw yn arwain at ail-agor Neuadd Ynys-wen ac atgyweirio'r maes chwarae.

**Penycae (Caffael Tir)** – Rwyf wedi cynrychioli trigolion Pen-y-cae gydag Adran Eiddo Powys i gaffael darn bach o dir trwy ‘Ddatganiad o Ddiddordeb’ fydd gyda lwc yn eu galluogi i adleoli cyfleusterau chwarae.

**Pryderon lleol** - trwy gysylltiad uniongyrchol a chymorthfeydd, rwyf wedi llwyddo i roi adborth ar ran trigolion ar bob math o broblemau, yn amrywio o atygweirio tai, goleuadau stryd, coed peryglus, cludiant cyhoeddus/ysgol, problemau draenio, llwybrau troed, rhoi wyneb newydd ar ffyrdd a gweithgareddau leuenctid/Hamdden. Rydym wedi llwyddo i ddatrys y rhan fwyaf o'r rhain.

**Ymweliadau Busnes** – Yn ystod Haf 2012, yng nghwmni Joyce Watson AC aethom i ymweld ag ystod o fusnesau yn y Ward.

**Cludiant cyhoeddus** - Rwyf wedi trosglwyddo pryderon i'r Awdurdod yngylch diffyg cyfleusterau cludiant cyhoeddus yn y Ward. Hefyd cynhaliwyd cyfarfodydd cyhoeddus.

**Ysbyty Ystradgynlais** – Rwyf wedi cwrdd gyda rheolwyr Ysbyty Ystradgynlais i drafod yr Uned Mân Anafiadau a chyfeiriad gofal iechyd yr ysbyty yn y dyfodol.

**Cerdded o gwmpas y Pentref** - Rwyf wedi cerdded o gwmpas y pentref gyda swyddogion perthnasol yr Awdurdod, i drafod gwaith atygweirio lle bo angen

**Cysylltu â mi:** Croeso i chi gysylltu â mis os oes gennych unrhyw broblemau i'w trafod (manylion cyswllt uchod).

**Adran 3: Dysgu a Datblygu** - ar ôl etholiadau mis Mai 2012 darparwyd sesiynau ymsefydlu ym mis Mai a Mehefin i sicrhau fod Cyngorwyr yn gallu cyflawni eu dyletswyddau. Darperir rhaglen datblygiad misol parhaus.

Datblygiad Parhaus – Rheoli'r Trysorlys, Trin gwybodaeth a diogelu data, Safonau Tai Cymru, Rheoli a Chyflenwi gwasanaethau Hamdden mewn ffordd Amgen; diweddariad Estyn; Rheoli Perfformiad a Phrosiectau; Gofal Cymdeithasol i Oedolion; Adroddiadau Blynnyddol Aelodau a defnyddio Outlook; Cynllun Newid Powys; Defnydd o Gyfryngau Cymdeithasol i Gynghorwyr.

**Hyfforddi Llywodraethwyr:** Rwyf hefyd yn mynd i nifer fawr o ddigwyddiadau hyfforddi i llywodraethwyr ysgol. Mae'r llywodraethwyr ysgol yn golygu treulio mwy a mwy o amser ynghyd â mwy o wybodaeth arbenigol. Rwyf wedi derbyn hyfforddiant penodol i llywodraethwyr yn y meysydd: ymsefydlu, cwynion a gweithdrefnau disgyblu. Mae'r hyfforddiant yn barhaus.
