Section 2: Constituency Activity

- I supported two local Tenant Resident Associations: Tai Gwalia and Gurnos.
- I have been involved in helping regenerate Gurnos Estate, working with and supporting the local Tenants' Residents Association: a new Children's Park was opened and a Play Pod was provided.
- Various seats and bollards have been requested and placed throughout Cwmtwrch.
- I attended the Ystradgynlais and District Access meetings and the Brecon Access meetings, helping to raise awareness of access issues.
- I attended the Ystradgynlais Area Tenants' Panel Meetings and Cross Border Collaboration meetings.
- A new bridge in Lower Cwmtwrch has recently been completed linking Powys with Neath Port Talbot and now the weight restriction has been lifted.

- I undertook individual case work for local residents on various issues ranging from planning, housing, benefits and so on.
- I have been involved in supporting groups of local people concerned about local transport, bringing officers to speak with them.
- I have been working with officers and people in Gurnos on flooding issues, trying to identify the problems and help alleviate them.
- The new area Welsh School, Ysgol Dyffryn Y Glowyr, in Bethel Road opened.
