Section 2: Constituency activity

Advice Surgery Sessions: I have held monthly advice surgeries at the Community Halls in Ystradfellte, Pontneddfechan and Coelbren. When Ynys-wen Hall re-opens surgeries will be scheduled there.

Local Concerns: Through direct contact and advice surgeries I have been able to feedback concerns for residents on all sorts of matters ranging from housing repairs, street lighting, speeding, dangerous trees, road repairs and footpath matters.

Tenant Panels: I attend the Ystradgynlais and District Tenant Panels.

New Play Parks: I have supported Action Groups in Coelbren and Pen-y-cae in their attempts to acquire new play parks. Pen-y-cae opened in Spring 2016 and Coelbren is scheduled to open in the Summer of 2016. Funding has also been sourced for improvements to Caehopkin play park.

Public Transport: I have worked to maintain and improve public transport facilities within

the Ward.

Timber Hauling: I continue to work with Officers to try and alleviate problems caused by timber harvesting near Coelbren. This has now finished and the road is to be re-surfaced.

Ynys-wen Hall: I am supporting the Action Group set up to try and re-open the Hall. Good progress has been achieved. The old hall has been demolished due to safety concerns.

Pontneddfechan Action Group: As a result of public concerns regarding parking issues in the village Traffic Regulation Orders have been submitted for consultation.

Drainage Issues Caehopkin: I have continued to work with Officers in an attempt to find a solution to the problem in Caehopkin Village. This work is ongoing.

Speeding: As a result of speed investigations police have increased checks on problem roads in the Ward.

Ystradgynlais Hospital: I have attended regular meetings between area councillors and hospital management to understand and encourage new developments at the hospital. The New Minor Injury Unit opening hours have proved to be a success.

Coelbren Surgery: I continue to fight to maintain services at Coelbren Health Centre and receive regular updates from the Health Board. Community updates have been arranged through the Focus on Health meetings.

Housing: Work has continued on Authority housing within the Ward to meet Welsh Housing Quality Standards.

ystod Gwanwyn 2016 a disgwylir y bydd Coelbren yn agor yn ystod Haf 2016. Sicrhawyd cyllid hefyd ar gyfer gwelliannau i maes chwarae Caehopcyn.
