I am the Disability Champion for Powys Council.

I served on the following outside organisations:

Board of Disability Powys – I attended an autism roadshow. I have also attended a meeting with regard to local health board and the potential relocation of the local hospital and these are on-going. I am a firm advocate of retaining Shrewsbury and Hereford Hospital facilities for the use of Knighton residents.

Knighton Church in Wales School Governing Body. I have undertaken training and am attending the Governor's Conference in June 2018. I am taking on responsibility at examining disability access within all schools in Powys as well as looking at religious issues and opportunities in schools.

Section 2: Constituency activity

I hold a surgery twice a month in various venues within the constituency to resolve constituent's issues. During the past year I have consulted with Environmental Health to resolve fly-tipping and other issues. I have liaised with Highways Officers concerning disabled access and other safety issues in Knighton. I have also been in touch with Highways regarding grass cutting to improve visibility and the outlook of the Town. I receive regular planning updates and will liaise with Town Council and residents before reporting to Planning Committee. I have spoken with Housing Services regarding social housing in Town. I also assisted with a parking survey on one of the housing estates.

I am seeking regeneration opportunities and attended the Business Breakfast in Knighton which draws together Council and businesses in partnership.

I attended the opening of the new Community centre and also the opening of the new Community Room at St. Edward's Close both of which were part funded by the County Council.

I attended the opening of the new library located in the Community Centre.

I am a regular helper at the local museum and was part of the local committee that located a suitable premises for this important resource in the town.

I attend regular meeting of Knighton Church in Wales School Governing Body. I have worked with Severn Trent Water Company as a learning opportunity for the children of the school to visit the groundworks for the Midlands Water pipes.
