I have pursued the following issues on behalf of constituents:

**Housing issues-** health, safety and safeguarding issues surrounding the Homeless block in the Penybryn estate, many repair and maintenance issues including dampness, leased garage issues, disputes over overgrowing/problematic domestic tree growth, uneven/unsafe pavements (Giedd Rd and Commercial St), two social housing heating

maintenance problems, two bathroom leaks, chasing up house documents on behalf of tenant, meeting regarding restoration of house fire in Dolfain, Welsh Housing Quality Standards [WHQS] issues including re-tendering of roofing contract in Lluest and speaking to tenants regarding necessary property alterations, liaising with Housing Officers regarding improvement works to Maesycwm sheltered housing, meetings with Housing Officers regarding Homeless block, responded to tenant concerns about new restoration charges when properties are vacated, support to Syrian refugees

**Highways** – various individual and locality waste collection problems, grass cutting and weed control issues in all areas but particularly on the Penybryn housing estate, several street light failure reports, pursuing capital monies for speed ‘damping’ solution in Neath Rd and dealing with consequent unhappiness with the work undertaken, chasing Powys officers to direct Road sweeper and Gully suckers to keep drains and kerbside clean (ongoing), six new dropped kerbs delivered in response to Access issues in Dolfain estate, ‘chasing’ officers for capital works including renewal of culvert in Station Rd (after flooding event), Giedd Rd resurfacing and Ystradgynlais Bus Terminal repairs to railings and bollards. I have spoken to Officers regarding many traffic issues such as parking disputes, disabled bays, enforcement and signage in the centre of Town.

**Planning/Rights of Way-** I have spoken to several residents regarding their issues with the Planning process and signposted to appropriate Officers, for six years I have pursued the restoration of Footpath No 6 and 75 in order to finally consolidate various other associated permissible paths after Brynhenllys OPC restoration

**Other** – Supported Youth Service personnel with regard Skatepark and Youth Club problems, spoke and lobbied in support of retaining the Canolfan Day Centre, offered support to Adults with Learning Disabilities staff during Service changes.

**Problemau tai** - materion iechyd a diogelwch ynghylch y bloc Digartref stad Penybryn, nifer o broblemau atgyweirio a chynnal a chadw yn ymwneud â lleithder, garejys ar les, anghydfod dros ordyfiant /tyfiant problemus coed, palmentydd anwastad/anniogel (Heol Gïedd a Heol Drafniol), dwy broblem gyda chynnal a chadw gwresogi tai ar ran y tenant, cyfarfod ynghylch cynnal a chadw'r system wresogi, dau achos o ddŵr yn gollwng mewn ystafell ymolchi, ceisio dogfennau tai ar ran y tenant, cyfarfod ynghylch adfer ar ôl tân mewn tŷ yn Nolfain, materion Safonau Ansawdd Tai Cymru [WHQS] gan gynnwys ail-dendro'r contract i osod toeau newydd yn Lluest a siarad â thenantiaid ynghylch y newidiadau angenrheidiau i eiddo, cysylltu â Swyddogion Tai ynghylch gwaith gwella i dai gwarchod Maes-y-cwm, cyfarfodydd â Swyddogion Tai ynghylch bloc i'r Digartref, ymateb i bryderon tenantiaid am ffioedd adfer newydd wrth adael eiddo, cymorth i ffoaduriaid o Syria

**Priffyrdd** – amrywiol broblemau unigolion a chymunedau o ran casglu gwastraff, problemau torri gwair a rheoli chwyn ymhob ardal, ond yn enwedig ar stad dai Pen-y-bryn, sawl adroddiad am oleuadau stryd yn pallu gweithio, ceisio arian cyfalaf ar gyfer ateb i liniaru cyflymder cerbydau yn Heol Castell-nedd a thrin yr anfodlonrwydd gyda'r gwaith a wnaed, mynd ar ôl swyddogion Powys i gyfeirio peiriannau sgubo'r ffordd a sugno gyliau i gadw'r draeniau ac ymyl y ffordd yn lân (Parhaus), chwech o gyrbiau isel o ganlyniad i broblemau Mynediad ar stad Dolfain, mynd ar ôl swyddogion i gael gwaith cyfalaf gan gynnwys adnewyddu cwlfat yn heol yr Orsaf (ar ôl y llifogydd), gosod wyneb newydd ar Heol Gïedd a gwaith atgyweirio rheiliau a bolardiau yn Nherfynfa Bysiau Ystradgynlais. Rwyf wedi siarad â Swyddogion ynghylch sawl mater yn ymwneud â'r traffig er enghraifft anghydfod ynghylch parcio, manau parcio i bobl anabl, gorfodi ac arwyddion ynghanol y Dref.

**Cynllunio/Hawliau Tramwy** – Rwyf wedi siarad â sawl un o'r trigolion ynghylch eu problemau gyda'r broses Gynllunio ac wedi eu cyfeirio at Swyddogion priodol. Am chwe mlynedd rwyf wedi bod yn ceisio adferiad Llwybr Troed Rhif 6 a 75 er mwyn atgyfnerthu'n derfynol sawl llwybr caniataol cysylltiedig arall ar ôl adfer OPC Brynhenllys.

**Arall** – Wedi cefnogi staff y Gwasanaeth Ieuenctid wrth ymdrin â'r Parc Sglefrio a phroblemau gyda'r Clwb Ieuenctid, wedi siarad a llobio o blaid cadw'r Ganolfan Ddydd, wedi cynnig cefnogaeth i staff Oedolion ag Anableddau Dysgu yn ystod newidiadau i'r Gwasanaeth
