1. CROESO AC YMDDIHEURIADAU / WELCOME AND APOLOGIES (CYNGH/CLLR BRYAN DAVIES)

Apologies for absence were received from Emma Palmer, Chief Executive Powys County Council.

3. COFNODION DRAFFT Y CYFARFOD DIWETHAF / DRAFT MINUTES OF THE LAST MEETING 26/07/2024

The minutes of the last meeting held on 26 July 2024 were agreed as a correct record.

4. PARTNERIAETH SGILIAU RHANBARTHOL CANOLBARTH CYMRU / MW REGIONAL SKILLS PARTNERSHIP (DAI PRICE)

The RSP Manager gave an update on the activities of the Regional Skills Partnership. He advised that RSP team was working with training providers, Further Education providers and engineering businesses to develop appropriate qualifications to support the growing Net Zero/ Green skills technology sector.

He also advised that there was wariness from businesses about taking on apprentices at this time.

5. BARGEN TWF CANOLBARTH CYMRU / MW GROWTH DEAL (CARWYN JONES-EVANS)

5.1. Diweddariad Portffolio Strategol / Strategic Portfolio Update

CJE reported significant challenges on securing match funding, pressure on project costs, delivery readiness and business case development.

To address these challenges, he has been appointed as the Senior Responsible Officer to oversee the Growth Deal and report directly to the Chief Executives of both Councils. In 2025 the Board would be meeting bi-monthly to enable quicker decision making.

Despite the challenges, it was looking likely that elements of the Portfolio would be entering delivery early in 2025.

6. BARGEN TWF CANOLBARTH CYMRU / MID WALES GROWTH DEAL (CATHY MARTIN)

The Operations Manager provided an overview of the programmes and projects within the Portfolio. Work is continuing to develop business cases for projects within the Digital Programme, and for the Sites & Premises Programme work is progressing on the forerunner projects at Horeb and Newtown.

With regards to the standalone projects:

- All 8 projects had received Strategic Outline Case approval.
- 1 OBC had been approved (Elan Valley Lakes).
- 1 OBC had been submitted for approval in this governance cycle (Cynefin).
- 2 projects will adopt a Programme 'Light' approach (GFIP and Montgomery Canal Restoration).
- 2 projects are in the early stages of developing their OBCs (FMIC and MWAMC)
- 1 project is showing very little progress (Aberaeron Harbour)
- 1 project is officially on hold (Tir Glas).

Due to the position for all projects being much clearer and a reasonable pathway forward identified, the general status across all projects is amber, with 6 self-assessments indicating a RAG status of amber, and a further 2 indicating a current position of red. RAG Status for previous period was Amber/Red.

7. DULL O YMDRIN AG ACHOSION BUSNES / BUSINESS CASE APPROACH (CATHY MARTIN)

The Board noted a phased delivery approach had been agreed by the Portfolio Delivery Board. This would allow sequencing and phasing of project delivery which would ease early delivery pressures. The first approach, Project Hybrid would be applied to the Cynefin and Elan Valley Lakes projects and would allow them to gain outline business case approval and then submit subsequent multi work-packages for final business case approval on a phased basis. The second approach, Programme Light, would be applied to the Green Futures Innovation Park and Montgomery Canal Restoration projects. This would enable both projects to develop a phased approach to both securing match funding and planned project delivery. Programme 'Light' means guidance would be applied proportionately and therefore may not necessarily be subject to the same assurance regime as the MWGD's formal programmes (Digital and Sites & Premises).

An approach has been agreed with Welsh Government's Office for Project Delivery – and has been agreed by the Portfolio Delivery Board.

It was confirmed that Welsh Government was content with the approach and that it was consistent with Treasury and Welsh Government guidance and therefore the projects could proceed with confidence.
