Description of proposal *	 The Council has developed a Strategic Outline Case (SOC) in respect of Ysgol Golwg Pen y Fan in Brecon. The SOC identified the following preferred option: Option 4D: Modern Methods of Construction (MMC) new build Ysgol Golwg Pen y Fan on Penlan site (former Brecon High School), with early years and wraparound provision and dedicated area for community/multi-agency facilities The Council's Cabinet will consider the SOC on the 18th February and will be asked to approve the following: To submit a Strategic Outline Case (SOC) to the Welsh Government's 21st Century Schools Programme for investment to develop a new 360 place English-medium primary school building with early years and wraparound provision, plus dedicated community/multi-agency facilities, to replace Ysgol Golwg Pen y Fan's current buildings. This impact assessment considers the potential impact of the preferred option identified.






Impact *	The preferred option would result in a new primary school building in Brecon to replace Ysgol Golwg Pen y Fan's existing poor quality buildings. The new school will be designed to achieve net zero carbon in use ensuring that the building is much more energy efficient than the school's current buildings. Community benefits to include opportunities for traineeships / apprenticeships are a key requirement of Sustainable Communities for Learning projects, therefore it is anticipated that these opportunities would be available as part of implementing the preferred option. It is acknowledged that the preferred option would lead to an increase in travel / transport for pupils living in Cradoc, however the number of pupils requiring additional transport would be relatively small, and it is anticipated that pupils could be accommodated on existing transport routes.

Impact * The intention is that the new building would be Passivhaus and Net Zero Carbon in operation, which would be significantly more energy efficient than the current buildings.

Consideration will be given to outdoor spaces as the scheme moves forward, to ensure that appropriate environmentally friendly outdoor spaces are available, and further biodiversity elements will be incorporated into the scheme where practical.

It is acknowledged that the preferred option would lead to an increase in travel / transport for pupils living in Cradoc, however the number of pupils requiring additional transport would be relatively small, and it is anticipated that pupils could be accommodated on existing transport routes. It is also acknowledged that the new building would be located up a hill, which could result in additional travel by car for those living in Brecon, which could also have an environmental impact.


Implementation of the preferred option would result in a new school building to replace Ysgol Golwg Pen y Fan's current buildings. This would have a positive impact on the well-being and morale of both pupils and staff, and would ensure that all pupils and staff were located in an efficient and stimulating teaching and learning environment with 21st Century facilities that will impact positively on the self-esteem and well-being of all pupils and enable delivery of the new curriculum for Wales. The new building will include sports facilities, and the building would be located near to Brecon High School and Brecon Leisure Centre, which would improve pupil access to these facilities.

The new building will be located up a hill, which may impact on pupils' ability to walk to school. In addition, pupils for whom Cradoc C.P. School is currently the closest school would no longer be able to walk to school.



Home to school transport would be provided for eligible pupils, however it is possible that this would impact on pupils' ability to access extra-curricular / after school activities, and that this impact would be greater in respect of pupils from lower income households. There would also be an impact on the parents of these pupils in terms of accessing school activities, particularly those who do not drive or own a car. It may also be more difficult for low-income families living in Brecon to access the new building on the Penlan site, particularly those who do not drive or own a car.

7. Overall summary and judgement 10

Outline assessment *

This Impact Assessment suggests that the impact would be positive. Since its establishment in September 2024, Ysgol Golwg Pen y Fan has been operating from three sites. The development of a new building to replace the current Ysgol Golwg Pen y Fan buildings would enable the school to operate from one site instead, which would enable the school to operate more efficiently. In addition, pupils and staff would be able to access much improved buildings and facilities for pupils compared with the current poor condition buildings, ensuring that future pupils would be taught in facilities that are fit-for-purpose, improving their learner entitlement and experience. The new facilities would be fully DDA compliant, supporting learners with disabilities. The new building will need to meet the Welsh Government's net zero carbon requirements, meaning that it will need to be highly energy efficient.

However, it is acknowledged that there are some negative impacts associated with the move to a new building. In particular, there would no longer be provision in Cradoc, which would have an impact on the community in Cradoc and would mean additional travel would be required for pupils for whom Cradoc is currently the closest school. In addition, it is acknowledged that the new building would be located up a hill, which may cause difficulties for those walking to the site. Active travel will be a key consideration when developing the scheme, with the aim of mitigating this.

8. Additional evidence 1

A statutory process was carried out in order to establish Ysgol Golwg Pen y Fan. This provided an opportunity to let the Council know their views on the plan.
