**1.     Summary**

- 1.1     This report is to request Cabinet to approve a draft Inter Authority Agreement for Agreeing the Heads of Terms for the Mid Wales Growth Deal ( see Appendix 1).

**2.     Background**

- 2.1     Growing Mid Wales is a regional partnership and engagement arrangement between the private and public sectors, and with Welsh Government. The partnership seeks to represent the region's interests and priorities for improvements to our local economy.

## Brecon Beacons National Park Authority

- 2.3 The IAA will put in place the governance to assist the Executive Management Team and the Programme Office to carry forward work to achieve the growth deal funding for the Mid Wales Region. These arrangements will also serve to enable governance of the partnership between the two Councils to develop and implement a 15 year Regional Economic Strategy based on the findings and the review carried out by the consultants from AECOM. The IAA also supports the setting up of an Economic Strategy Group which will be an independent group formed from private sector businesses. The Chair from this group will sit on the Joint Committee but in an advisory capacity only. If agreement is also reached with Welsh Government to allow a Regional Learning & Skills Partnership to be formed for the Mid Wales Region, the IAA will also support that arrangement and provide governance for the RLSP. Attached at appendix B is the proposed Terms of Reference for the Joint Committee.

### 3. Options Considered / Available

#### 3.1

##### Options:-

- Continue with Mid Wales Partnership in form of a voluntary arrangement
- Establish a formal joint committee with stakeholders having observer status (North Wales model)
- Establish a company, sector led Economic Development company in which all current partners are represented i.e. Authorities, FE's & HE's, Private sector companies – all with equal status on the board
- Joint Cabinet Model similar approach to the joint committee but formed by both Cabinet's. Private sector could be stakeholders having observer status only. (Cardiff and Swansea model)

##### Pros & Cons:-

- Continue with Mid Wales Partnership in form of a voluntary arrangement  
Pros: Already established and understood by partners. No additional running costs or other overheads.  
Cons: Unlikely to satisfy Government that partnership with Ceredigion is sufficiently formalised. Decision making not entirely open and transparent.
- Establish a formal joint committee with stakeholders having observer status (North Wales model)  
Pros: A tried and tested model operating in North Wales. Open and transparent and accountable open to formal scrutiny.  
Cons: Does not formally engage private sector, higher education or other stakeholders. Additional ongoing overheads to manage.
- Establish a company, sector led Economic Development company in which all current partners are represented i.e. Authorities, FE's & HE's, Private sector companies – all with equal status on the board  
Pros: Will formally engage private sector, higher education and other stakeholders in the governance arrangements. Is innovative, will appeal to private sector.  
Cons: Will have set up costs and ongoing administration requirements. Less transparent than joint committee or joint Cabinet models.

- Joint Cabinet Model similar approach to the joint committee but formed by both Cabinet's. Private sector could be stakeholders having observer status only. (Cardiff and Swansea model)  
Pros and Cons: Same as joint committee, though potentially more transparent as Cabinet model is more recognised by the public.

#### **4. Preferred Choice and Reasons**

- 4.1 The preferred choice is the formation of a Joint Committee as this gives a more formal structure to the partnership between both Councils and sets out clearly the areas of responsibility for each Council.
- 4.2 In order to ensure that appropriate governance arrangements are in place, it is proposed that Cabinet approves the draft "Inter-Authority Agreement for Agreeing the Heads of Terms for the Mid Wales Growth Deal" ("the IAA") attached as Appendix 1. This is an Agreement between Ceredigion County Council and Powys County Council. The Agreement will continue for the duration of the project, being the development of the Outline Business Case for the Mid Wales Growth Deal and for approval of Heads of Terms with the Welsh Government and the United Kingdom Government.
- 4.3 The terms of IAA has not yet been finalised and on 19<sup>th</sup> March 2019 Ceredigion's Cabinet granted delegated authority to its chief legal officer to make minor amendments to the draft IAA. It is recommended that Cabinet grant delegated authority to the Leader in consultation with the Head of Legal and Democratic Services to make minor amendments to the draft IAA in Appendix 1
